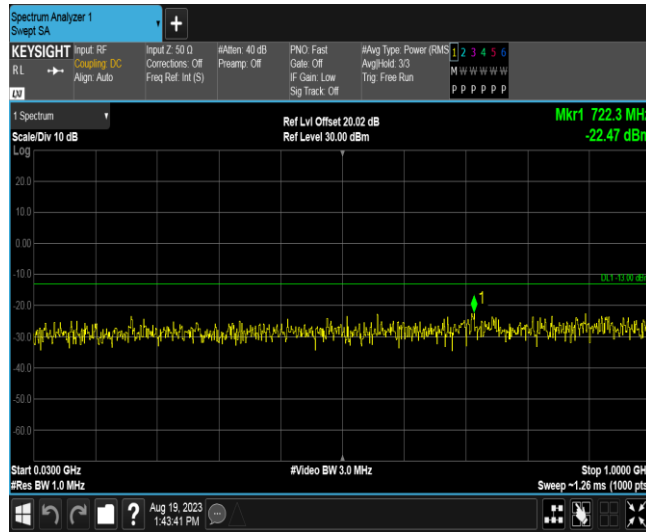


Band66-1.4MHz-QPSK-131979-1RB#0-Range2:1000~20000MHz
