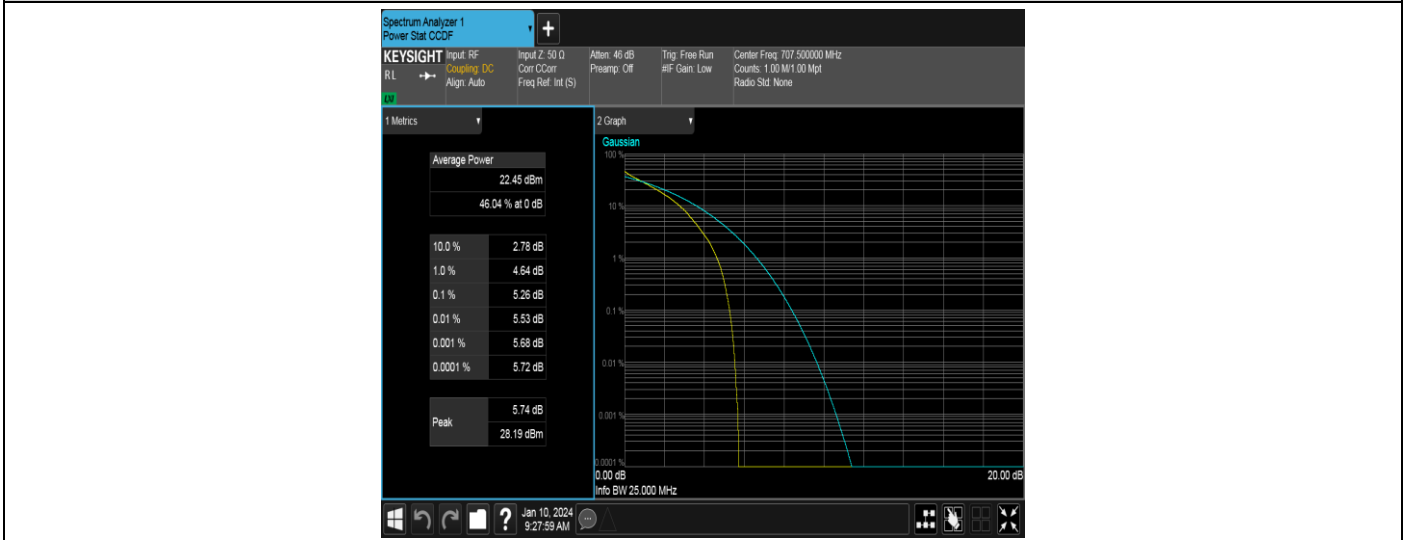




Band12-1.4MHz-QPSK-23095-1RB#0

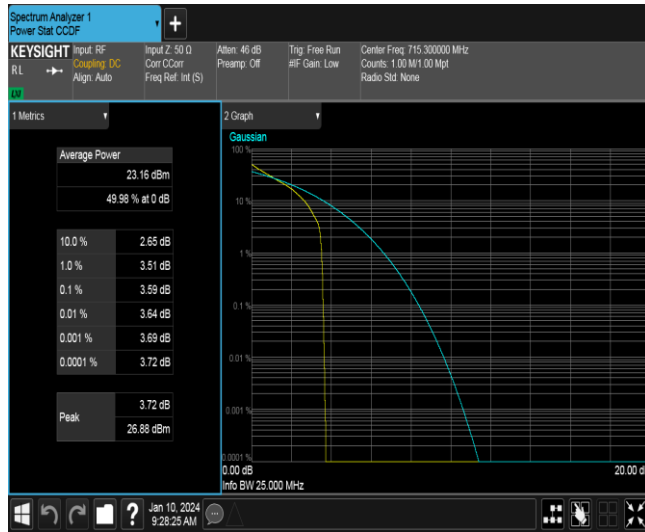


Band12-1.4MHz-QPSK-23095-6RB#0

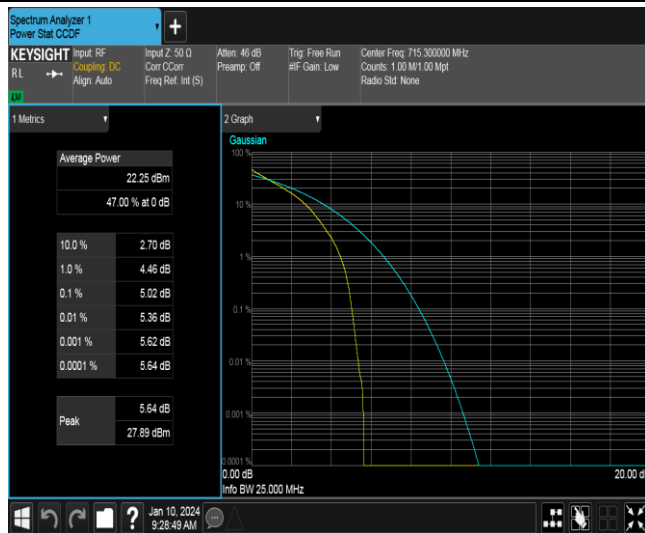

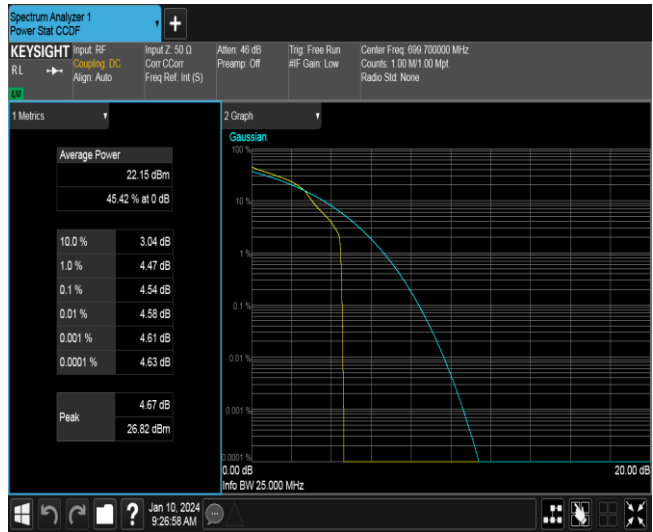


Band12-1.4MHz-QPSK-23173-6RB#0

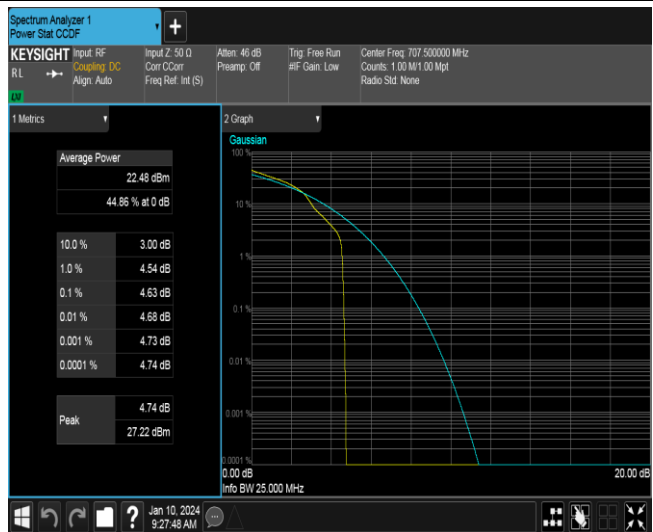

Band12-1.4MHz-16QAM-23017-6RB#0

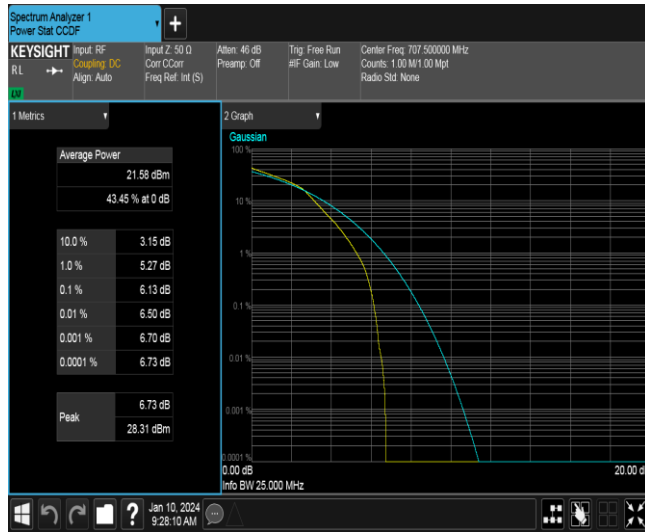


Band12-1.4MHz-16QAM-23095-1RB#0

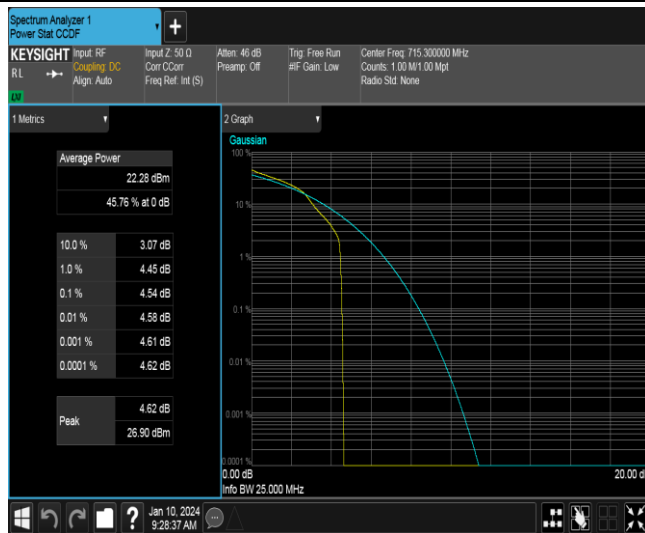

Band12-3MHz-QPSK-23025-1RB#0



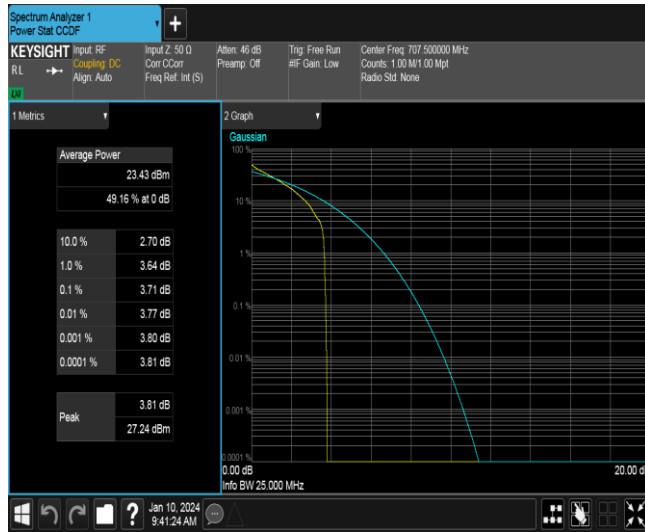

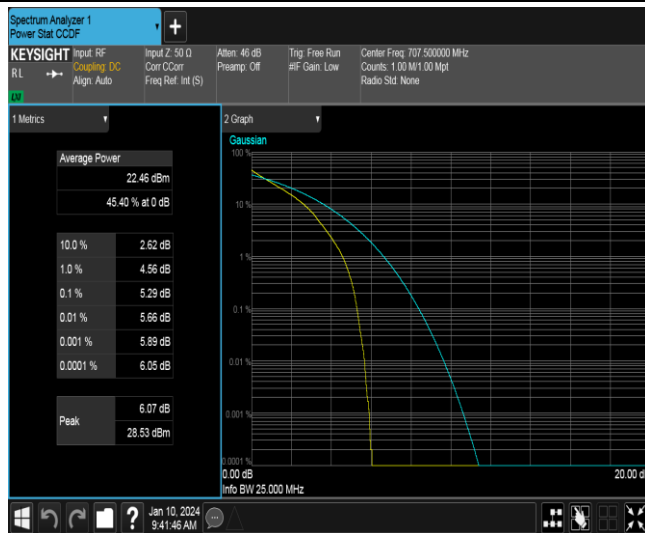

**Band12-3MHz-QPSK-23095-1RB#0**

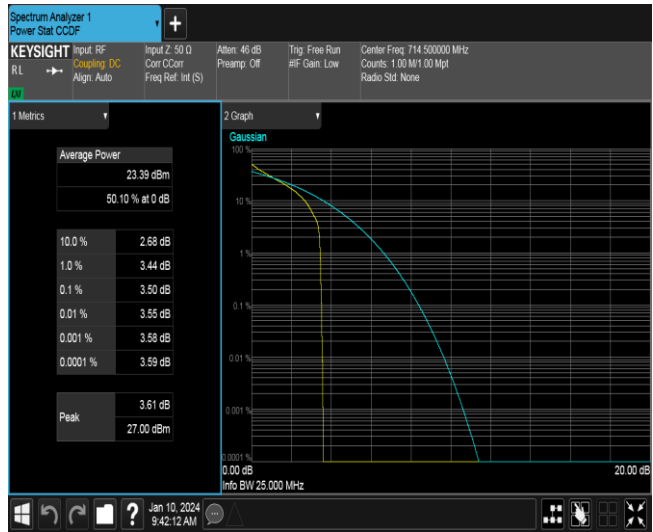


**Band12-3MHz-QPSK-23095-15RB#0**

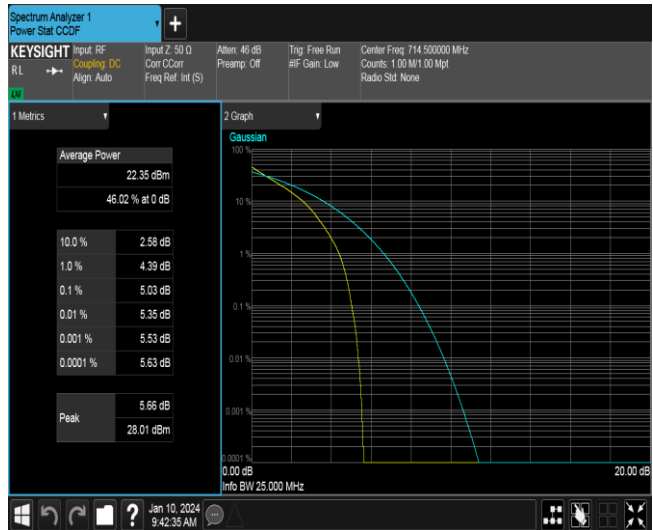
