Band14-5MHz-16QAM-23305-25RB#0

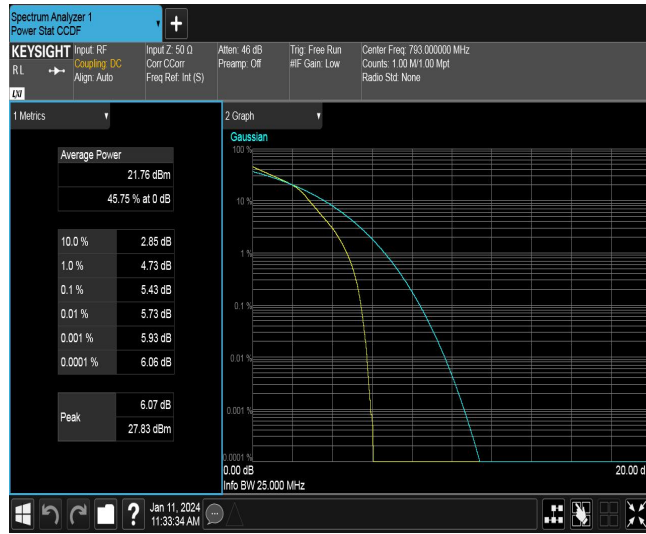

Band14-10MHz-QPSK-23330-1RB#0

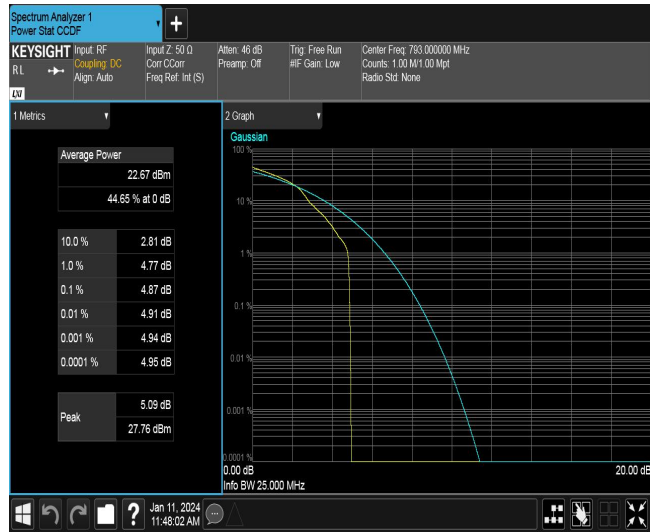


Band14-10MHz-QPSK-23330-50RB#0

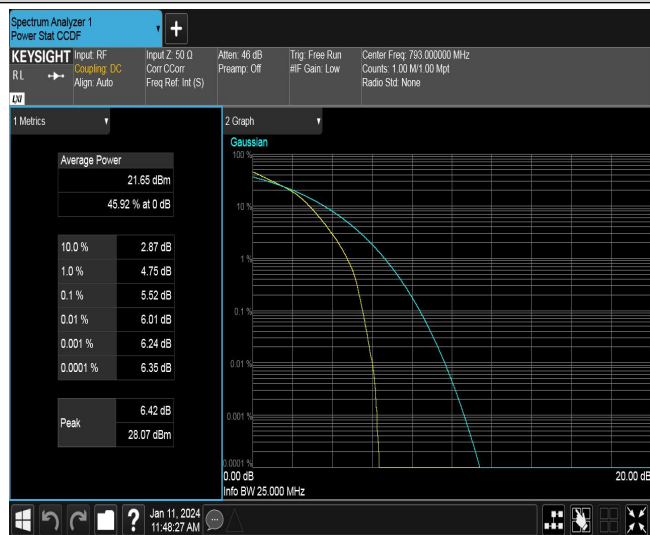

Band 14-5MHz-QPSK-23355-25RB#0

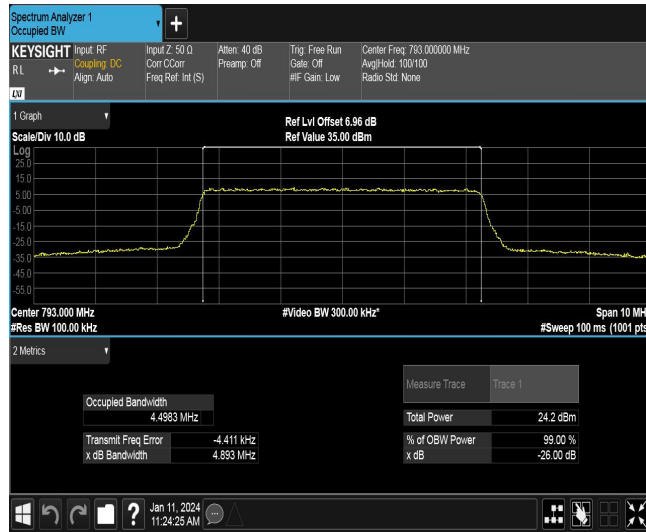

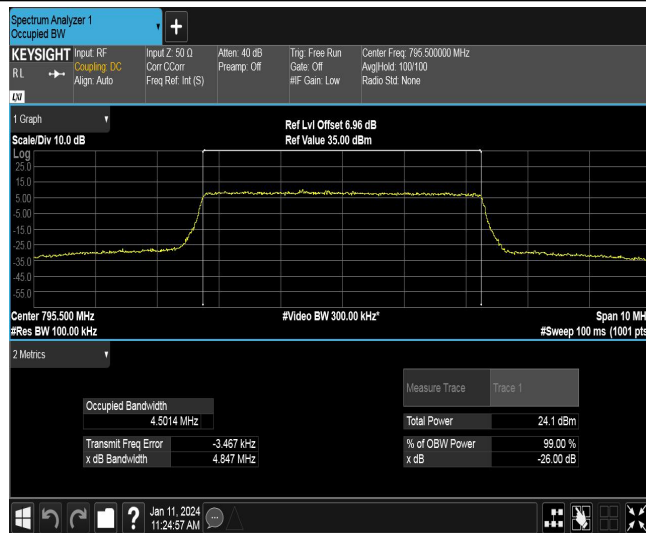

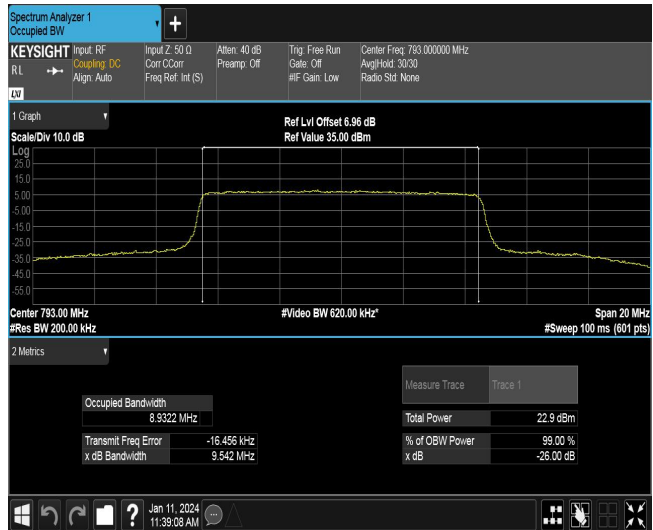

Band14-10MHz-16QAM-23330-50RB#0



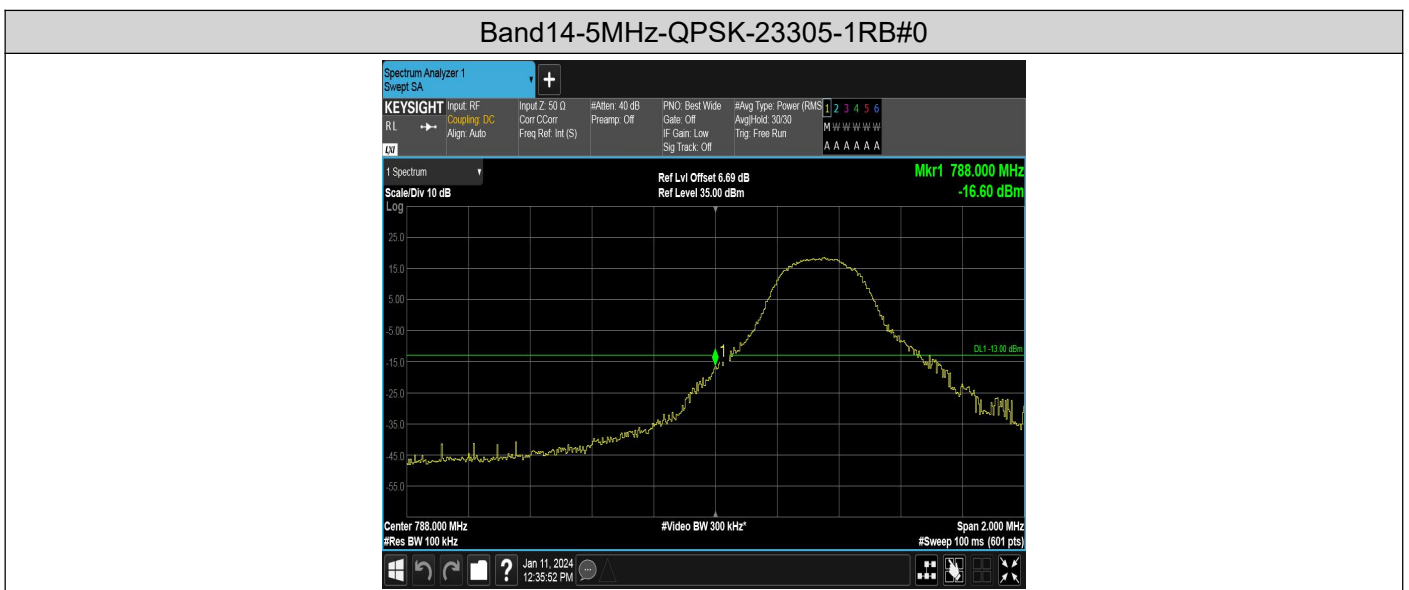
