



Wireless Charger User Manual



Before using product, please read this manual carefully and keep it properly.

Product introduction

This product is a multi-function, 360 degree rotation, with magnetic suction wireless charger, simple design, safe use, portable, can charging multiple devices at the same time, also be split into three modules used alone.



Usage introduction


1. Rotate open the wireless charger, raise the holder and put the wireless charger in a suitable position.
2. Connect the charging line, turn on the power (it is recommended to use the QC2.0-QC3.0 or PD adapter, otherwise the fast charging function cannot be achieved), The charger starts working.
3. This product mobile phone charging area and watch charging area are equipped with magnetic suction function, which can be automatically calibrated to ensure that the charging device is aligned with the charging area of the wireless charger. Put the device with wireless charging function on the corresponding position of the wireless charger. When the wireless charger is in normal working state, the device will show normal charging.
4. This product can also be divided into three modules for separate use, each module is equipped with Type-C interface, independent power supply.

Special remind


1. To ensure that three devices are charging at the same time in more safer and efficient, you need to use a 9V/3A adapter with a quick charge cable, such as a mobile phone quick charge power up to 15W, you need to use the mobile phone charging module port is powered with 9V/3A or 12V/2.5A adapter quick charge cable.
2. Please keep the magnet cleaning at the connection of the module at use the wireless charger to charge the mobile device of no dust or dirt and other foreign bodies, avoid interfering with the normal work of the wireless charger.
3. If the charger can not be worked normally, please follow the following method for detection:
 - ①. Cut off electric power then connect the charging cable ;
 - ②. Check whether there are foreign bodies, dust, dirt, etc on the magnet at the connection of the module. Clean it up and reconnect it;
 - ③. Replace the adapter and cable then reconnect;
 - ④. If you still can't solve the problem, please contact the salesperson.

- Do not use the wireless charger under severe heat, humidity or corrosive conditions to avoid damage to the circuit or have electric leakage.
- Do not place the magnetic or chip card (ID card, bank card, etc.) too close with the charger to avoid malfunction of the magnetic card.
- Keep the distance between the implanted medical device (cardiac pacemaker, implantable cochlear implant, etc.) and the wireless charger at least 20cm to avoid potential interference with medical equipment.
- Children should be supervised to ensure that they do not play wireless chargers as toys to avoid unnecessary accidents. Children should use this product under adult supervision.
