### 2 Requirements

According to the item 5 of KDB 680106 v03r01:

Inductive wireless power transfer applications that meet all of the following requirements are excluded from submitting an RF exposure evaluation.

(1) Power transfer frequency is less than 1MHz.	Yes; the device operate in the frequency range from 115 KHz to 205 KHz

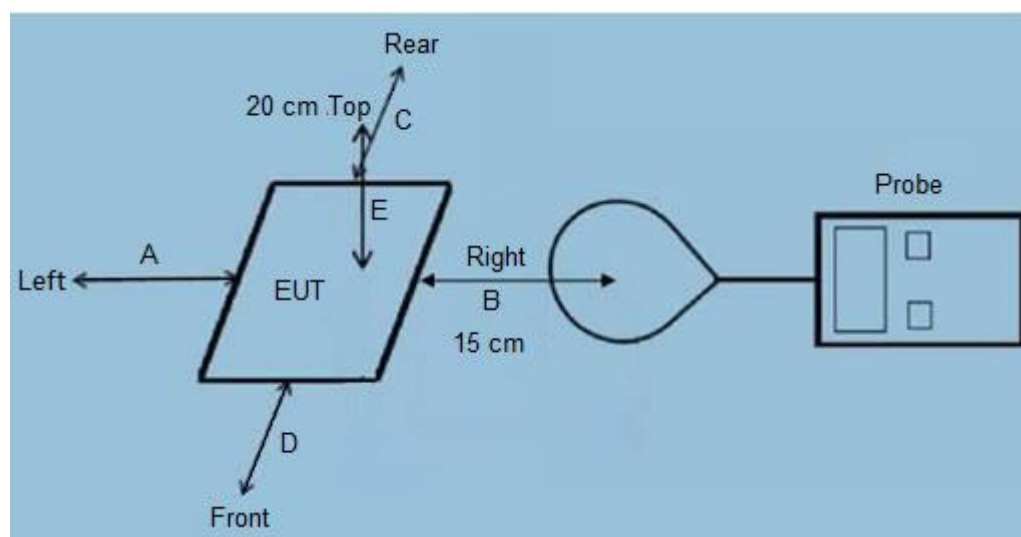

### 4 Test Procedure

- 1) The RF exposure test was performed in anechoic chamber.
- 2) The measurement probe was placed at test distance (15 cm from all sides and 20 cm from the top) which is between the edge of the charger and the geometric center of probe.
- 3) The highest emission level was recorded and compared with limit as soon as measurement of each points

(A, B, C, D, E) were completed.

4) The EUT was measured according to the dictates of KDB 680106 v03r01.

Remark: The EUT's test position A, B, C, D and E is valid for the E and H field measurements.
