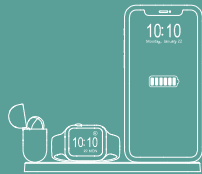

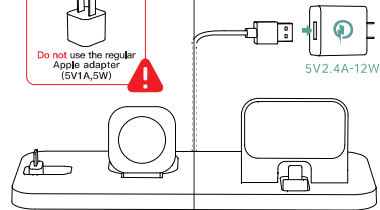


Recommend using 10W or above adapter (12W adapter is included)

working for 3 devices.

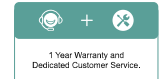


Do not use the regular

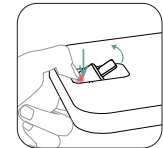

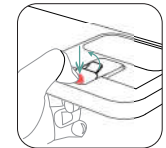
① Press to make the plug
stand up



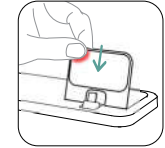
② Push the watch charger up



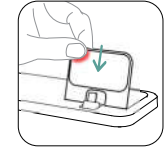
③ Press to make the plug
