2DH1\_Ant1\_Hop

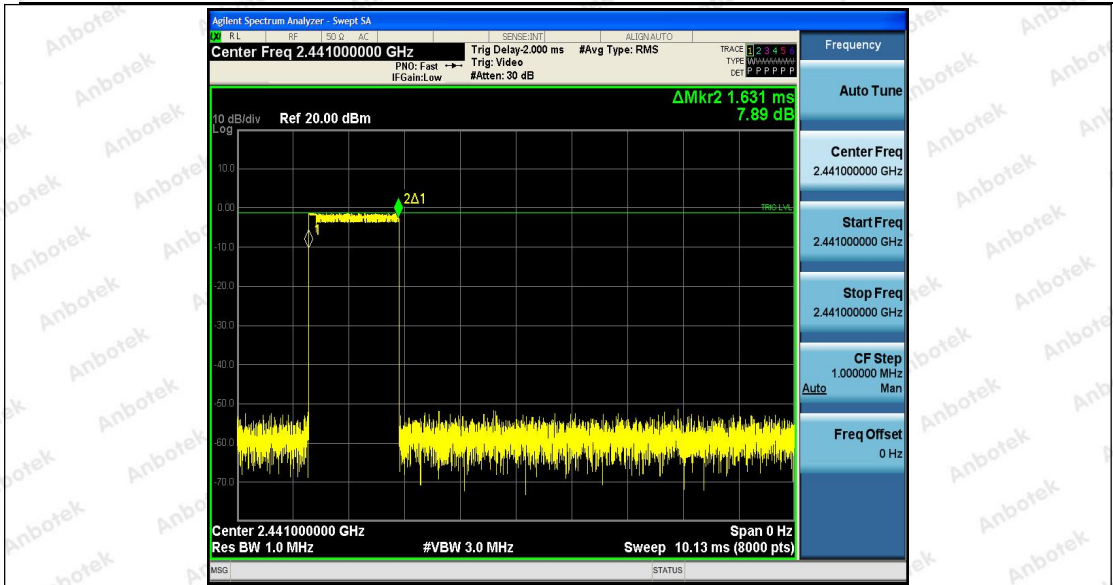

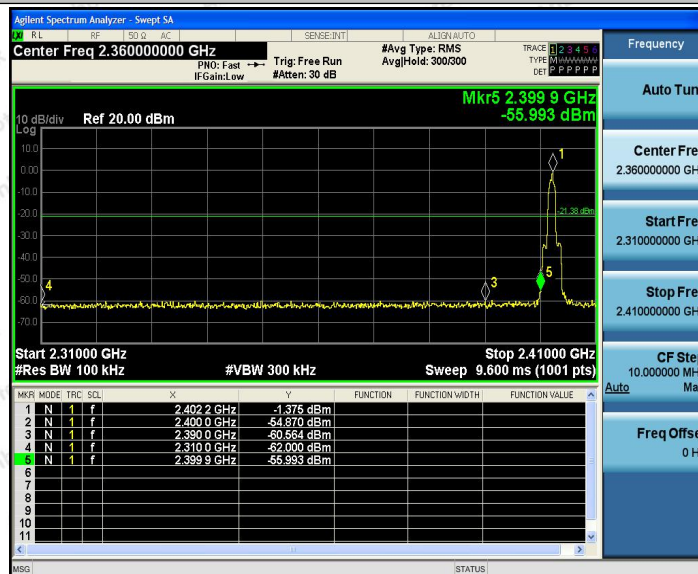

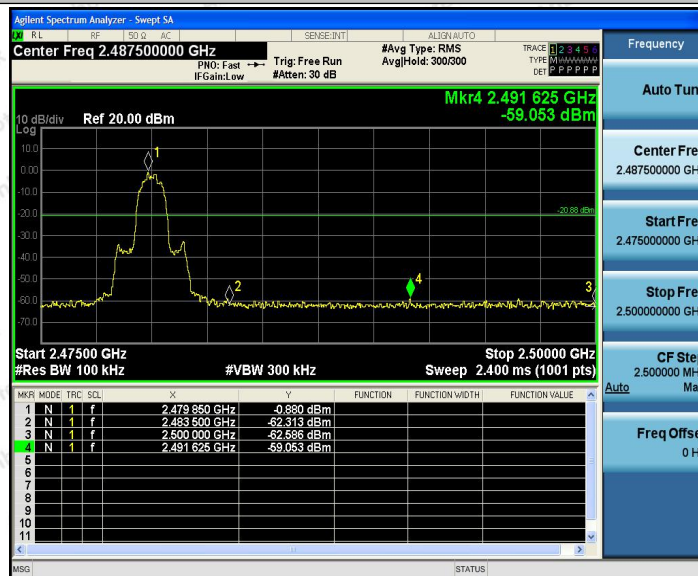




3DH5\_Ant1\_Low\_2402
