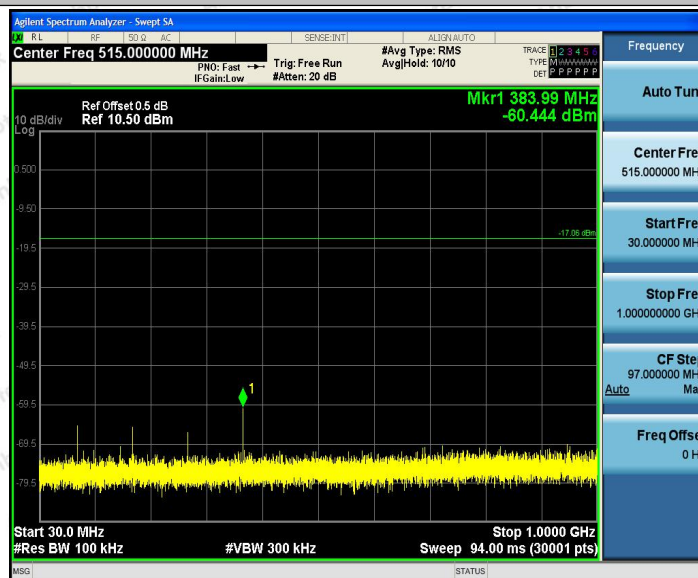




BLE_1M_Ant1_2440_0~Reference



BLE_1M_Ant1_2440_30~1000

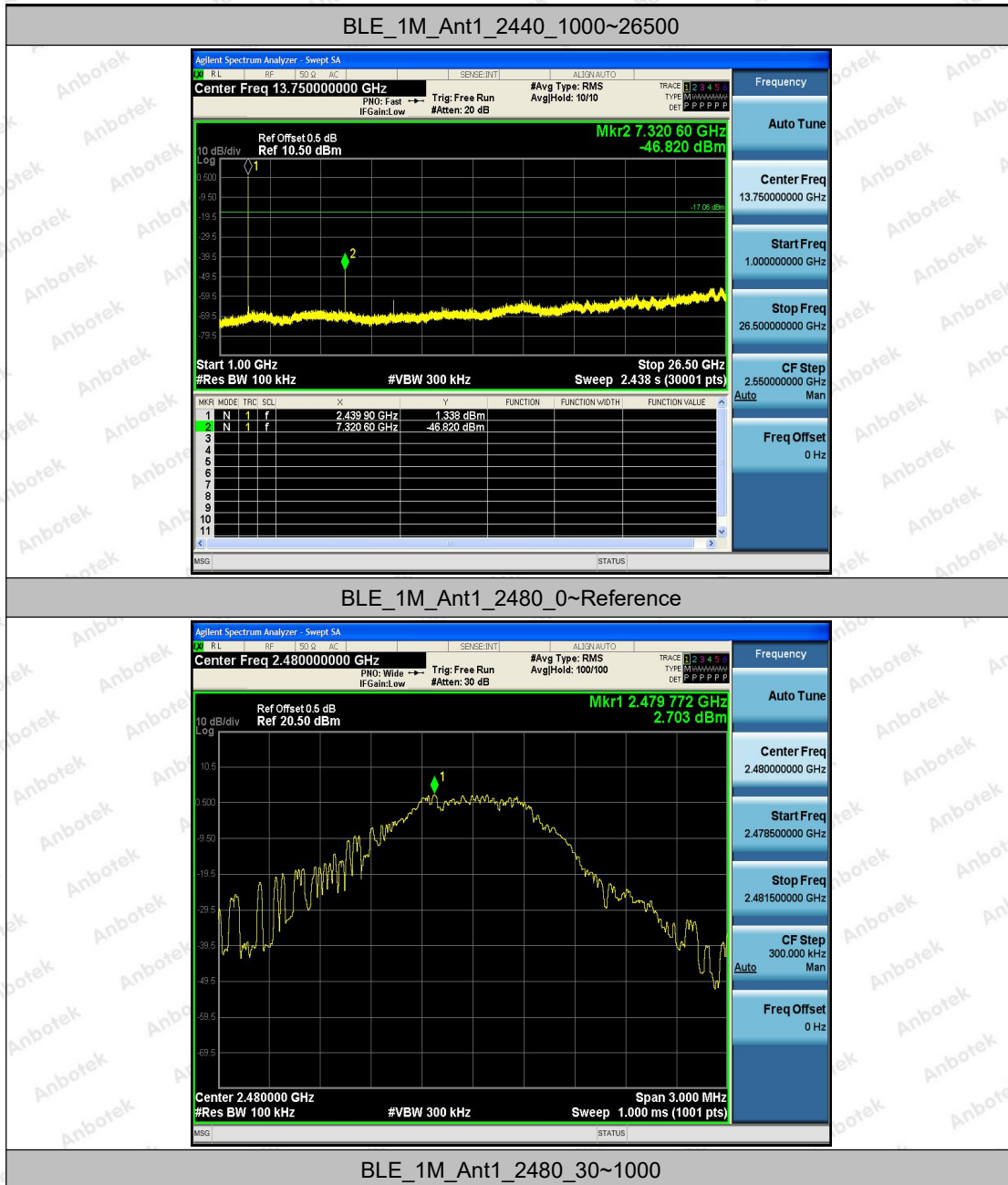
