### 01. ATTACH

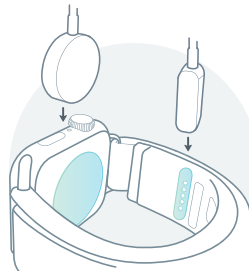
Attach the band to the watch.

Before first use, charge the band for 1 hour.



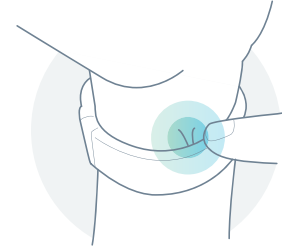
### 03. WEAR

Place the band near the wrist bone.

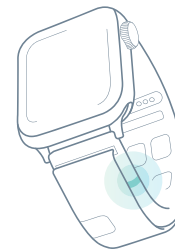


### 04. FIT
