## QUICK STEP GUIDE

1. Press and hold the crossed tees Action Button to turn on the Player+ and to go into pairing mode.
2. Go to your Bluetooth settings on your phone and look for "Blue Tees Player+" to connect.
3. Download the Blue Tees Game App, set up your profile and connect Player+ to register your device.
4. Find your course in the Game App and start a round to get access to Golf Mode on Player+.
5. Swipe up and down to access Utility screens (Music Controls, Time and Setting screens).
6. Swipe left and right to access Golf screens (GPS Distances, Driving Distance, Hazards, and Score Display screens).
7. While in a round in the Game App, you can swipe up to the sub-menu to access Device Settings to customize your experience.
