




Know your phone

Charging the phone

You can charge your device using a charger or by connecting it to the computer using a USB cable (comes with the phone).

1. Please remind the front and back of the plug.

 Use only VIMOQ charger and cables. Other chargers or cables may damage the device. This will invalidate your phone warranty.

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules.
