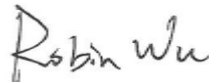

The EUT supports Cyclic Delay Diversity (CDD) technology, the CDD supports 802.11a/g/n/ac/ax, not include 802.11b (SISO only), and CDD signals are correlated.

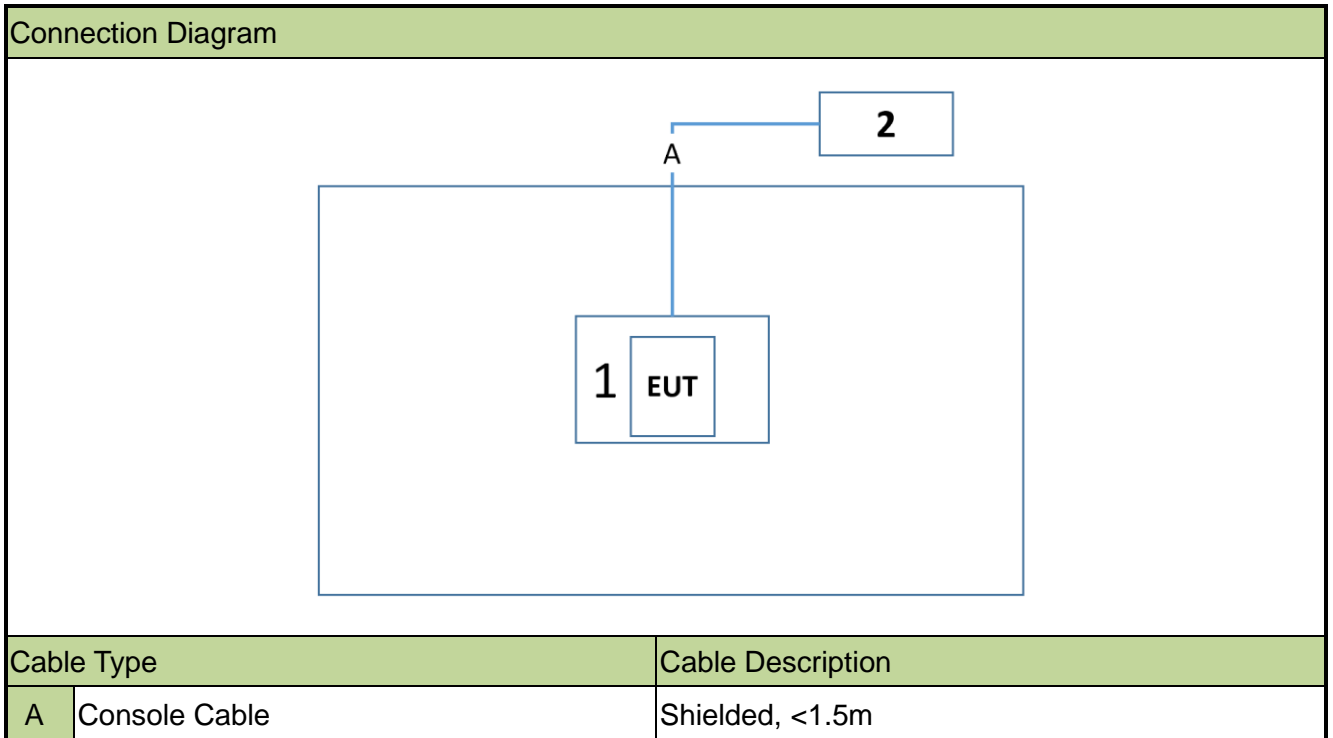

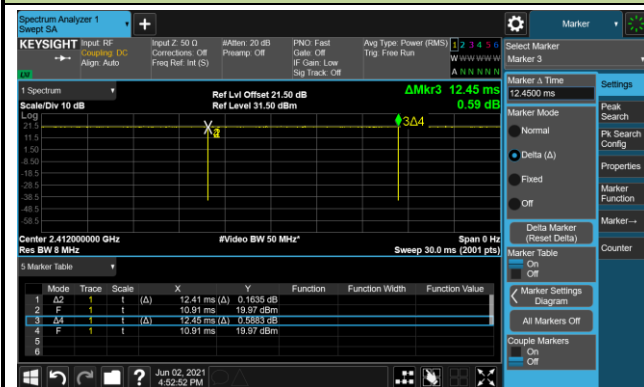
2.10. Duty Cycle

2.4GHz WLAN (DTS) operation is possible in 20MHz channel bandwidths. The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

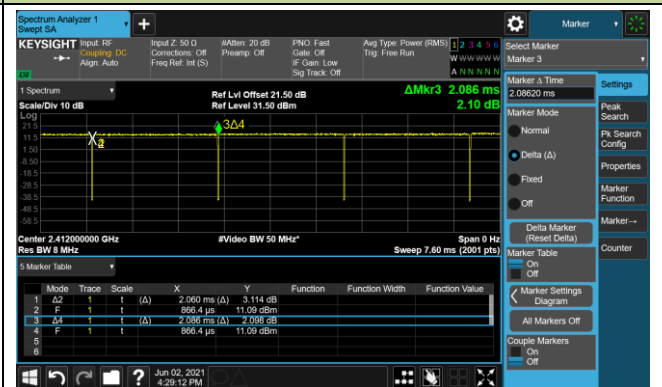

Duty Cycle (T = Transmission Duration)

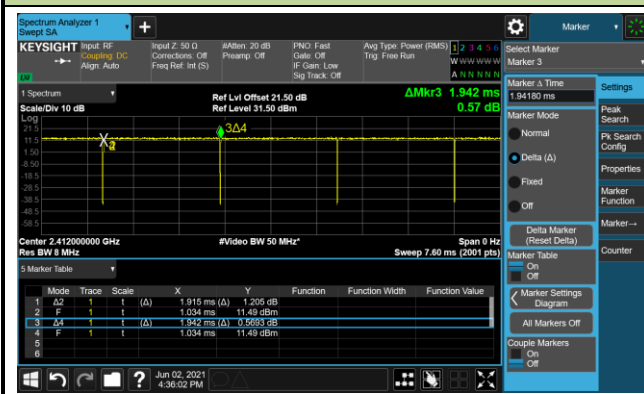

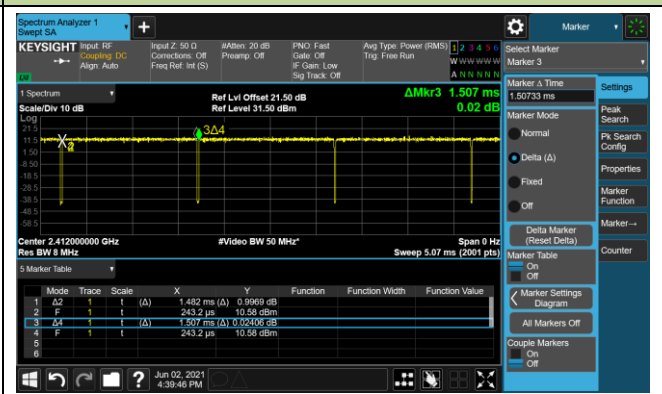

Notes:

- 1) The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- 2) Output power test was verified over all data rates of each mode (data refers to operational description), and then choose the maximum power output (low data rate) for the final test of each channel.
- 3) For radiated emission tests, every axis (X, Y, Z) was also verified. The test results shown in the following sections represent the worst-case emissions.
- 4) Test Items "6dB Bandwidth" & "99% Bandwidth" showed the worst test data in this report.
- 5) EUT supports one configuration only in 802.11ax full RU mode, i.e. 242 tone in 11ax-HE20.

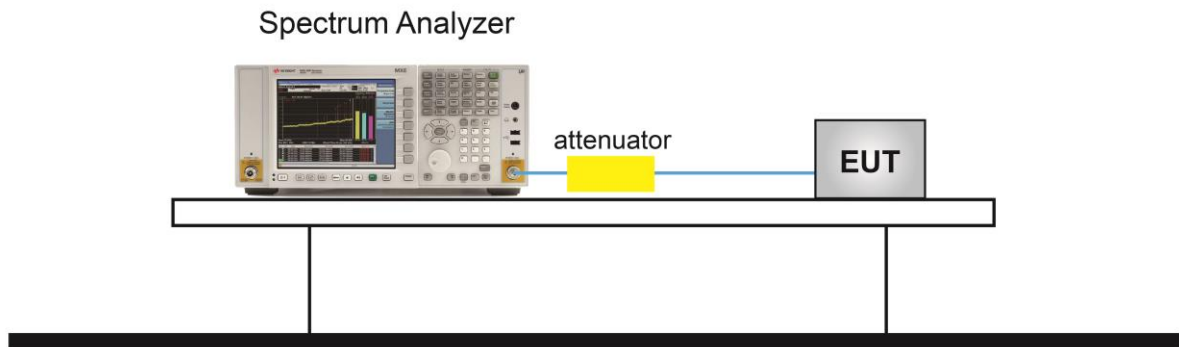
For 6dB bandwidth

1. The Spectrum's automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to $X = 6$. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. Set RBW = 100 kHz
3. $VBW \geq 3 \times RBW$
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple
7. Allow the trace was allowed to stabilize

For 99% bandwidth

1. Span = 1.5 times to 5 times the OBW
2. Set RBW = 1% to 5% the OBW
3. $VBW \geq 3 \times RBW$
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple

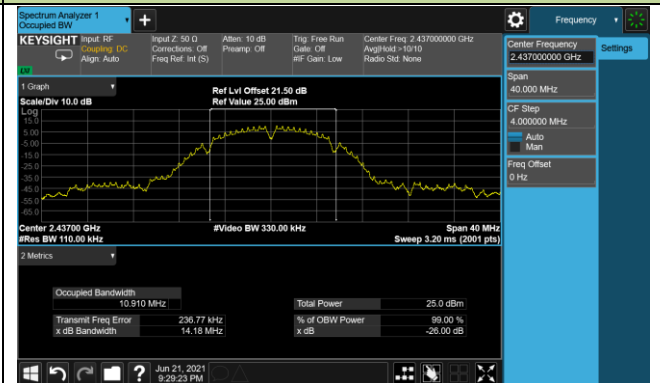


802.11b 99% Bandwidth - Ant 0

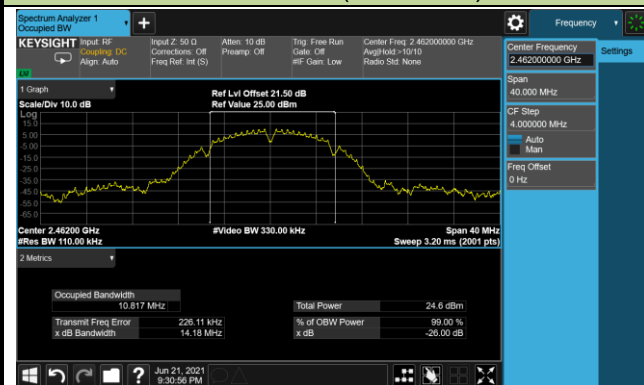

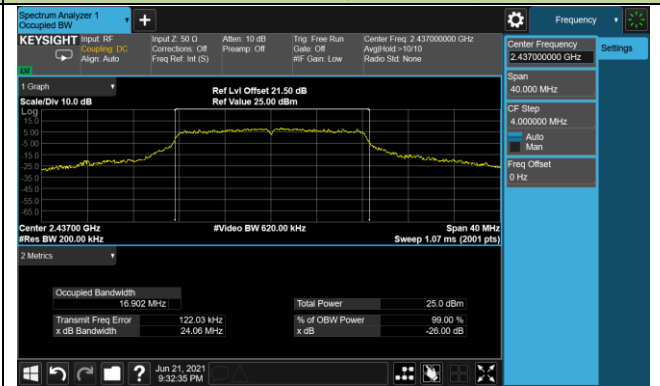


802.11g 99% Bandwidth - Ant 0

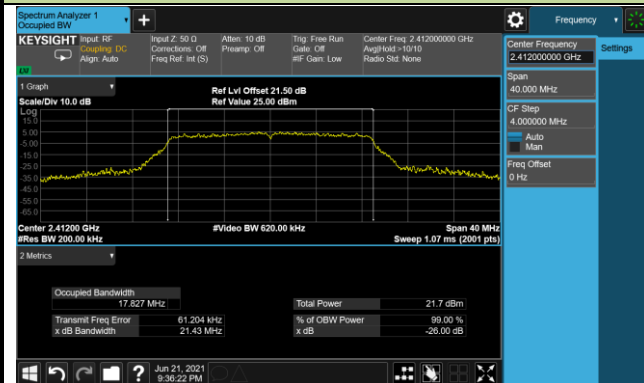

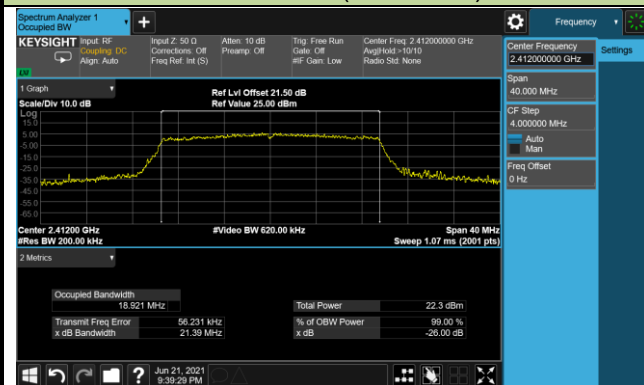

6.3. Output Power Measurement

6.3.1. Test Limit

The maximum output power shall be less 1 Watt (30dBm), and the E.I.R.P shall not exceed 4 Watt (36.02dBm).

The conducted output power limit specified in paragraph FCC Part 15.247(b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs FCC Part 15.247(b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

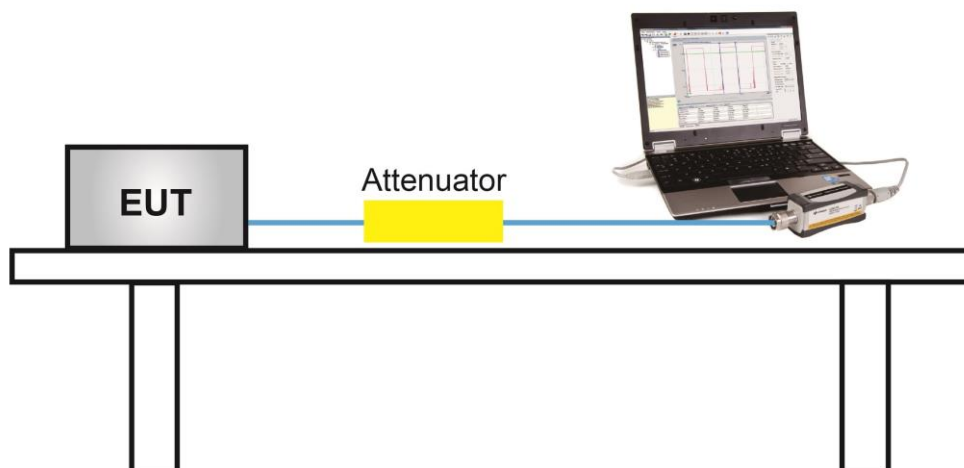

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. 6.5. Conducted Band Edge and Out-of-Band Emissions

6.5.1. Test Limit

The limit for out-of-band spurious emissions at the band edge is 30dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100 kHz bandwidth per the PSD procedure.
