First please connect this charging station and adapter(included in box) with the included USB cable, then plug adapter to the power source. Charger's green light will turn on for about 10 seconds and then turn off automatically, now you can charge your devices.

#### 1. Charge iPhone

Put your iPhone 12/13 on this charger's upper magnetic charging area with or without a Magsafe case, charging will begin

#### 2. Charge Apple watch

Put your apple watch on the charger's back watch magnetic charging area,it will

charge the watch

### 3. Charge Airpods

Put your Airpods pro/2/1 on the charger's below wireless charging pad, it will charge airpods
