# 2.2 Description of Test conditions

(1) E.U.T. test conditions:

For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

  - only the worst-case results are recorded in this report.

The sample was placed (0.8m below 1GHz, 1.5m above 1GHz) above the ground plane of 3m chamber. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating the turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. # 4 Test Result

## 4.1 Antenna Requirement

#### 4.1.1 Standard requirement

#### **Standard Applicable**

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247, if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.



The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited. Further, this requirement does not apply to intentional radiators that must be professionally installed.

#### **Antenna Connected Construction**

The antenna used in this product is a PCB antenna which permanently attached. It conforms to the standard requirements. The directional gains of antenna used for transmitting is -0.58dBi.


#### 4.2.2 Test procedure

- 1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is placed on turntable; a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10:2013.
- 2. Support equipment, if needed, was placed as per ANSI C63.10:2013
- 3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10:2013.
- 4. The adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5. All support equipments received AC power from a second LISN, if any.
- 6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8. During the above scans, the emissions were maximized by cable manipulation.

#### **Test Procedure**


- 1. The EUT was placed on turn table which is 0.8m above ground plane for below 1GHz test, and on a low permittivity and low loss tangent turn table which is 1.5m above ground plane for above 1GHz test.
- 2. Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0°C to 360°C to acquire the highest emissions from EUT
- 3. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 4. Repeat above procedures until all frequency measurements have been completed.

#### 4.6 6dB Bandwidth

#### 4.6.1 Limit

For digital modulation systems, the minimum 6 dB bandwidth shall be at least 500 kHz.

#### 4.6.2 Test procedure
