8.1 Transmitter output power and EIRP requirements

8.1.1 References and limits

- FCC 47 CFR Part 15, Subpart B: §15.247(b)(3)
- RSS-247: §5.4(d)
- Test method: 558074 D01 DTS Measurement Guidance §8.3.1.1 and ANSI C63.10 §11.9.1.1 (RBW $\geq$ DTS bandwidth)

§15.247:

- (a) Operation under the provisions of this Section is limited to frequency hopping and digitally modulated intentional radiators that comply with the following provisions:
- (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

RSS-247:

- 5.4 Devices shall comply with the following requirements, where applicable:

- (d) For DTSS employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1 W. The EIRP shall not exceed 4 W, except as provided in RSS 247 section 5.4(e).

As an alternative to a peak power measurement, compliance can be based on a measurement of the maximum conducted output power. The maximum conducted output power is the total transmit power delivered to all antennas and antenna elements, averaged across all symbols in the signalling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or transmitting at a reduced power level. If multiple modes of operation are implemented, the maximum conducted output power is the highest total transmit power occurring in any mode.

No testing was performed. The EIRP was calculated on the basis of test data from the original test report on the "JODY-W2" WLAN and Bluetooth module, report reference MDE_UBLOX_2008_RADIO_02 (FCC ID: XPYJODYW263, IC: 8595A-JODYW263). EIRP was re-calculated from the original test data using the new manufacturer declared antenna gain.

8.2 FCC 15.247(d) and RSS-247 5.5 Radiated restricted band-edges and spurious emission

8.2.1 Definition and limits

Title 47 → Chapter I → Subchapter A → Part 15 → Subpart C → §15.247(d)

- (d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

RSS-247 → §5.5

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

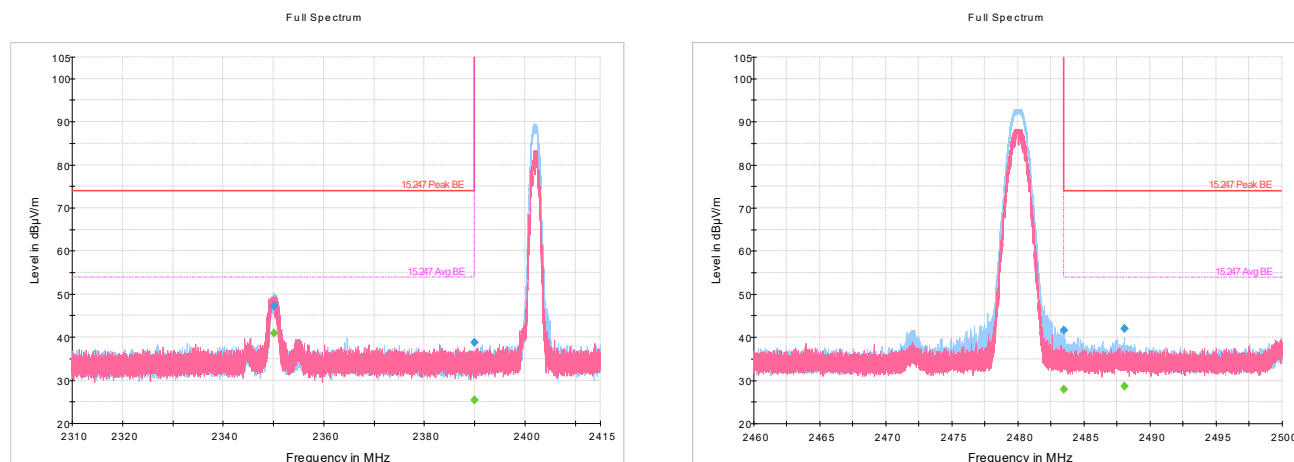


Figure 8.2-1: Radiated emissions, restricted band edge, BLE, 2 Mbps

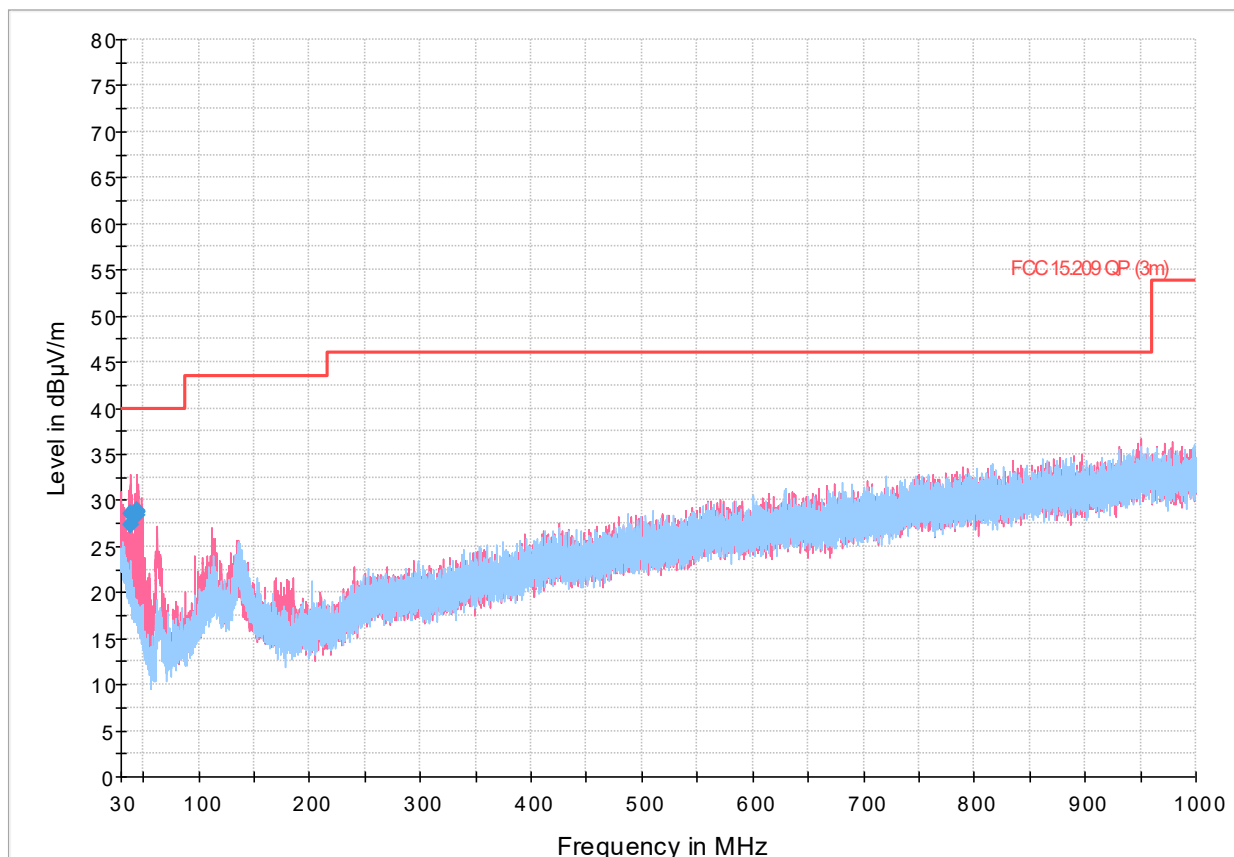

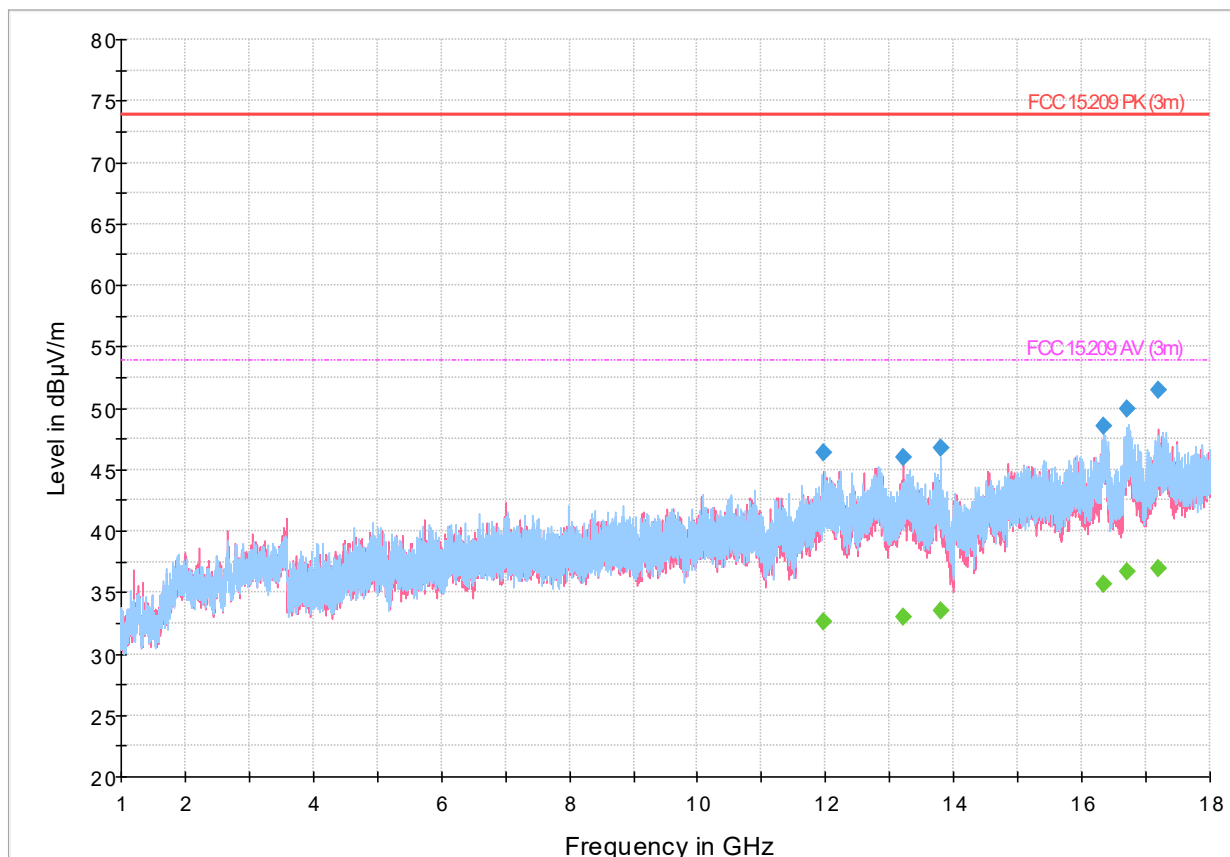

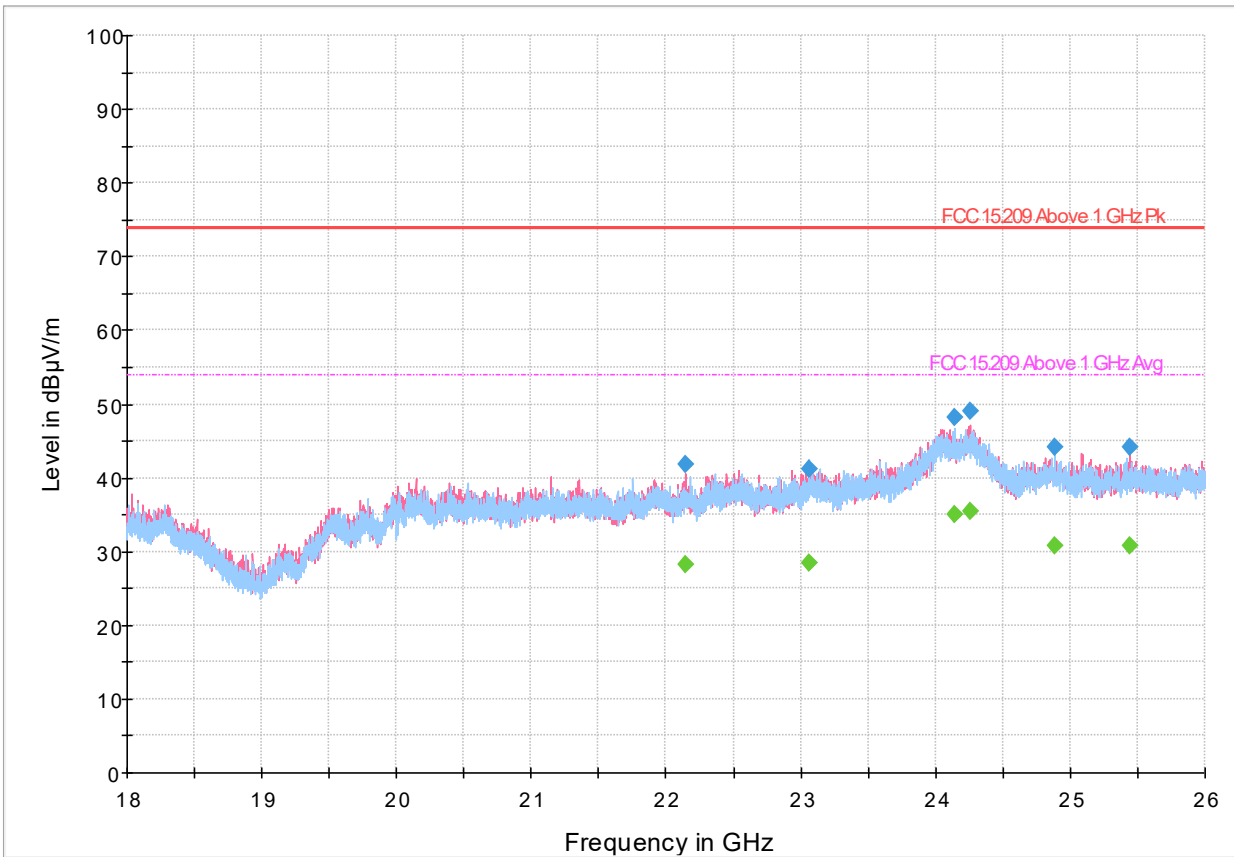

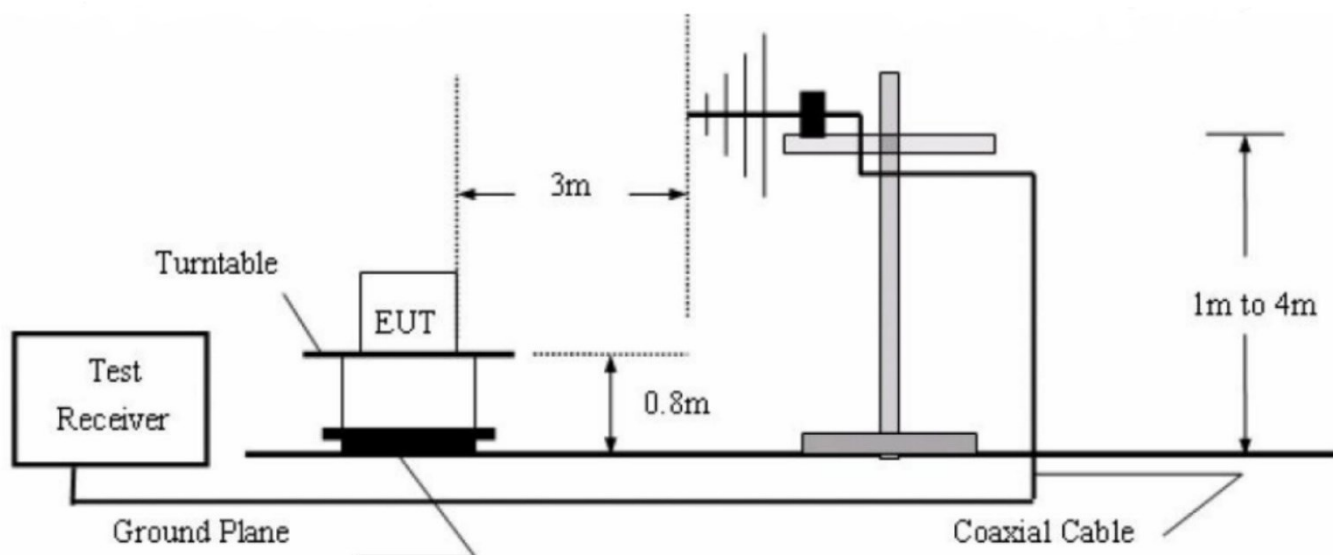


Figure 9.1-1: 30 MHz - 1000 MHz Setup

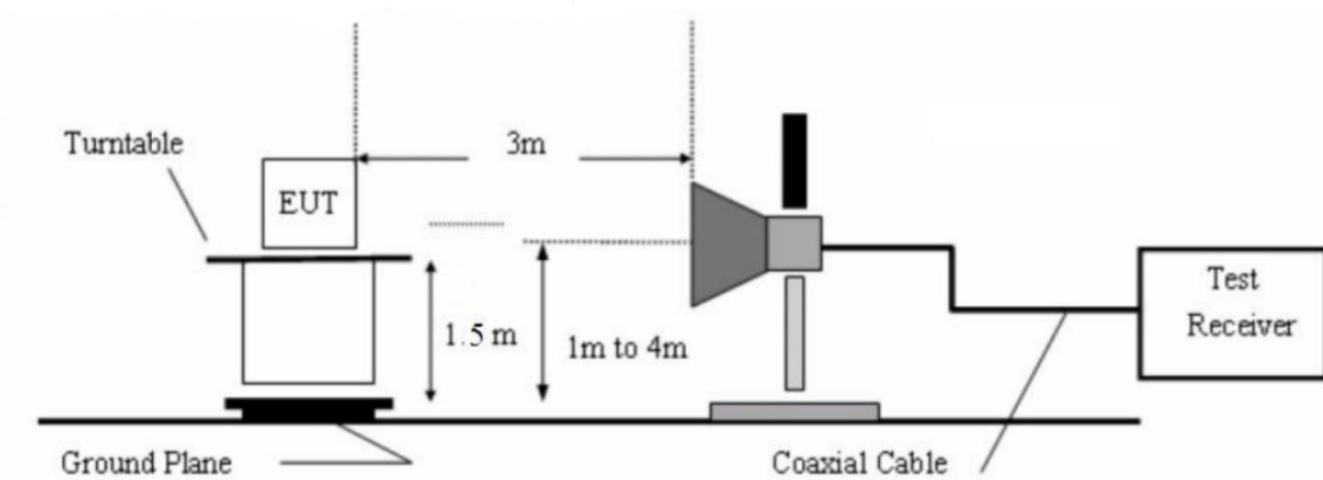


Figure 9.1-2: 1 GHz - 26 GHz Setup
