We, GIPS Technology Co., Ltd (Su, Li-Tse) declare that the product, FCC ID: 2A6S5-GT130, have complied with the following 2022 April TCB workshop.

UWB Indoor UWB Systems

We complied with the following requirements.

- Restricted to indoor operation by nature of design and manual notice (15.517(a)(1))
- Shall not be intentionally directed to perform outside functions, such as entry detection (15.517(a)(2))
- The use of fixed outdoor mounted antenna is prohibited (15.517(a)(3))
