



Operation steps

- Plugged in, connected to the control box and painter light.
 At this point, the power indicator will always be blue light after power on.
- 2. Press the power button to turn on/off the painter light.
- 3. Press the mode key, you can change the lighting effect, a total of five light effects.
 - #1 rainbow color
 - #2 red, green, blue and red
 - #3 aurora color
 - #4 lavender sea
 - #5 warm white light
- 4. Press the music rhythm button to change the music rhythm mode, a total of four modes.
 - #1 breathing mode
 - #2 running light mode, low sensitivity
 - #3 running light mode, high sensitivity
 - #4 jumping mode
- 5. Press the timer button to enable or disable the "timer shutdown" function.
- (1) After opening, the timer indicator will always be blue, nd it will automatically shut down after 30 minutes by default.
- (2) APP adjustable timing time.
- 6. Reset hole, long press this button light flashes three times, keep the light on and then release, restore factory settings.

Of course, you can also download the Woohlab APP on your mobile phone and control the painter light through the APP.
