





Below 30MHz Test Setup




Below 1000MHz Test Setup





- b) Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP (see 11.12.2.6 for guidance on determining the applicable antenna gain).
- c) Add the appropriate maximum ground reflection factor to the EIRP (6 dB for frequencies ≤30 MHz; 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive; and 0 dB for frequencies > 1000 MHz).
- d) For MIMO devices, measure the power of each chain and sum the EIRP of all chains in linear terms (i.e., watts and mW).
- e) Convert the resultant EIRP to an equivalent electric field strength using the following relationship:

 $E = EIRP-20 \log d + 104.8$

where

E is the electric field strength in dBuV/m

EIRP is the equivalent isotropically radiated power in dBm

d is the specified measurement distance in m

- f) Compare the resultant electric field strength level with the applicable regulatory limit.
- g) Perform the radiated spurious emission test.



The process is repeated until 99.5% of the total is reached; that frequency is recorded as the upper frequency. The 99% power bandwidth is the difference between these two frequencies.
- h) The occupied bandwidth shall be reported by providing plot(s) of the measuring instrument display; the plot axes and the scale units per division shall be clearly labeled. Tabular data may be reported in addition to the plot(s).
