

Battery Replacement

Smart Finder includes the battery (1 CR2032 Lithium battery); when battery is drained, replace battery as below:

- Unscrew to remove the back cover with a small Phillip screwdriver.
- 2. Replace the battery inside with a new CR2032 button cell battery as per the indicated polarity
- . Put back the back cover and secure it tightly with 2 screws.




