- 1. The testing follows the guidelines in ANSI C63.10-2013 clause 6.4.
- 2. The EUT was arranged to its worst case and then turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level. Both Horizontal, Face-on and Face-off polarizations of the antenna are set to make the measurement.
- 3. The EUT was placed on a turntable with 80 cm above ground.

For example, the measurement frequency X KHz resulted in a level of Y dBuV/m, which is equivalent to Y-51.5 = Z dBuA/m, W dB, to the limit as it has to be 15.209(a) limit.






X axis, Y axis, Z axis positions:




