5.2.2 Test Graph



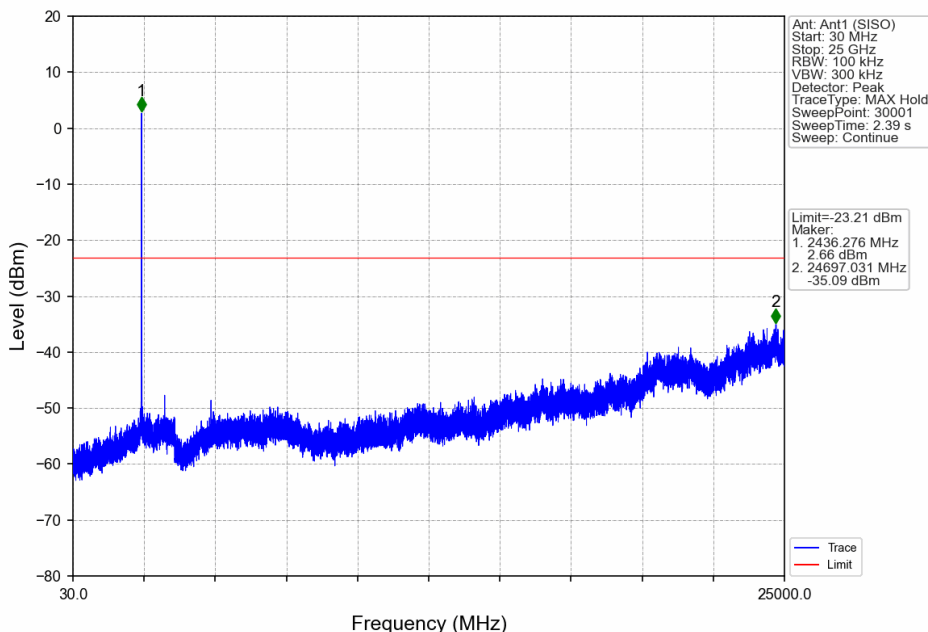
