





Below 30MHz Test Setup




Below 1000MHz Test Setup

- If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit Below 1 GHz, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed. But the Peak Value and average value both need to comply with applicable limit above 1 GHz.
- Testing frequency range 30MHz-1GHz the measuring instrument use VBW=120 kHz with Quasi-peak detection. Testing frequency range 9KHz-150Hz the measuring instrument use VBW=200Hz with Quasi-peak detection. 



d is the specified measurement distance in m

- f) Compare the resultant electric field strength level with the applicable regulatory limit.
- g) Perform the radiated spurious emission test.
