BUTTON INTRODUCTION:

1. **Push button:** Control the light. There will be a voice prompt when turning on or off the light

2. **Press button:**

A.When playing music:Press the function once to stop/play; Press twice in a row to the previous song ; Press three times in a row to the next song

B.When the call comes,:Press the function once to answer/end

3. **Microphone:** Automatically turn on after connection

4. **Audio port:**Connect the headphone with your device by the given audio cable.(**Headphone will automatically turn off wireless connection and Microphone if use this audio port.**)

5. **Charging port**

6. **Reminder light:**Red light flash Intermittently when not paring, when connect successful reminder light will turn off; The Reminder light flash blue light when charging,Reminder light will turn off when full charging.

Battery below 10%, audio reminder: Battery is running low

When charging, the Bluetooth function can be used normally, but it is not recommended to use the Bluetooth function during charging, otherwise it may cause the device to heat up.

WAY OF USE:

Long press " ○ " to power on the headphones and then choose Pair Name :**BT-UNICORN** to connect your device with the headphones.
