The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is 3.98dBi . It complies with the standard requirement.



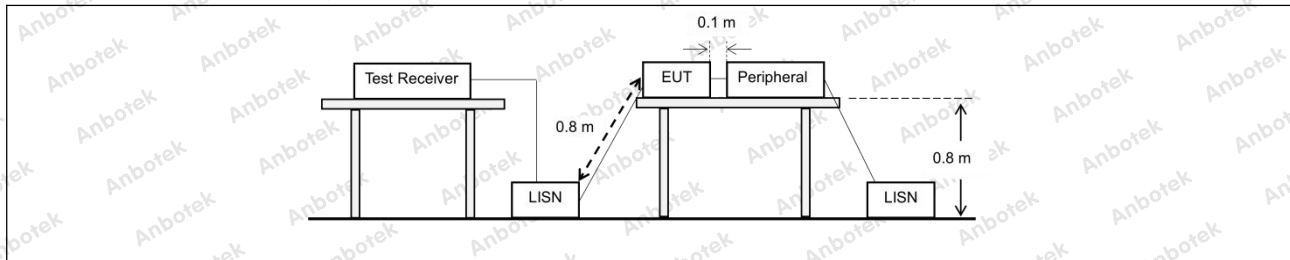

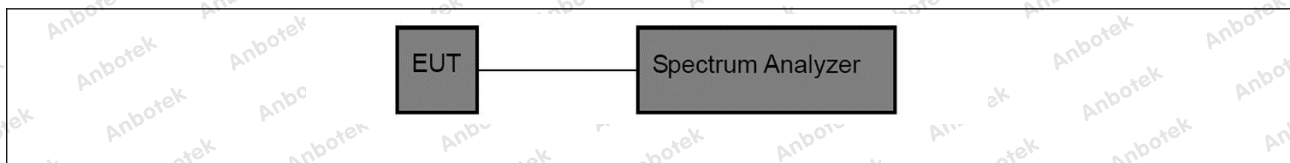
## 5. Maximum Conducted Output Power
