








- The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/50uH of coupling impedance for the measuring instrument.
- Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- ●I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- ●LISN at least 80 cm from nearest part of EUT chassis.









Radiated measurement

Below 1000MHz Test Setup



- 3) For a given signal structure, testing of multiple error-correction coding rates is not required (e.g., 1/2, 2/3, and 3/4).

If a given signal structure can be exercised with various combinations of spatial multiplexing (such as different numbers of spatial streams), beamforming, and cyclic delay diversity, peak excursion tests are not required to include those variations.






