
1. Download the app from Google Play or App store.

Do not try to connect your watch via Bluetooth in the phone settings.



## Charging

To charge the watch, place the watch in the charging dock as shown in the illustration. You will receive a notification in your watch when it's time to charge the watch. The watch has a battery life of up to 10 days.
