





roduct operating instructions

- Power on Method 1: Take out the headphones from charging case, the headphones will turn on automatically Method 2: Long press MFB for 3 seconds.
- Method 1: Put the headphones into the charging case and close the cover. Method 2: After disconnected from the bluetooth device for 3 minutes.

- Method 1: Take out the headphones from the charging case, the headphones will start pairing automatically.
- Method 2: Search and click for "Monster Airmars XKT 10 Pro" on the bluetooth list of the smart device, and when connection is successful, "Connected" will
- * If the distance is exceeded, return to the effective distance within 3 minutes. after disconnection, and automatically connect the device.



- * If the product is not suitable for a long time, it should be fully charged and ensure that the device is in a shutdown state
- * After charging, please pull out the charging cable to avoid equipment damage caused by long-time charging.
