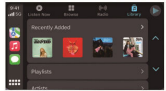

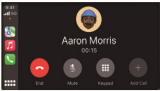

Help-link APLink needs to be installed for the first time.After the product is connected, access the external storage directory using the file browser of the device that find and install the Help-link.apk. After that, disable the voice recognition function for the proper operation of the product.
