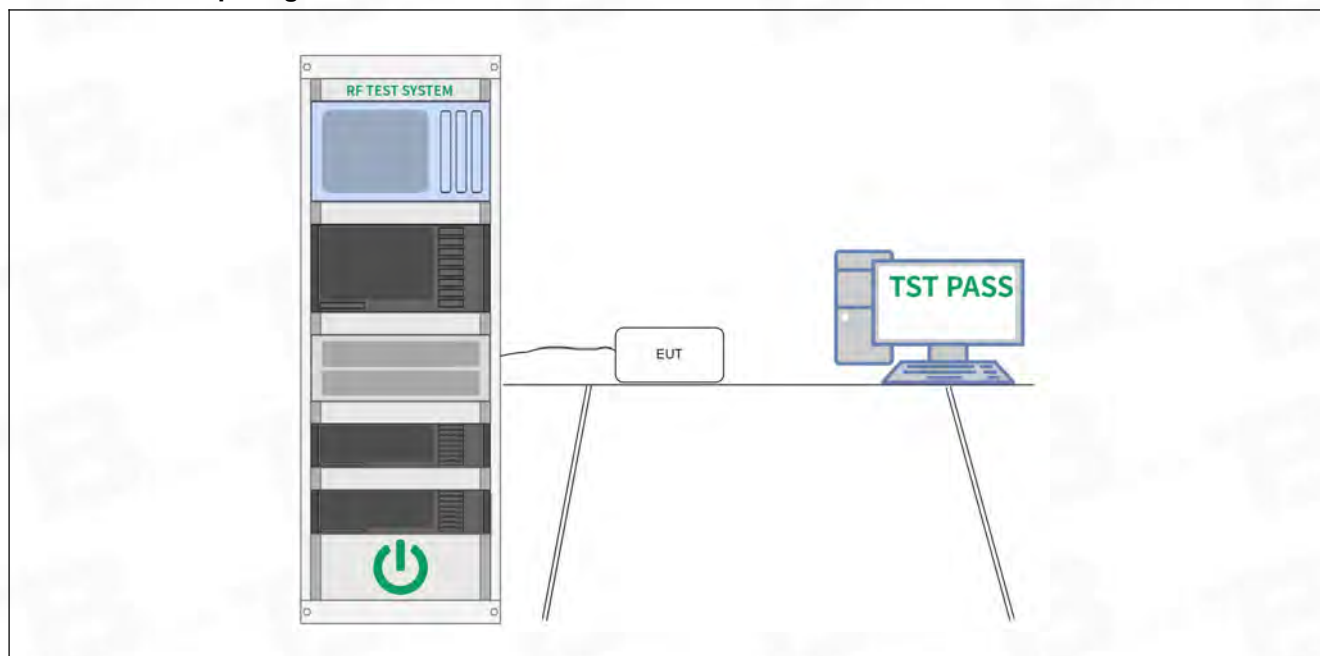

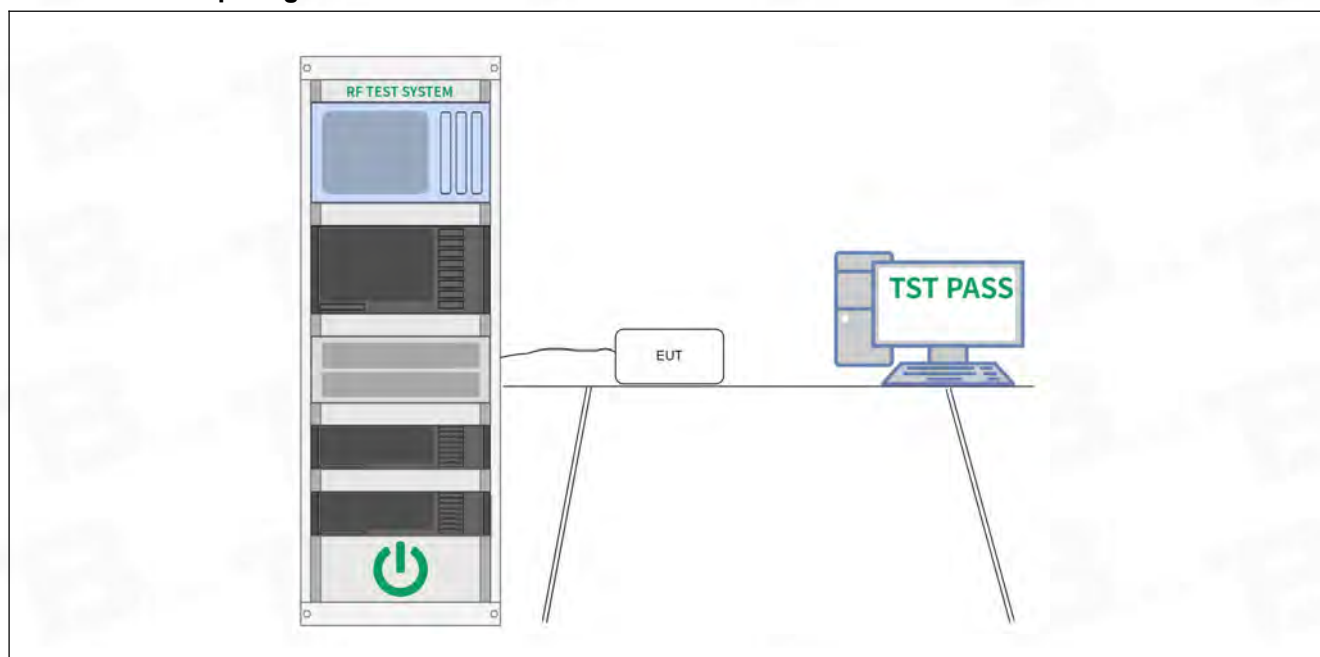

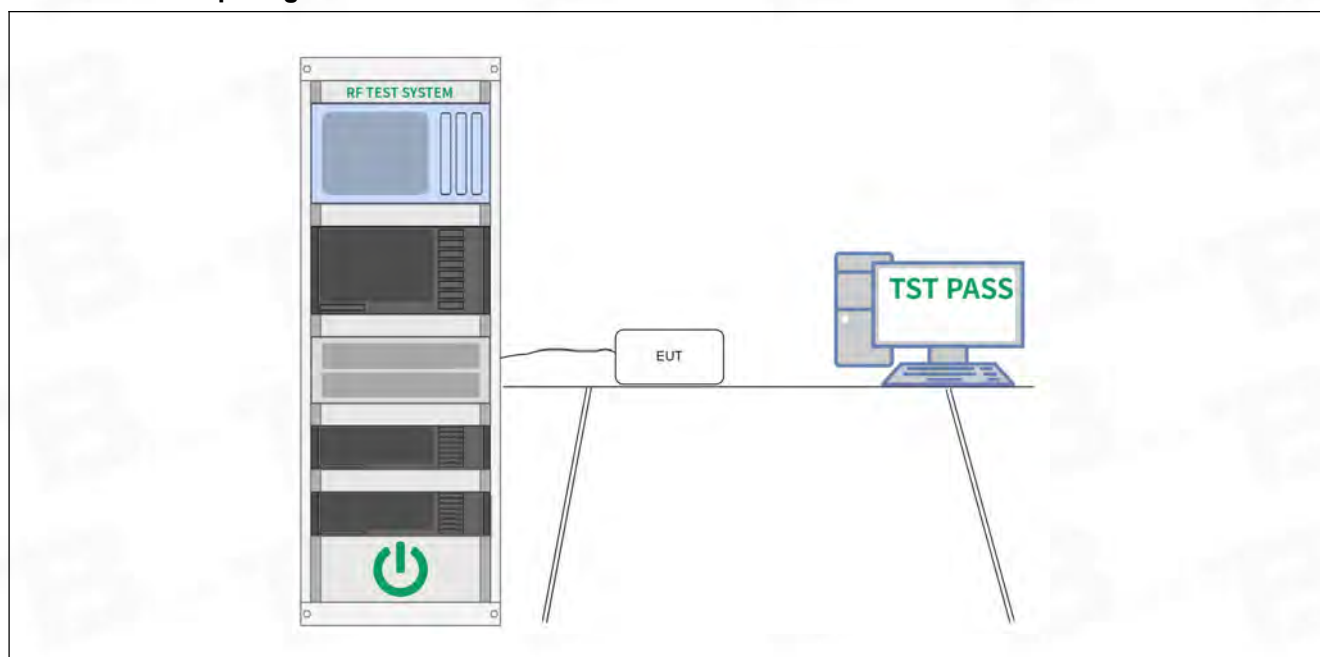

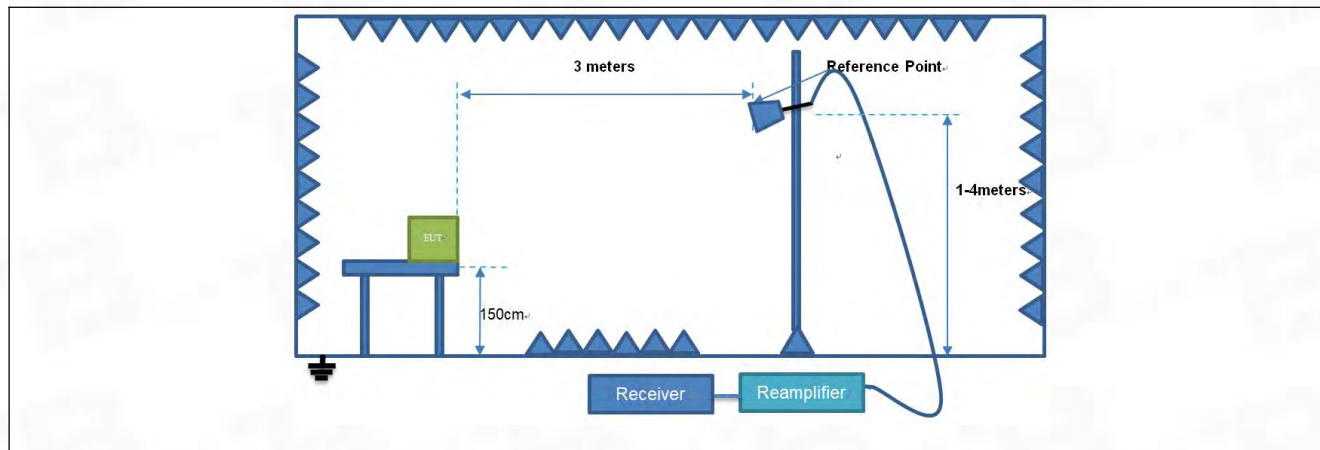

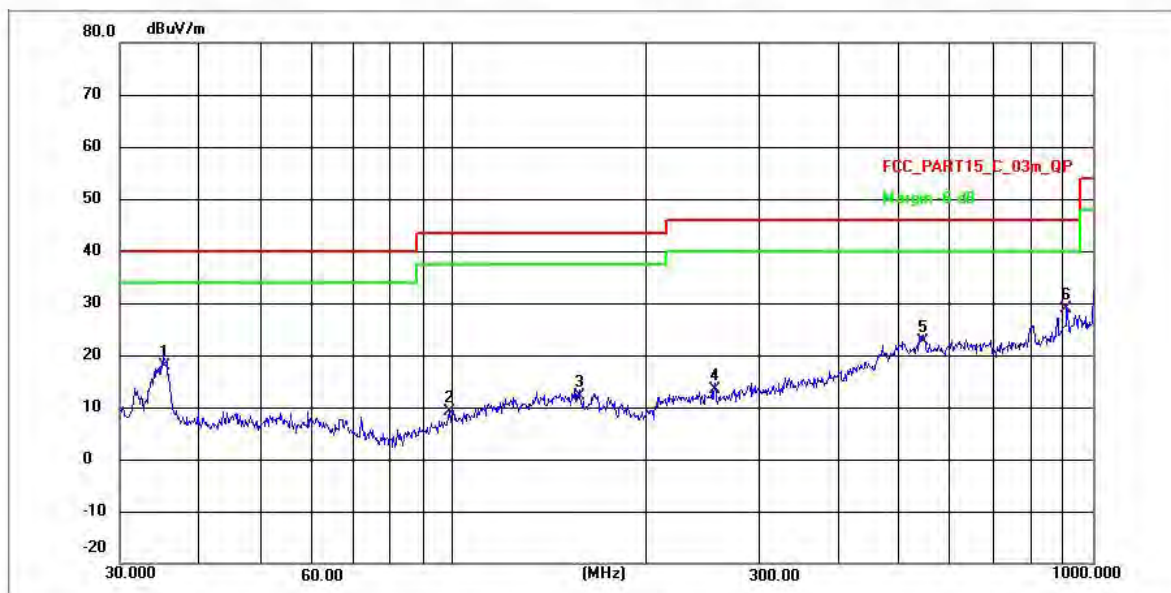

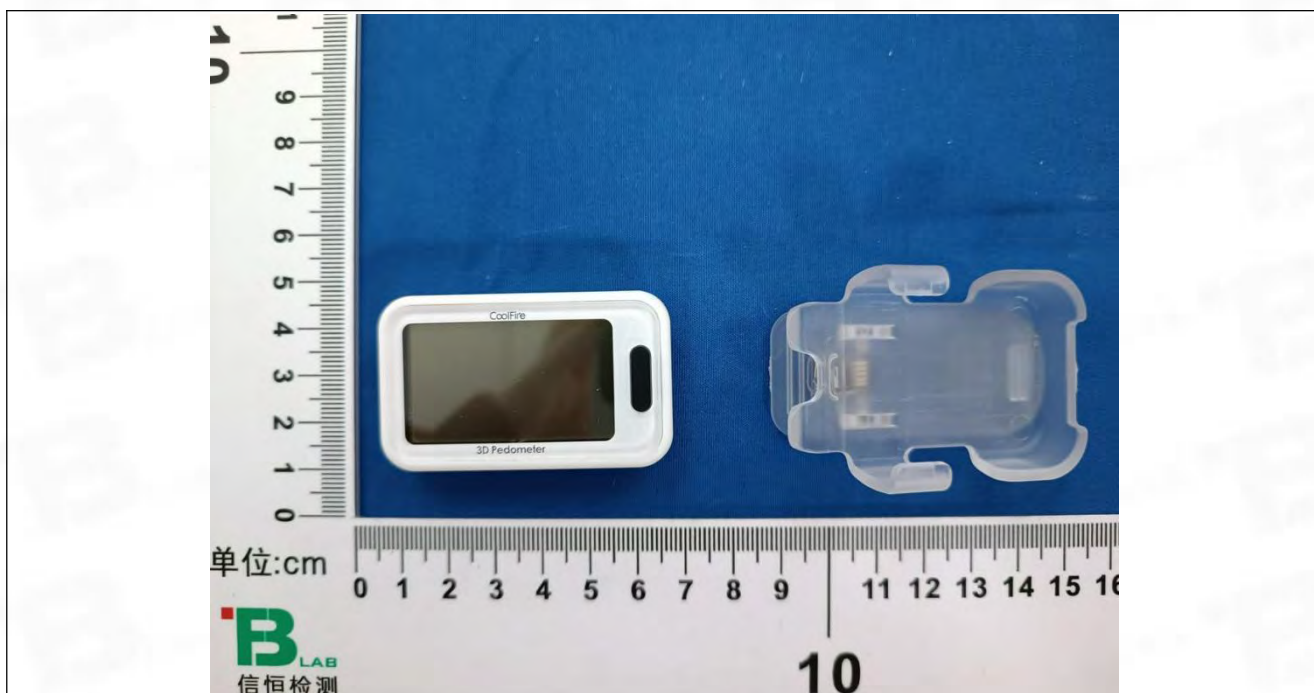


Emissions in frequency bands (below 1GHz)



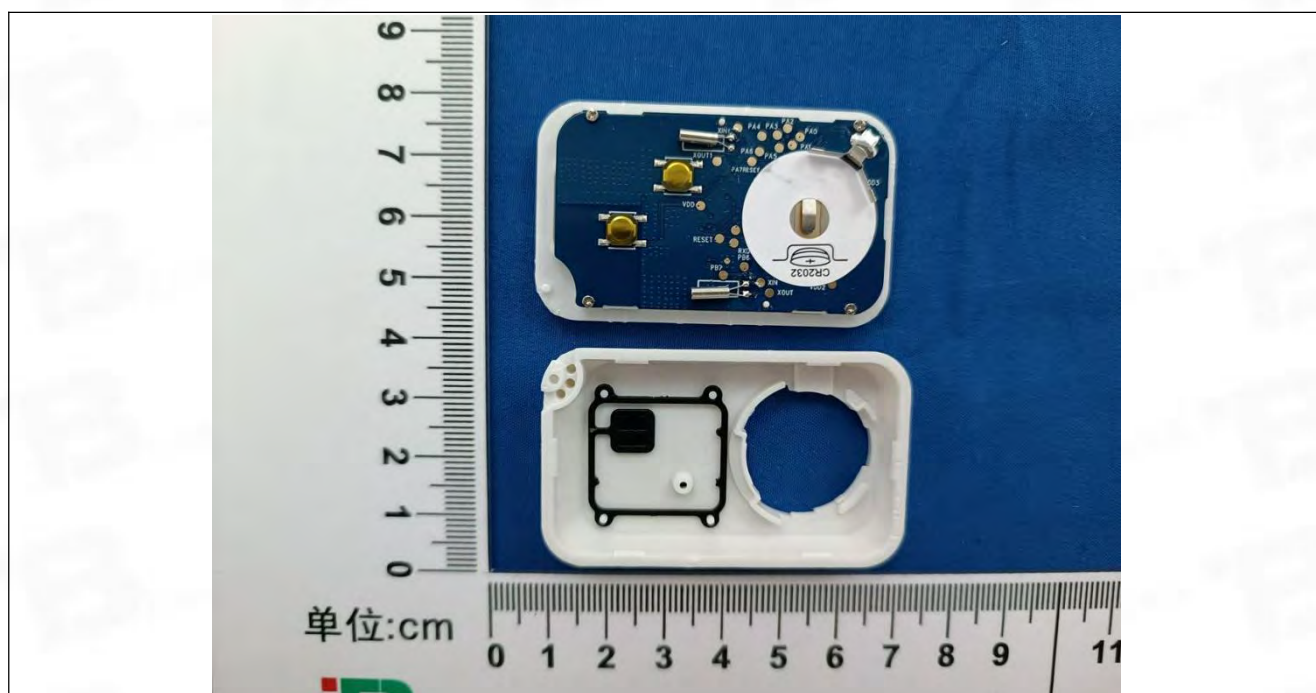
