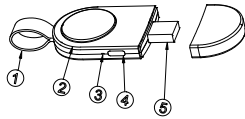


**Redi iWatch

**Functions:**

1. Silicone Strap
2. Wireless Charging Pad Surface
3. LED Indicator
4. Type-C Input Port
5. USB-A Input Port

**What's included:**

1 x iWatch USB Charger

**Tech Specifications**

- Type-C/USB-A Input: DC 5V/1A
- Wireless Output(iWatch): 2W(max.)

**Instructions:**

1. Connect the USB-A Input Port (4) to a USB-A AC adapter or Insert the Type-C tip of a cable into Type-C input port (3); The LED indicator (5) will illuminate RED once the connection is established.
2. Position the iWatch on the designated area of the wireless charging pad (2). The iWatch will automatically secure itself to the pad, triggering the LED to switch to a BLUE light indicating the iWatch is now in the process of charging.

**SAFETY PRECAUTIONS:**

- WARNING-When using this product, basic precautions should always be followed:
1. Read all the instructions before use.
  2. Never store or use this product in temperatures below 32°F(0°C) or above 115°F(45°C).
  3. Do not overcharge your iWatch. The unit may become hot under excessive use. Remove your iWatch once it is fully charged. Never charge your iWatch for more than 7 hours at a time.
  4. To reduce the risk of injury, close supervision is required when the product is used near children.
  5. Do not expose the device to moisture.
  6. Do not use the device in excess of its output rating. Overload outputs above the rating may result in a risk of fire or injury
  7. Do not use the device if damaged or modified.
  8. Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury.

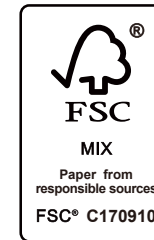
