Test Graphs of Spurious Emissions outside of the 5.25-5.35 GHz band for transmitters operating in the 5.25-5.35 GHz band

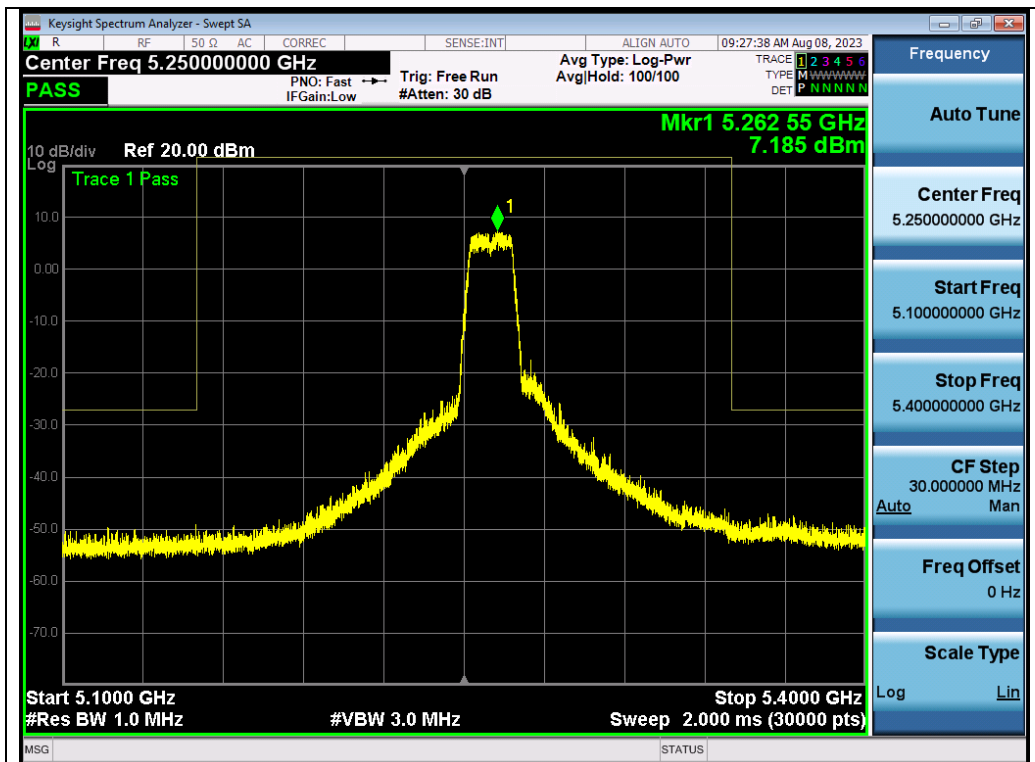

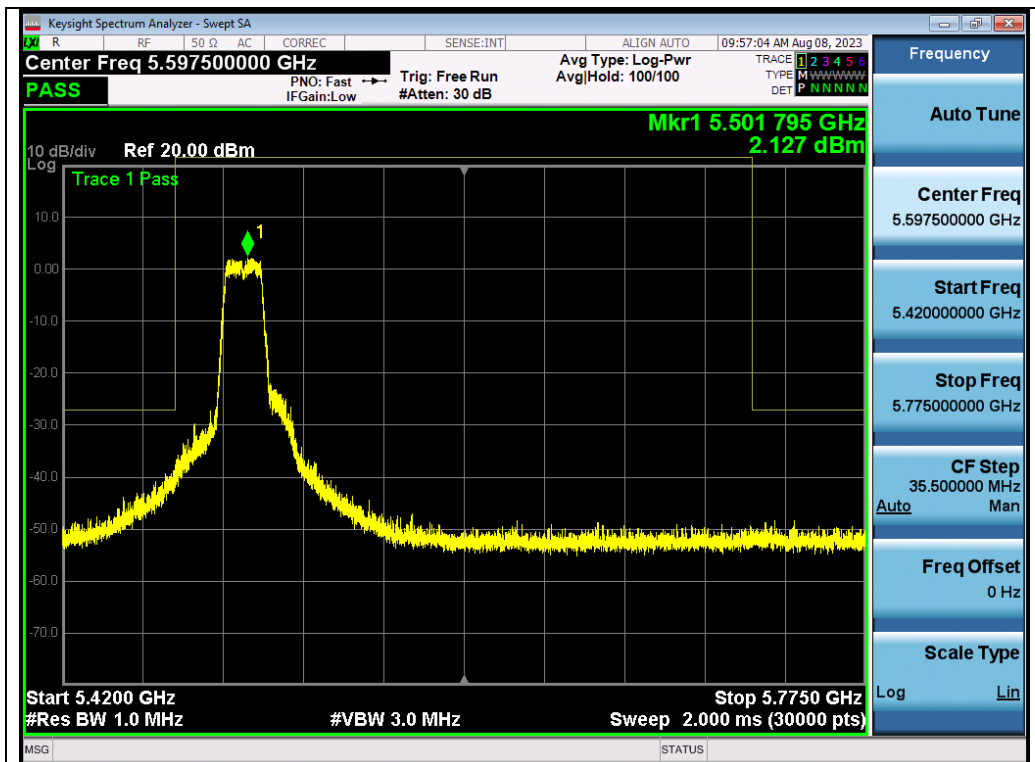

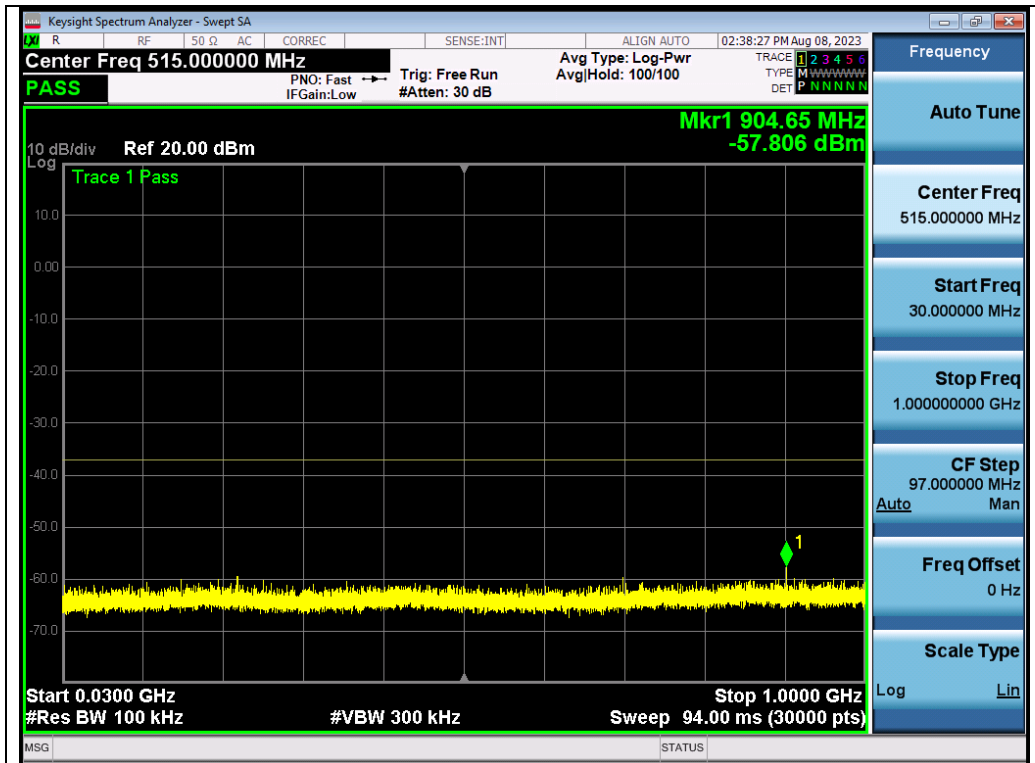


Test_Graph_802.11a_ANT2_5500_6Mbps_Frequency Band 3

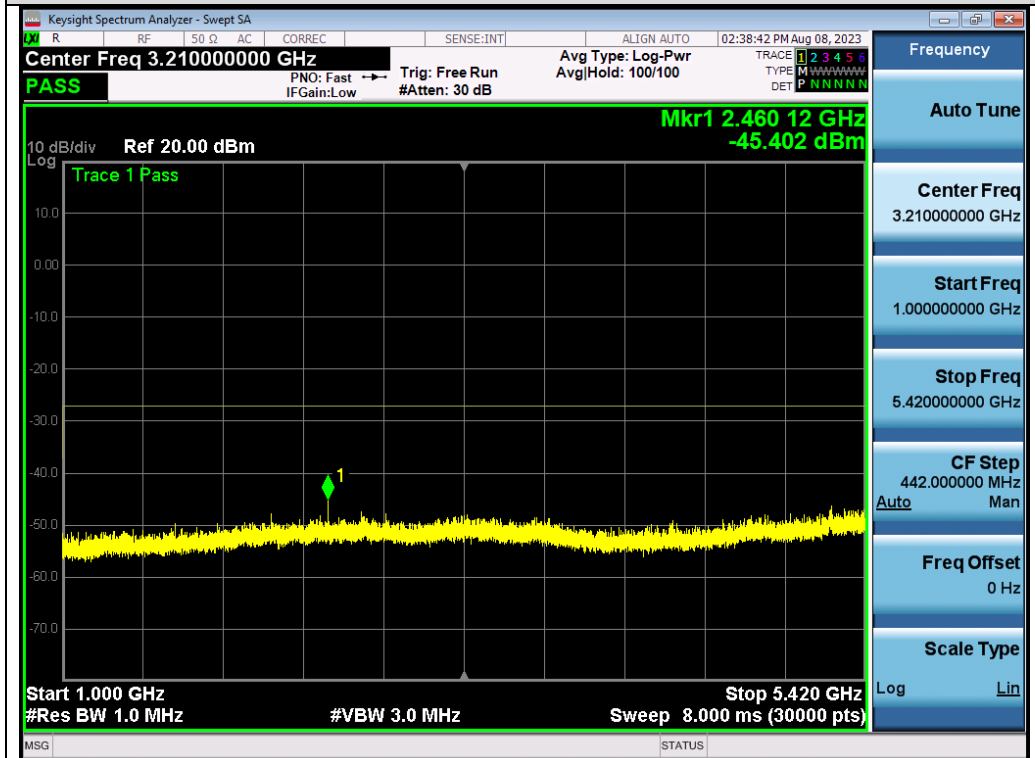

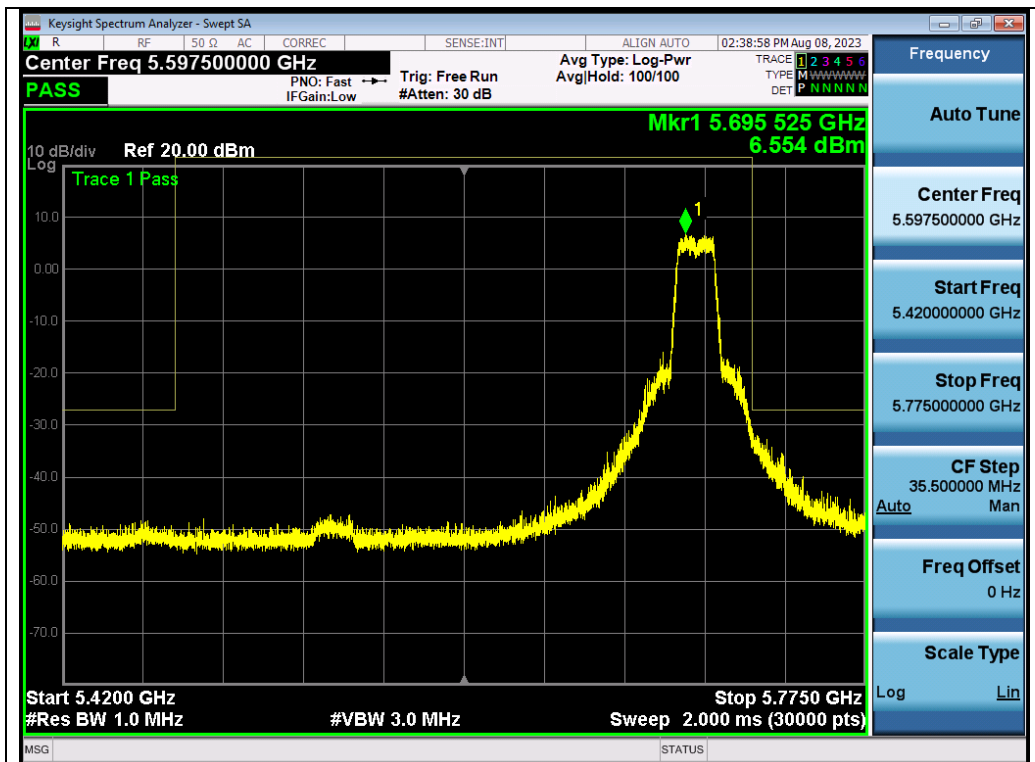


Test_Graph_802.11a_ANT2_5700_6Mbps_Frequency Band 1

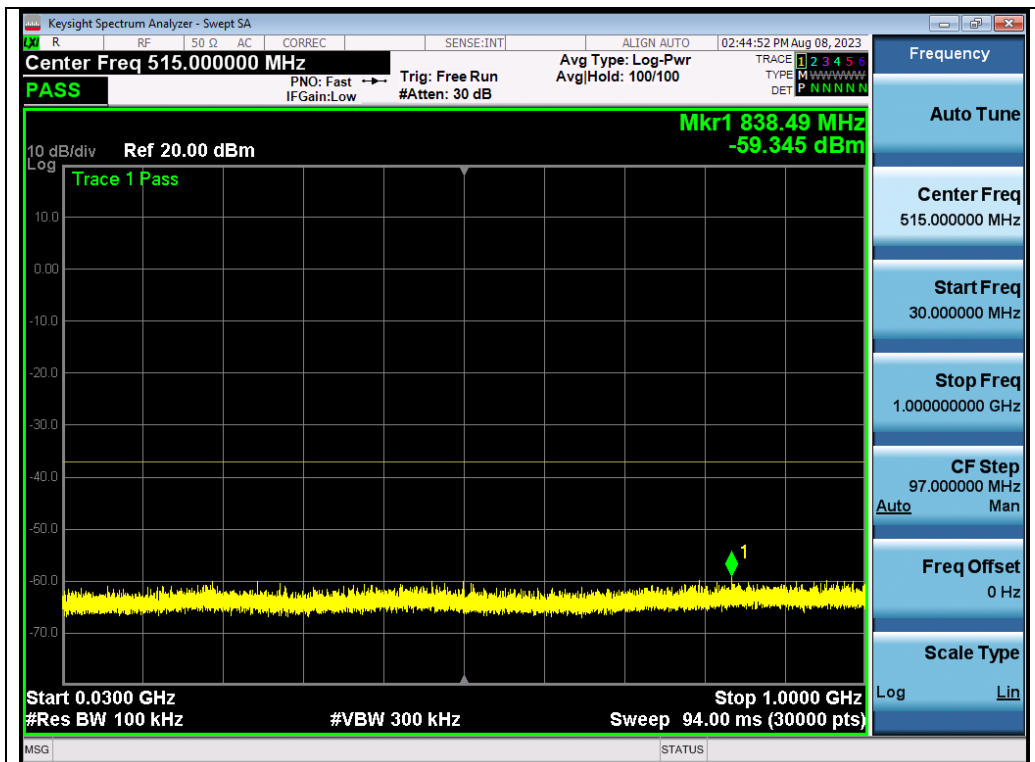


Test_Graph_802.11a_ANT2_5700_6Mbps_Frequency Band 3

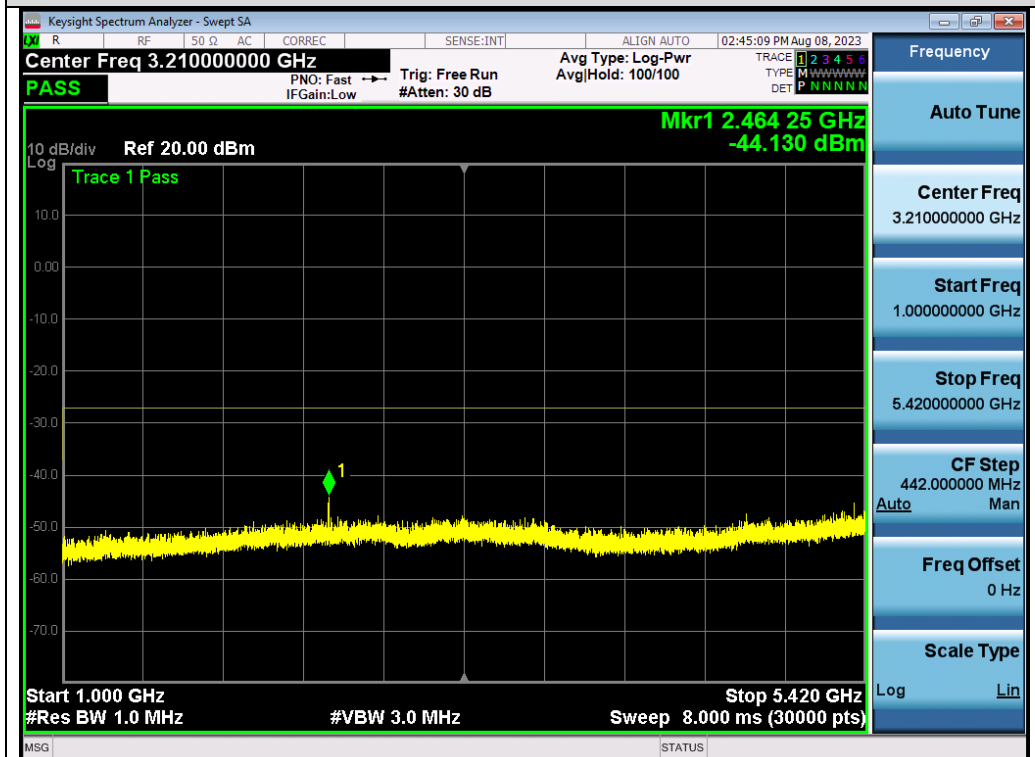

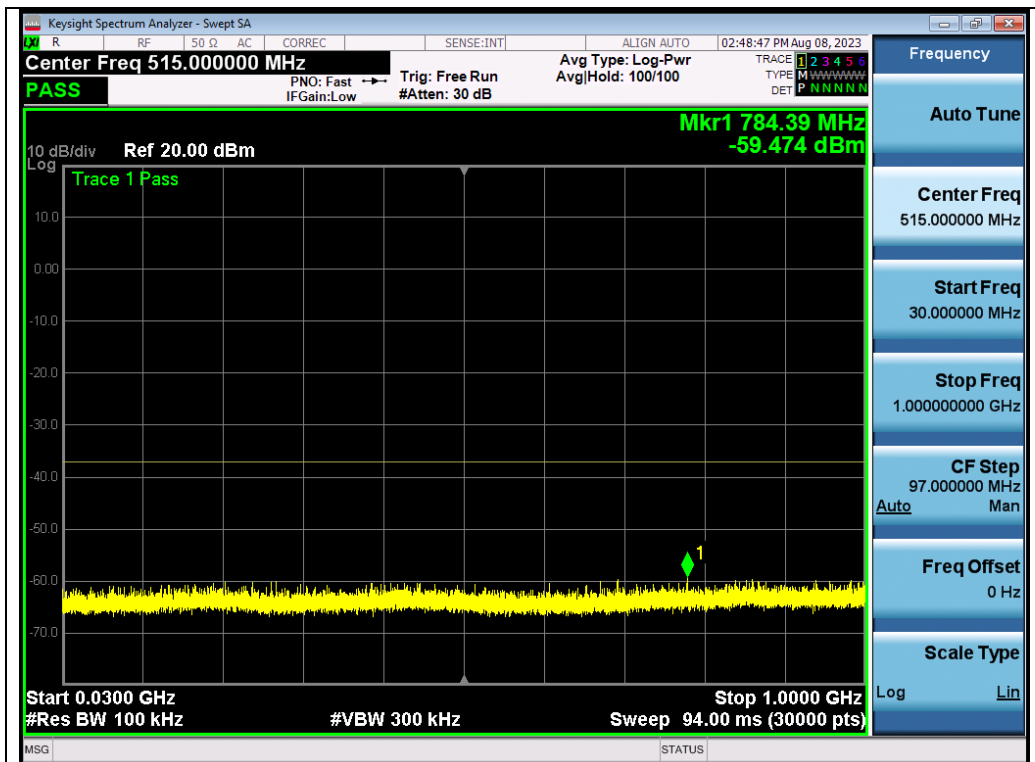

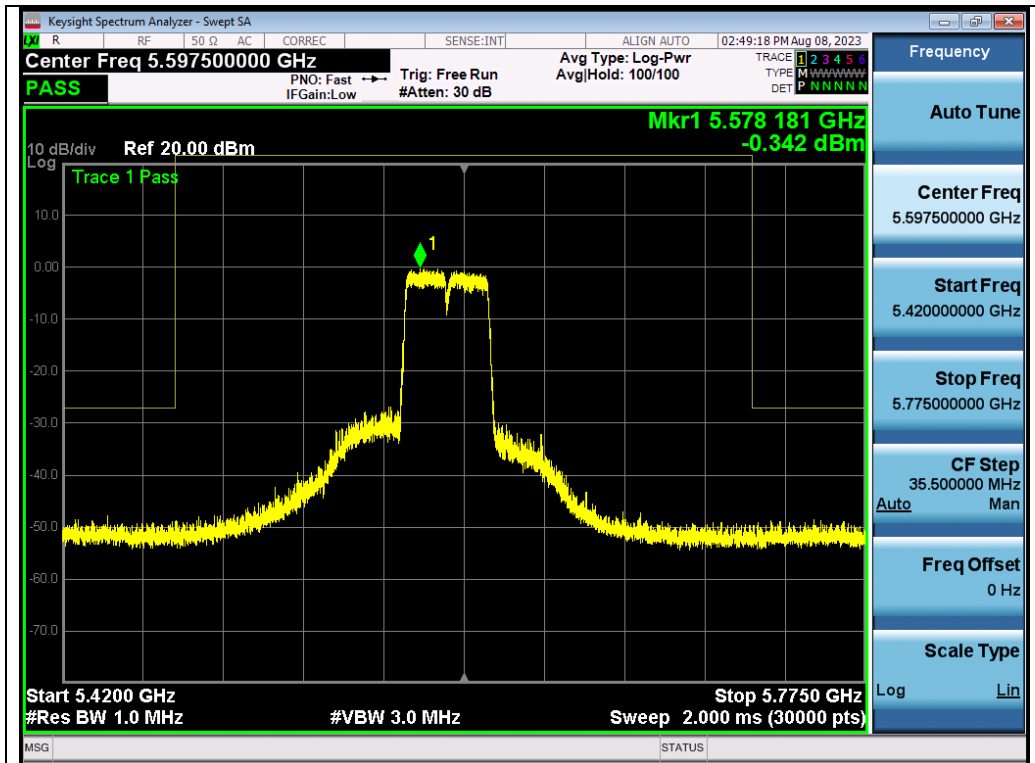


Test_Graph_802.11n40_ANT2_5590_MCS0_Frequency Band 1

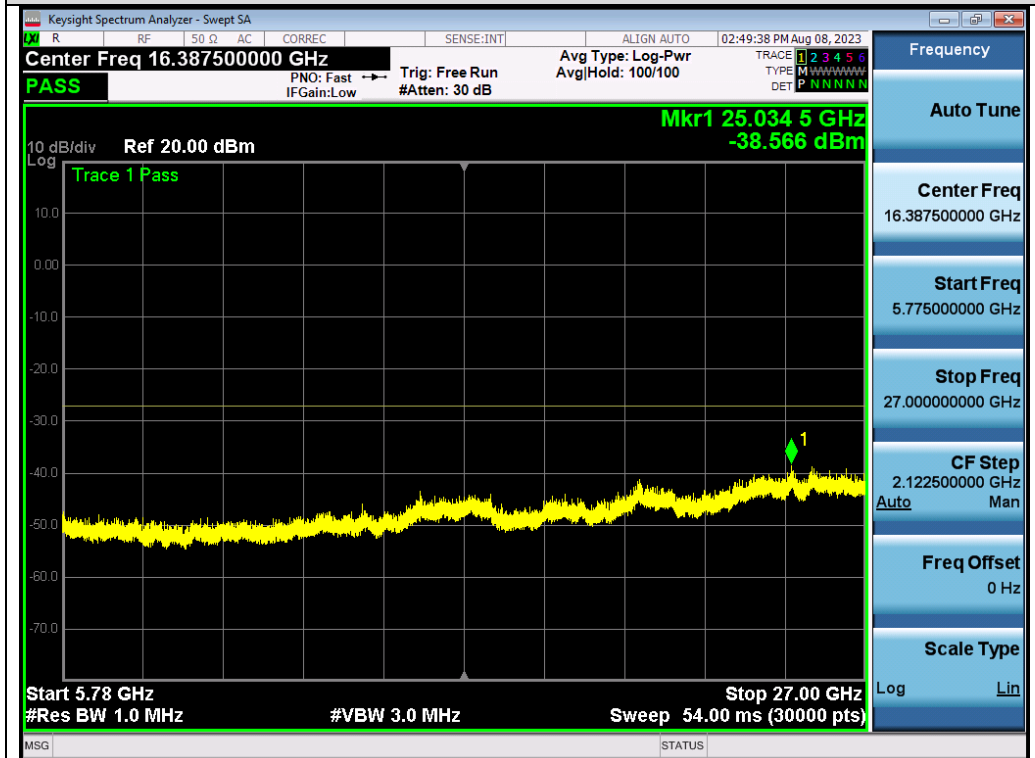

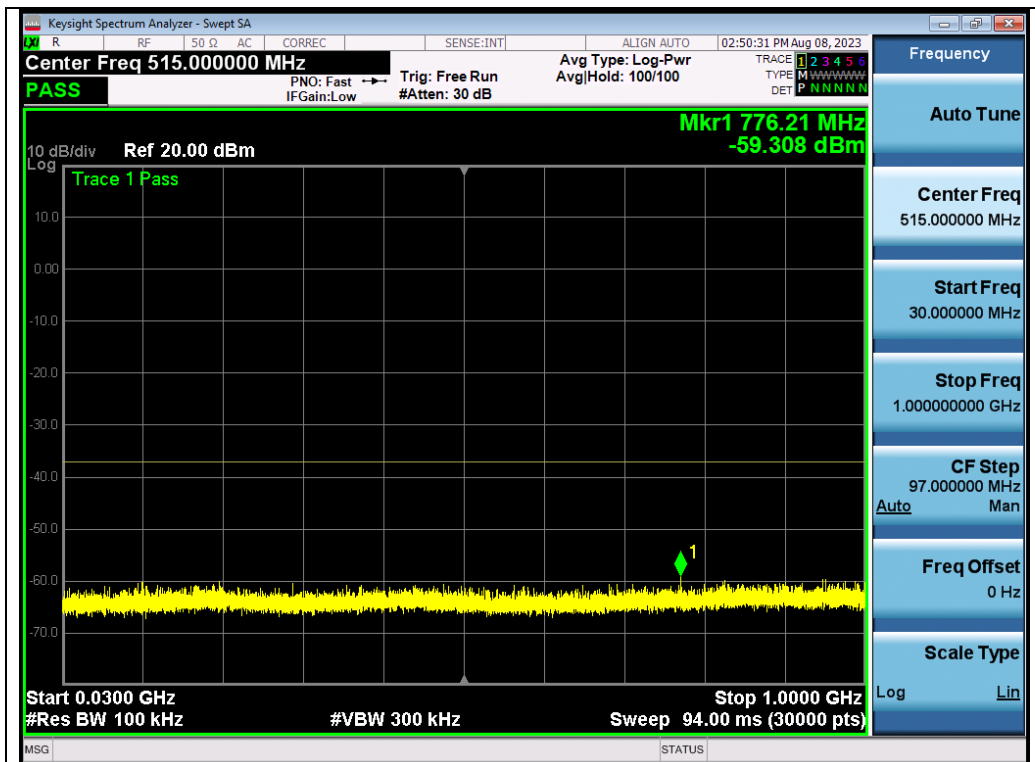


Test_Graph_802.11n40_ANT2_5590_MCS0_Frequency Band 3

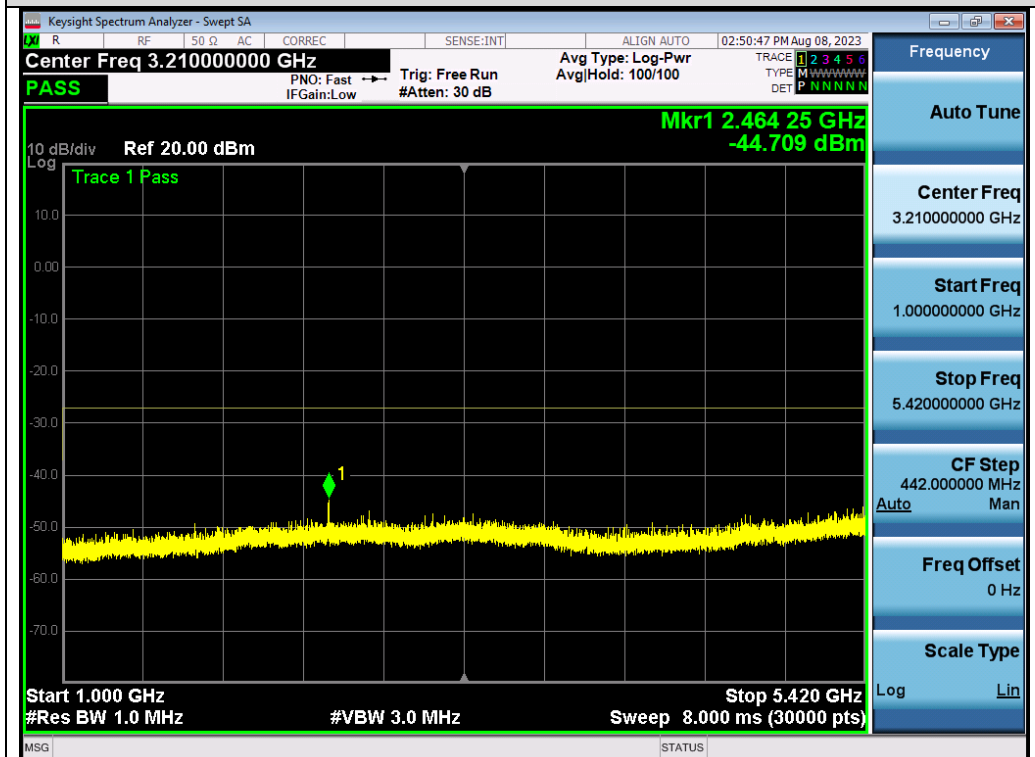

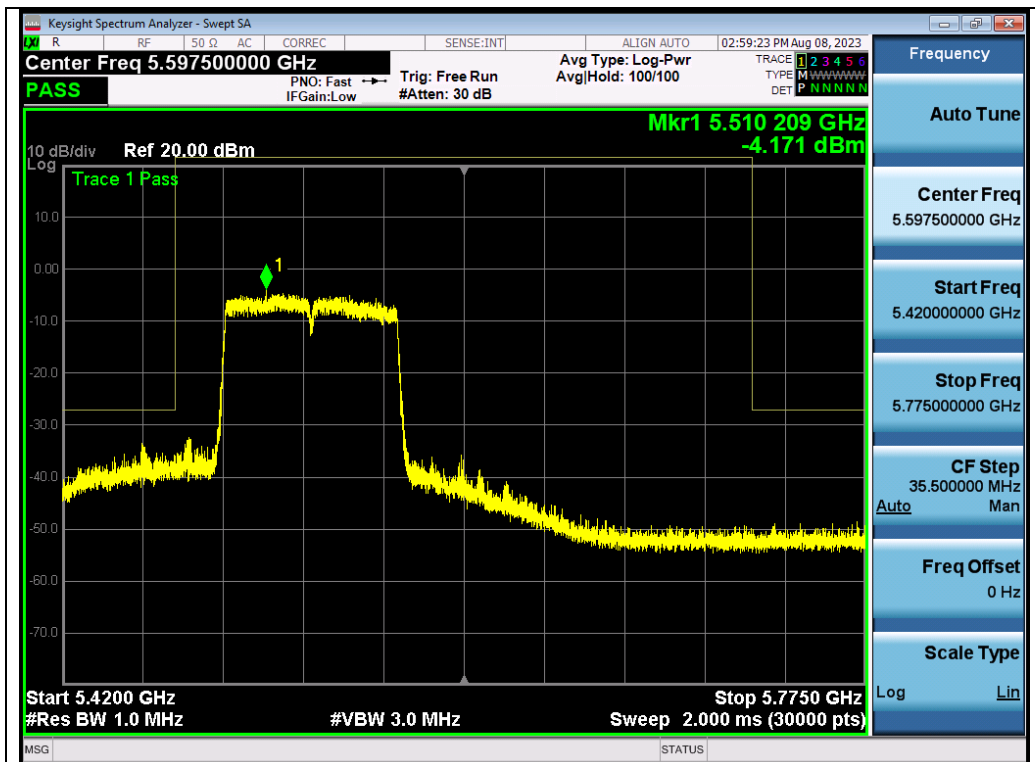

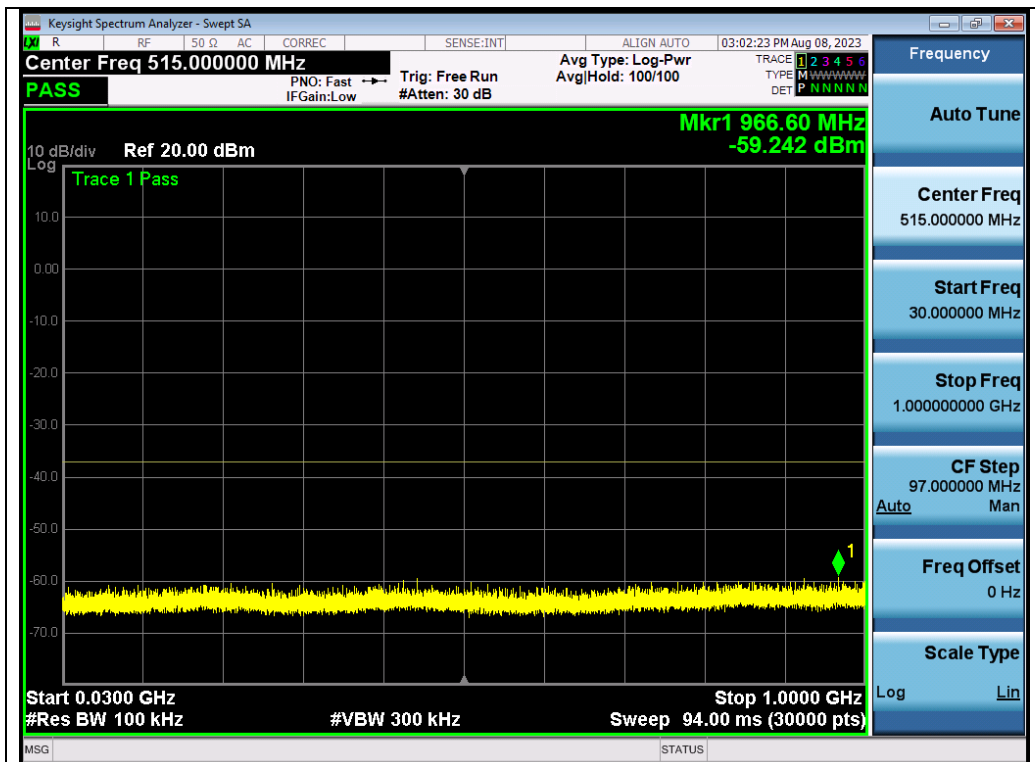


Test_Graph_802.11ac80_ANT2_5530_MCS9_Frequency Band 3

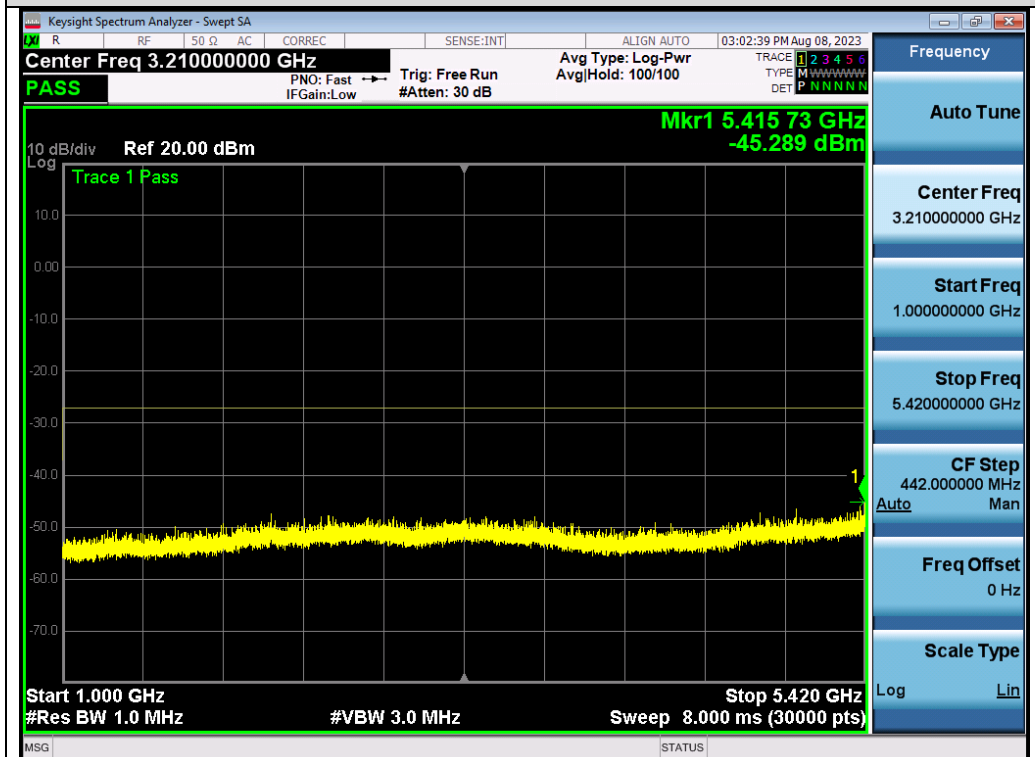


Test_Graph_802.11ac80_ANT2_5530_MCS9_Frequency Band 4

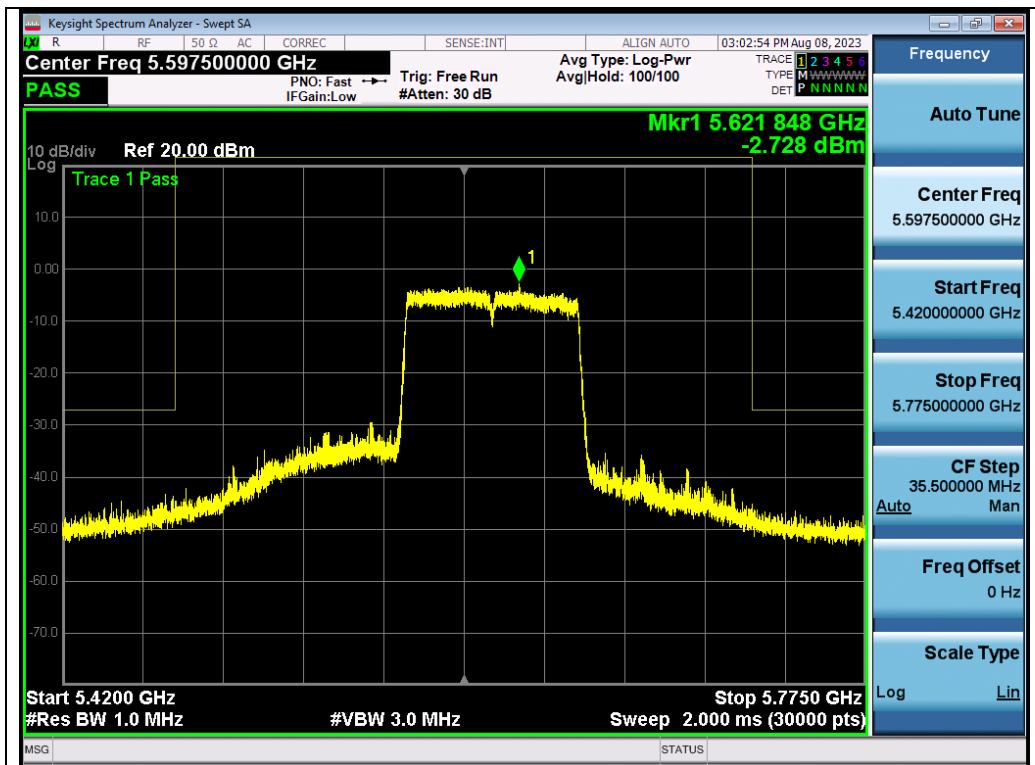

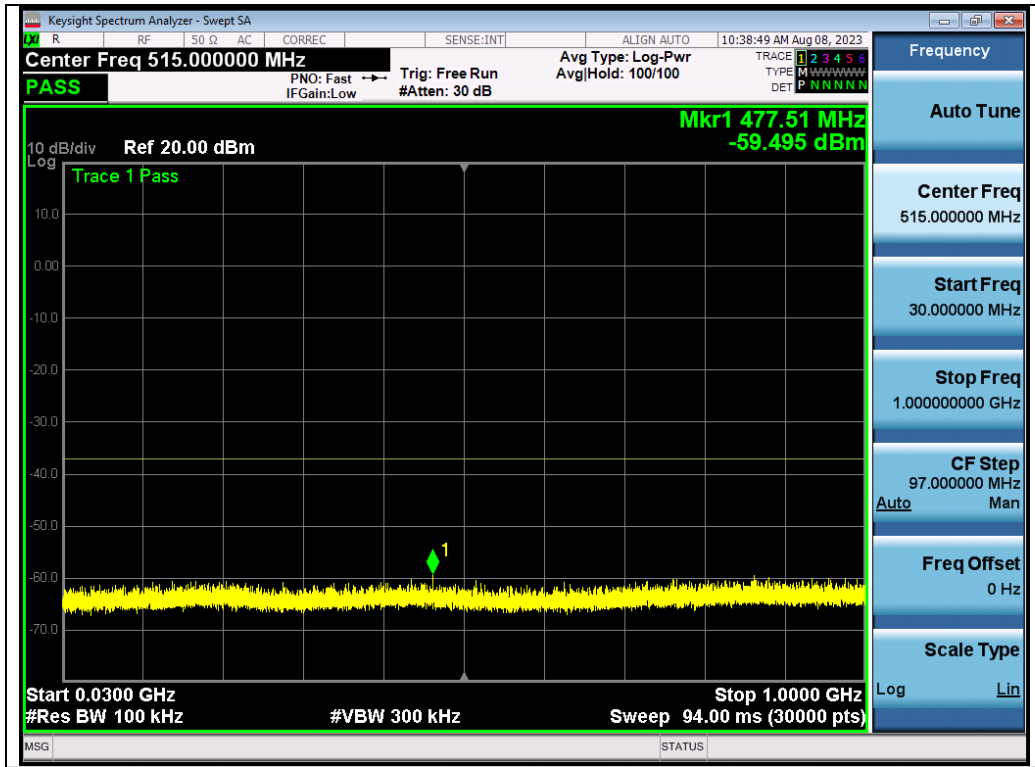

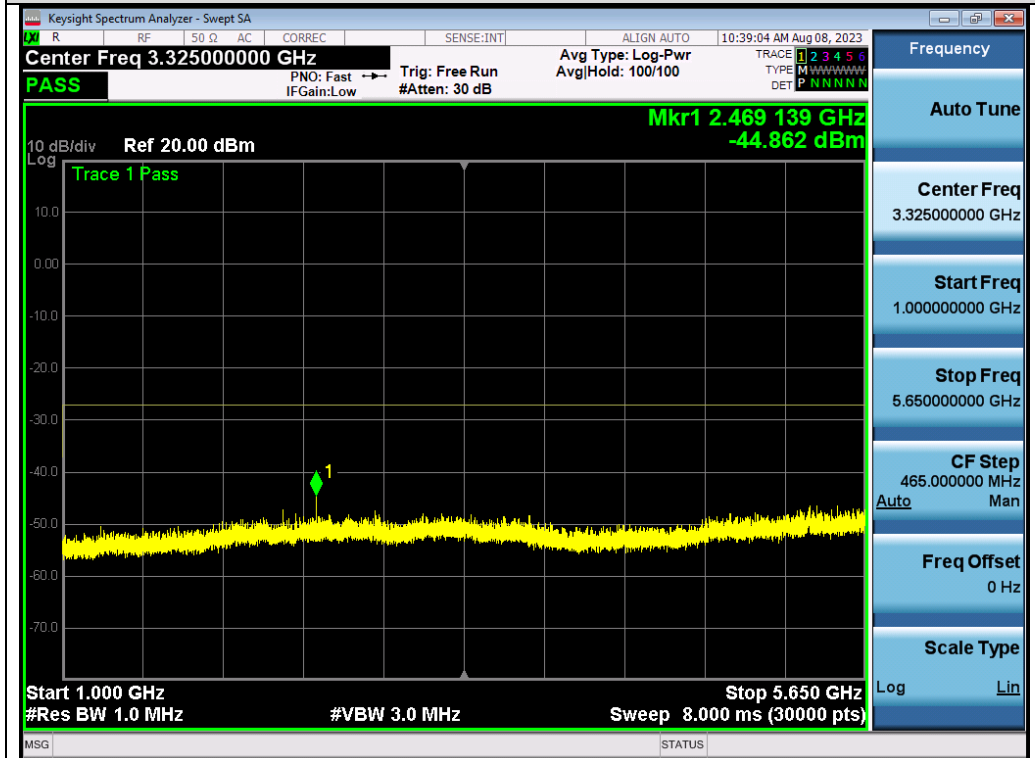

Test Graphs of Spurious Emissions outside of the 5.725-5.85 GHz band for transmitters operating in the 5.725-5.85 GHz band

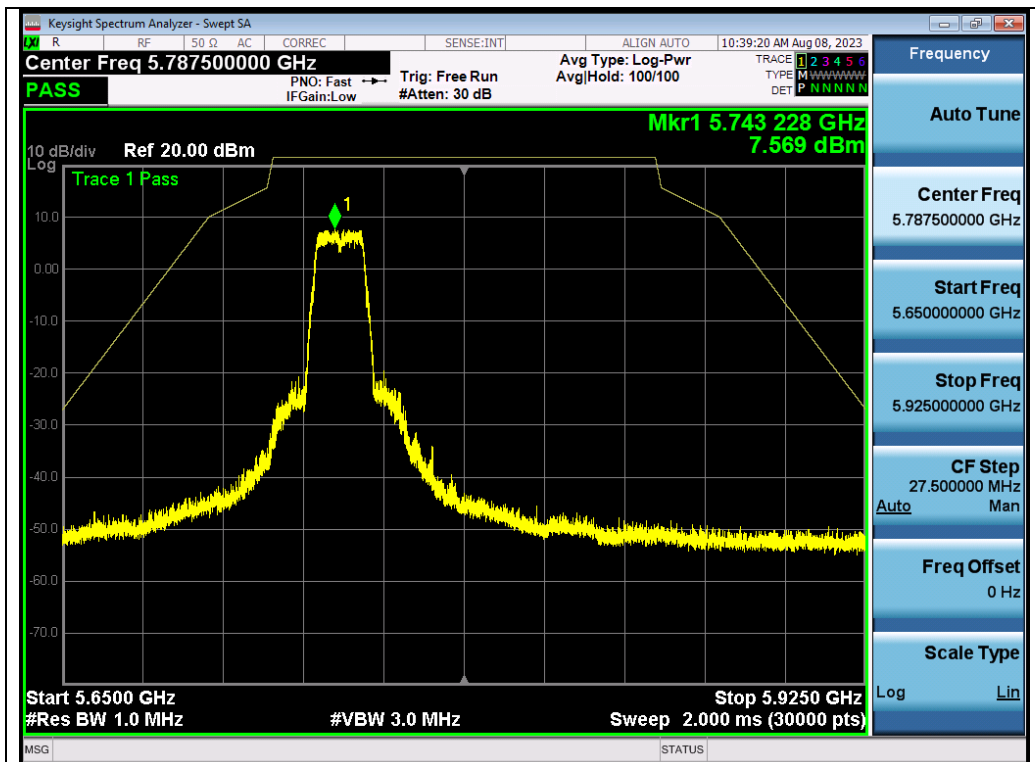
