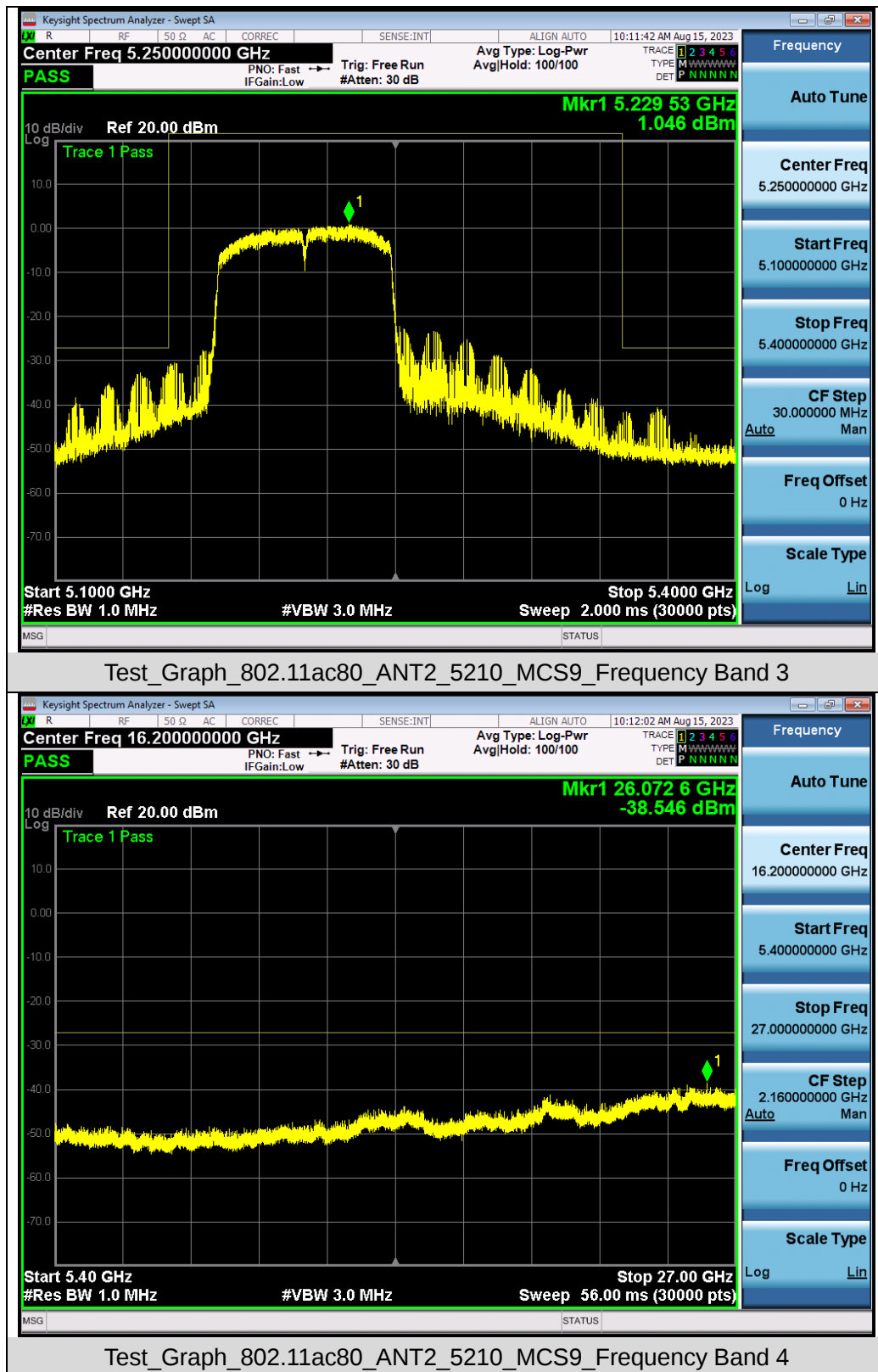
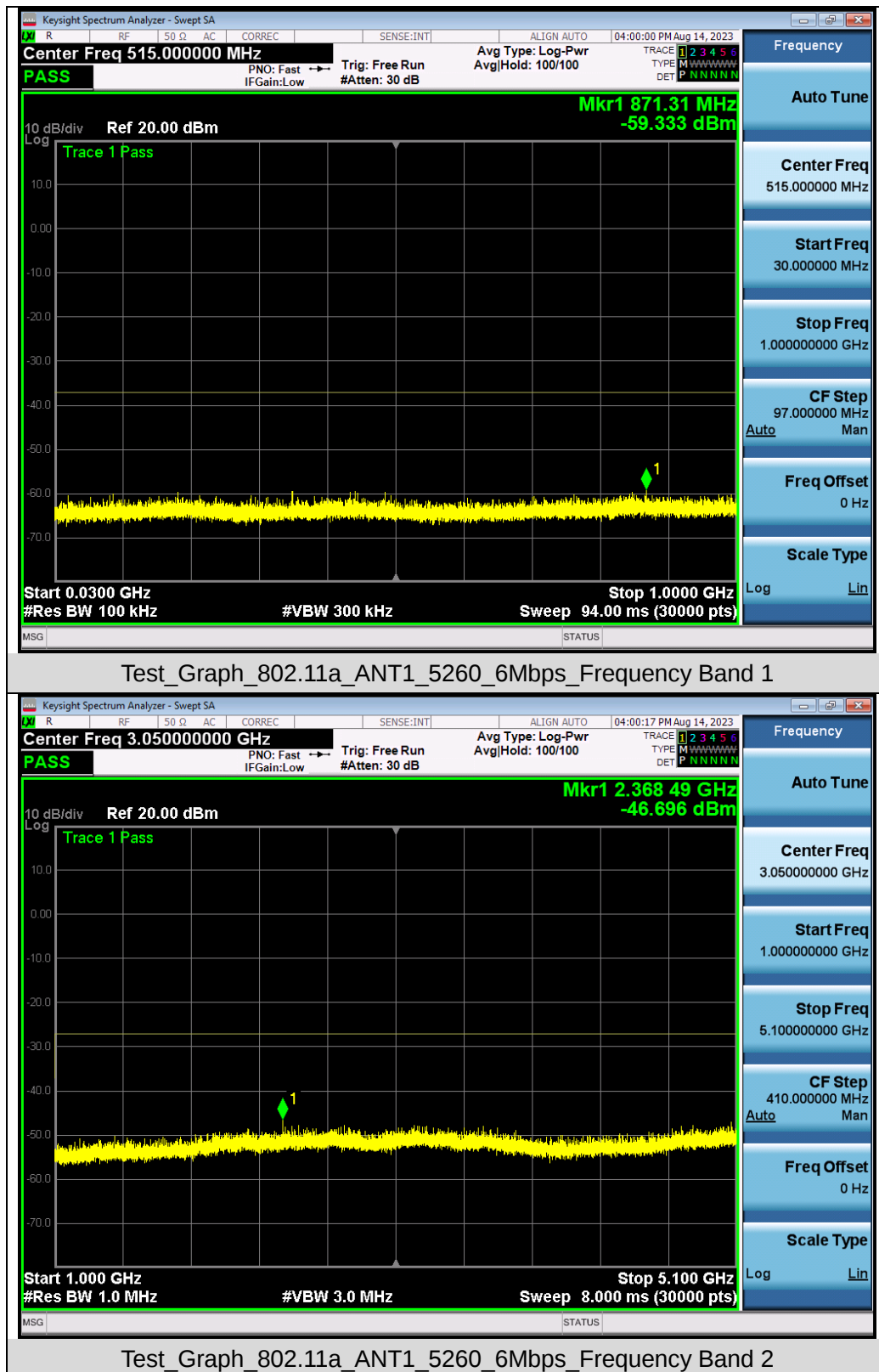




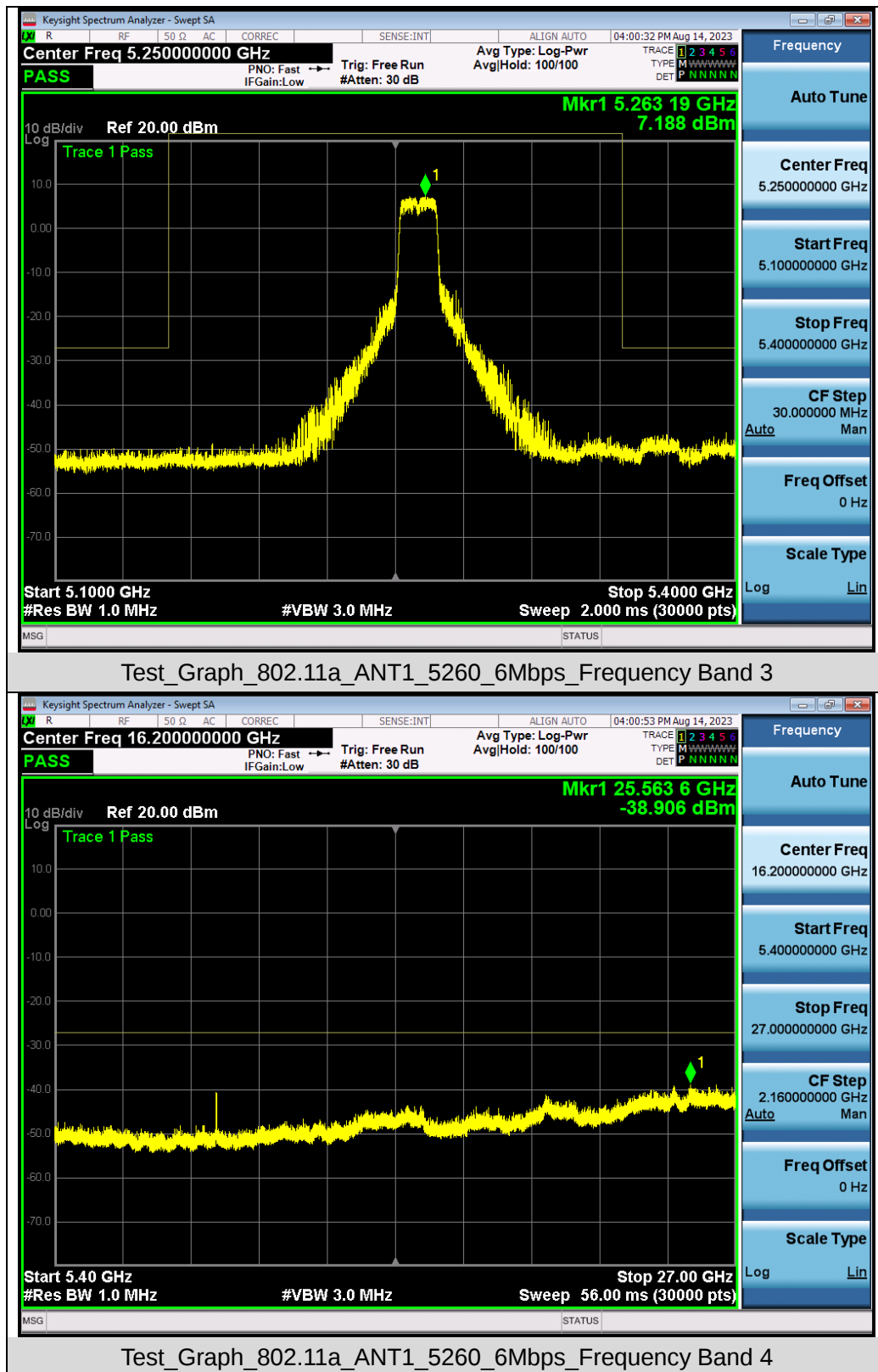

Test Graphs of Spurious Emissions outside of the 5.25-5.35 GHz band for transmitters operating in the 5.25-5.35 GHz band

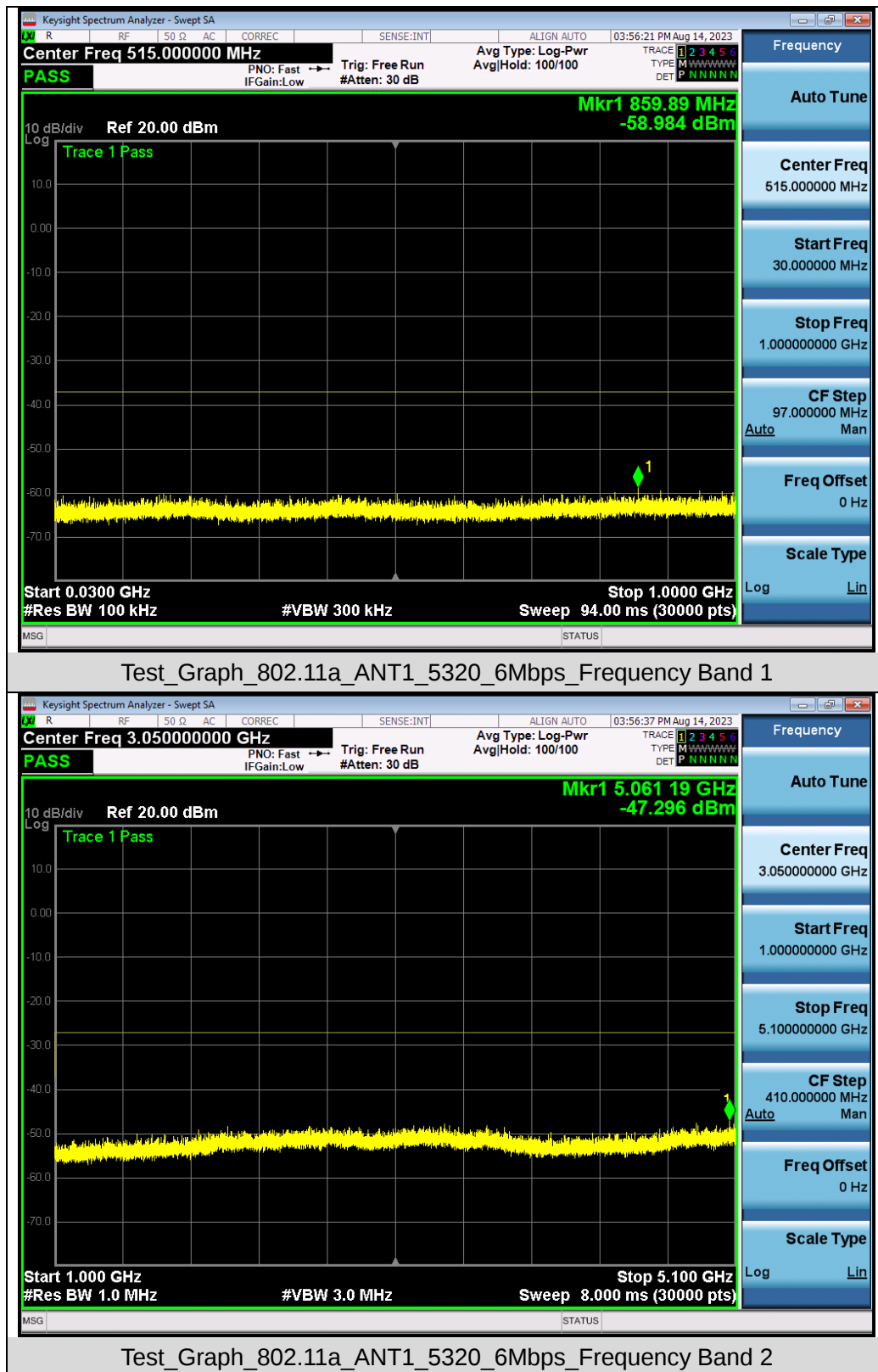
