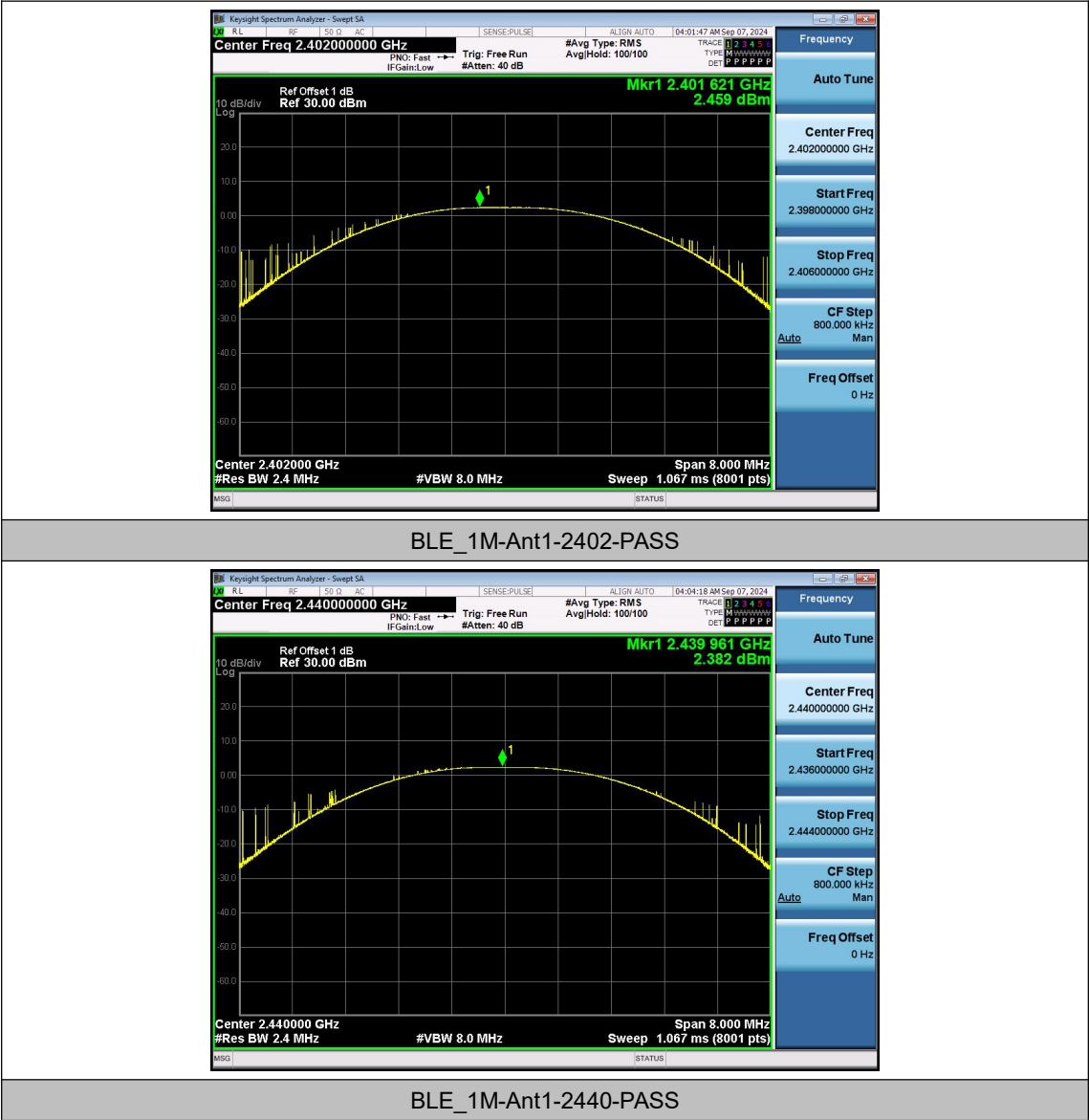

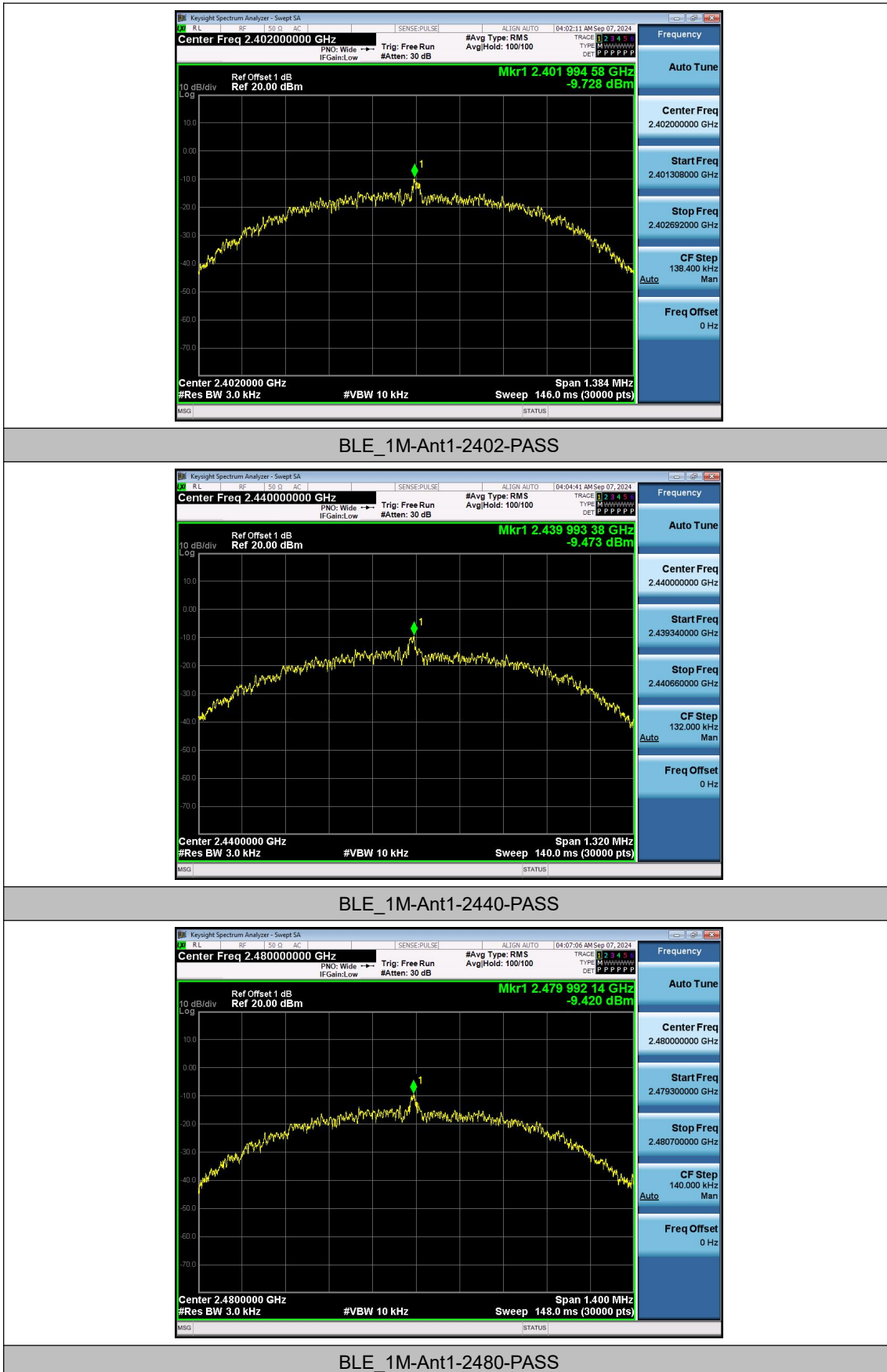

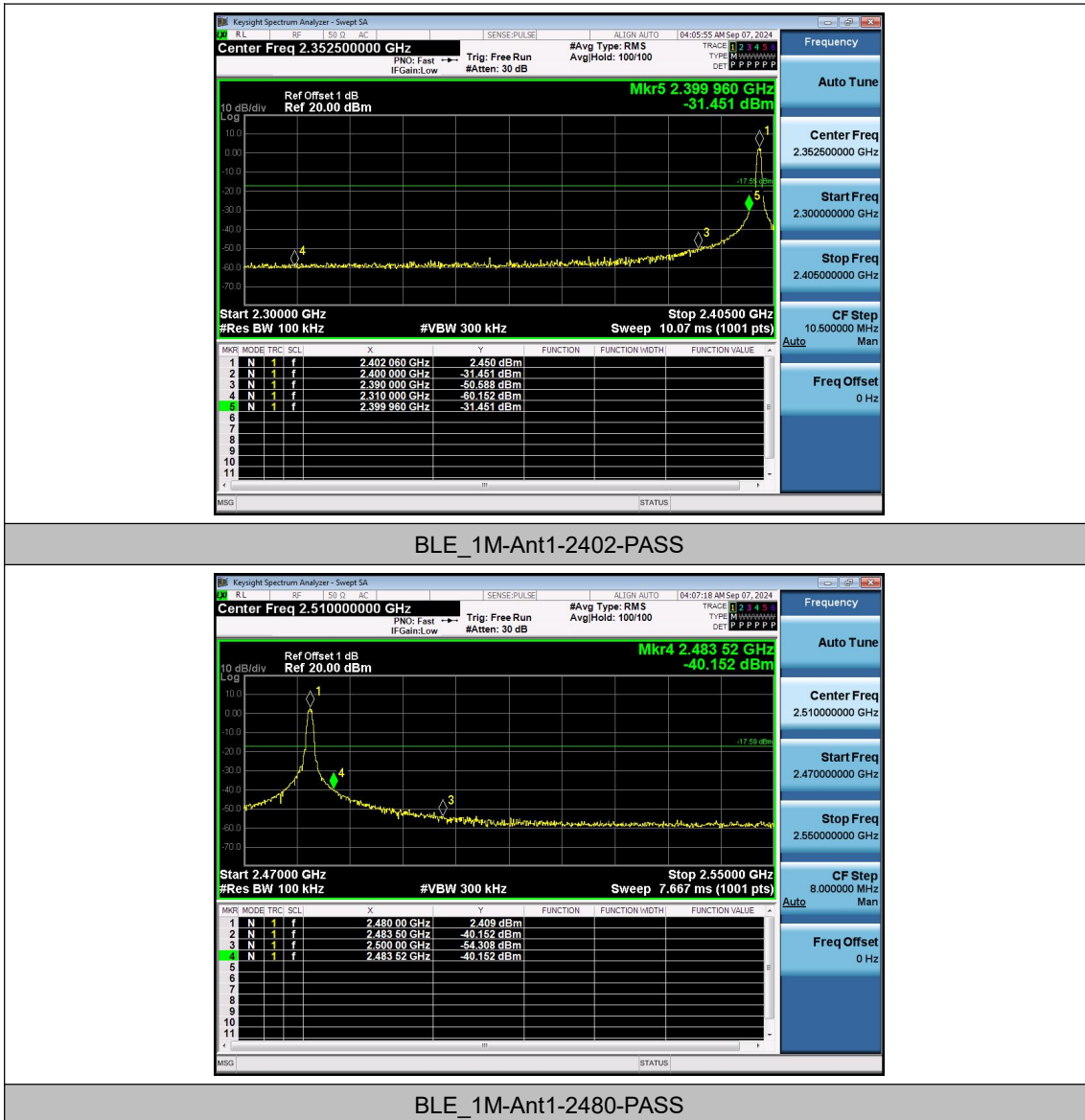

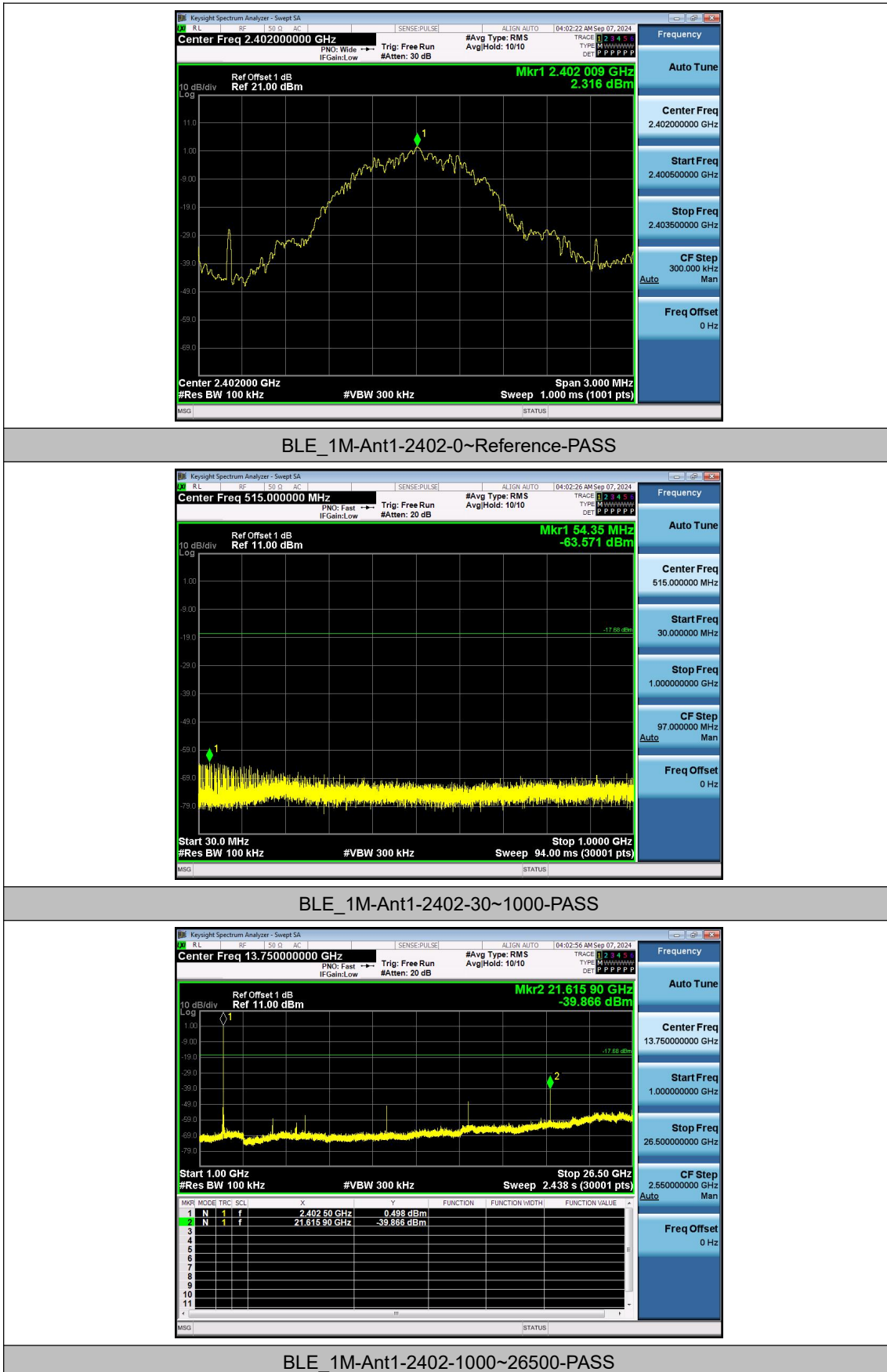

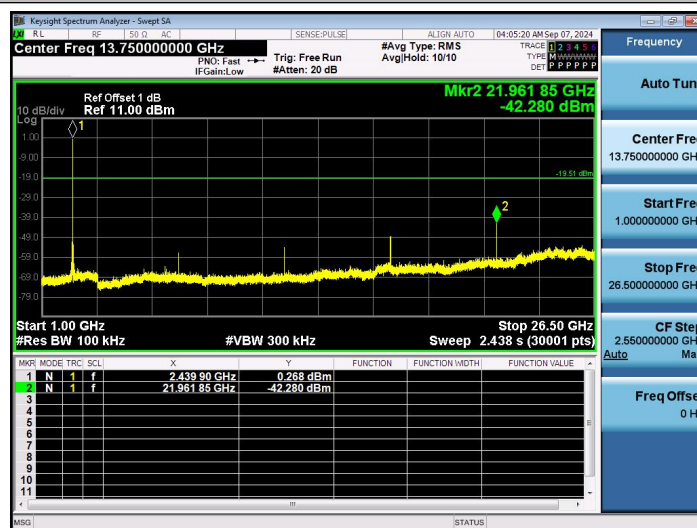




BLE_1M-Ant1-2440-0~Reference-PASS



BLE_1M-Ant1-2440-30~1000-PASS

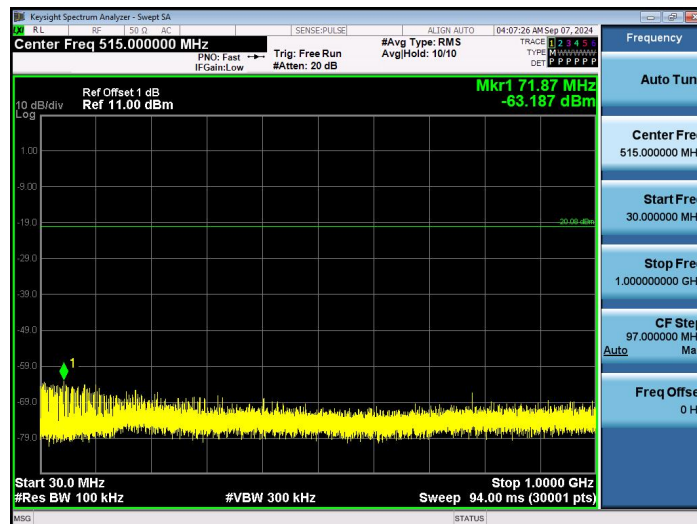


BLE_1M-Ant1-2440-1000~26500-PASS

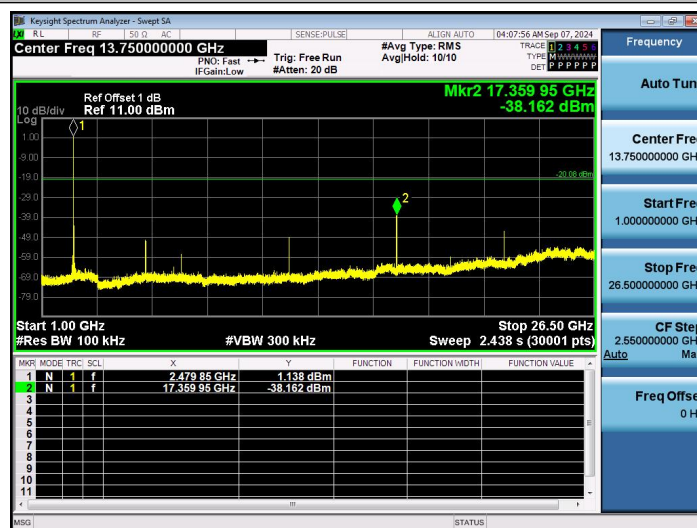

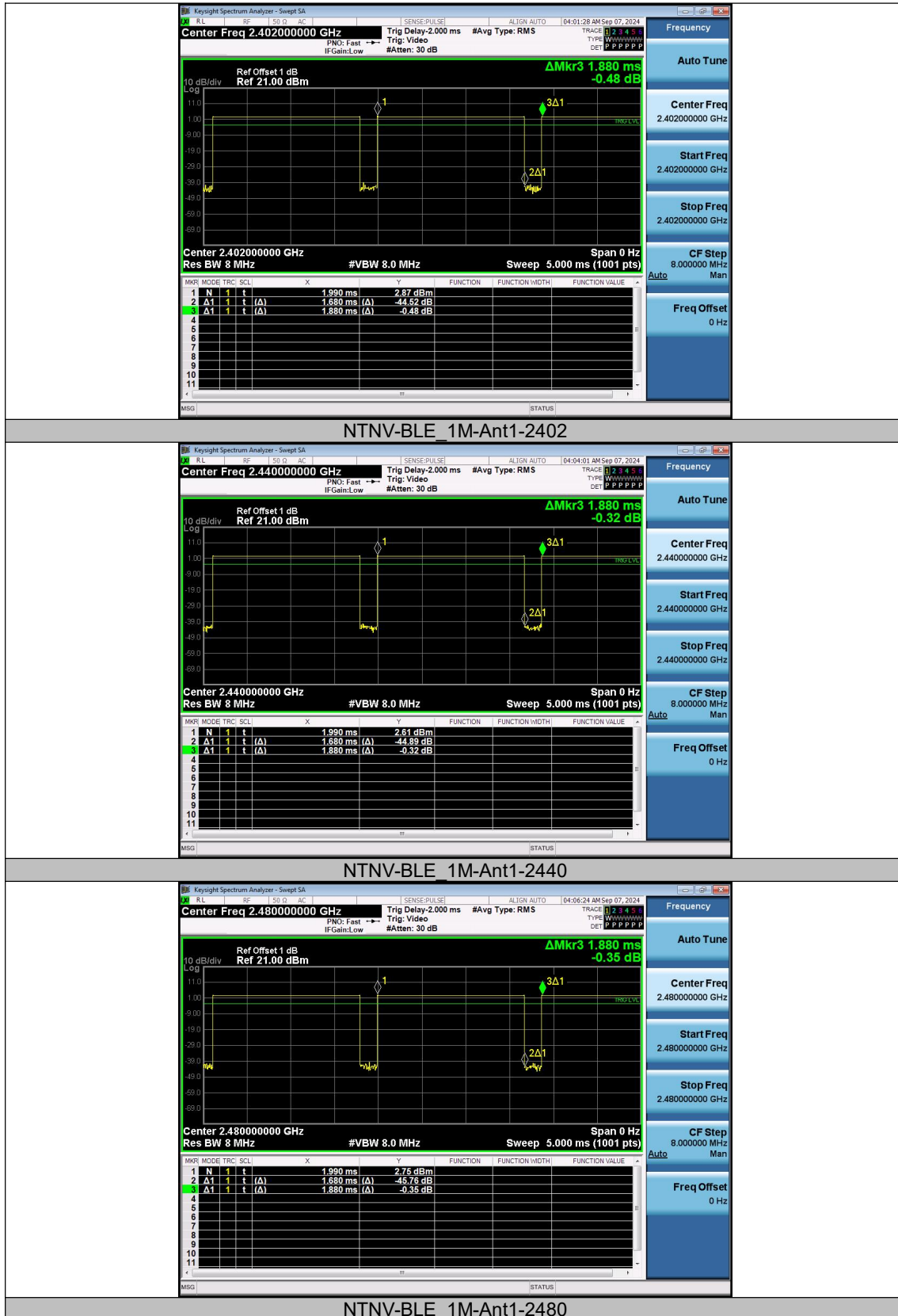
