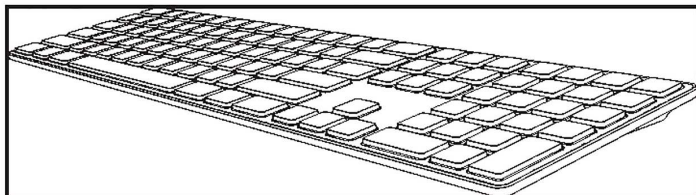

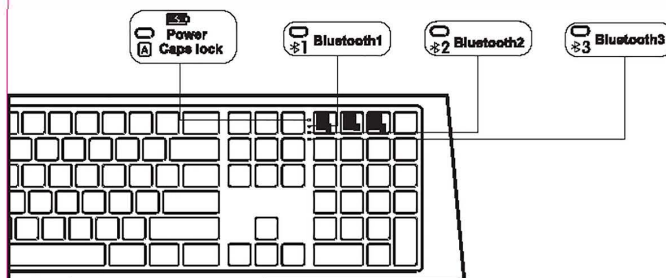

## 1 3 Indicators for convenience

Power led will blink in red every few seconds if low power. Numbs and caps lock will be indicated in red if unlocked and turns off in 5s automatically if no activities.

## 2 You can pair to a second computer instantly

Your keyboard can be paired up to 3 different computers easily.



Easy switch by a short press  
Switch channels (from one computer to another). Led will indicate in blue.
