Edge 1(Top) 10mm-Hotspot Mode

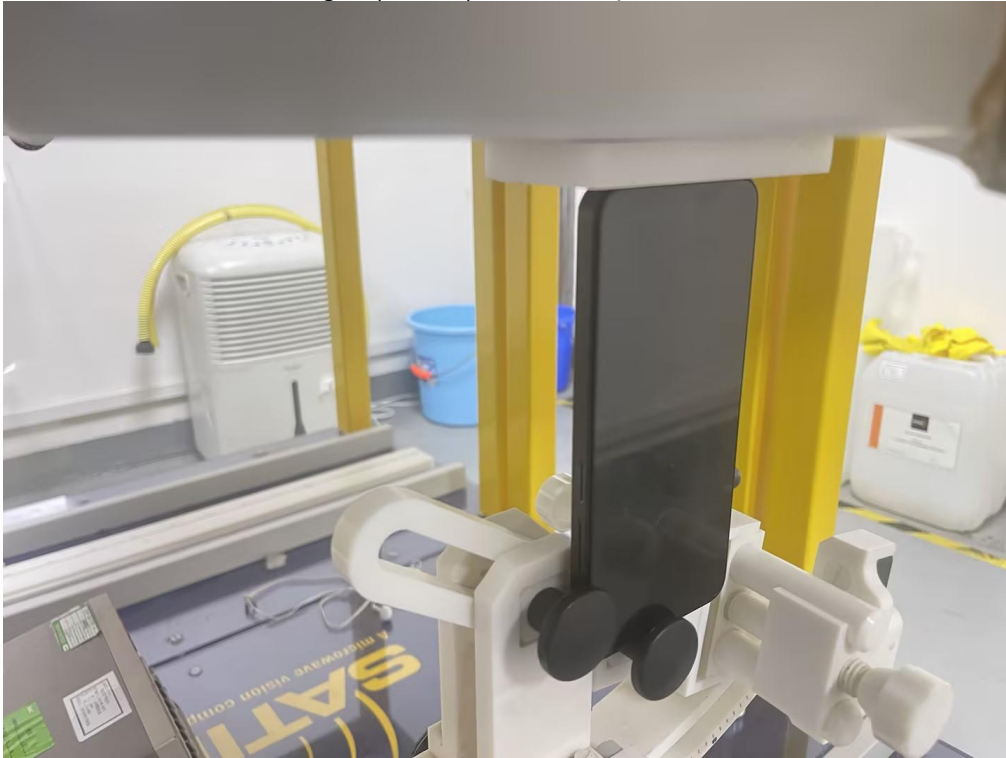

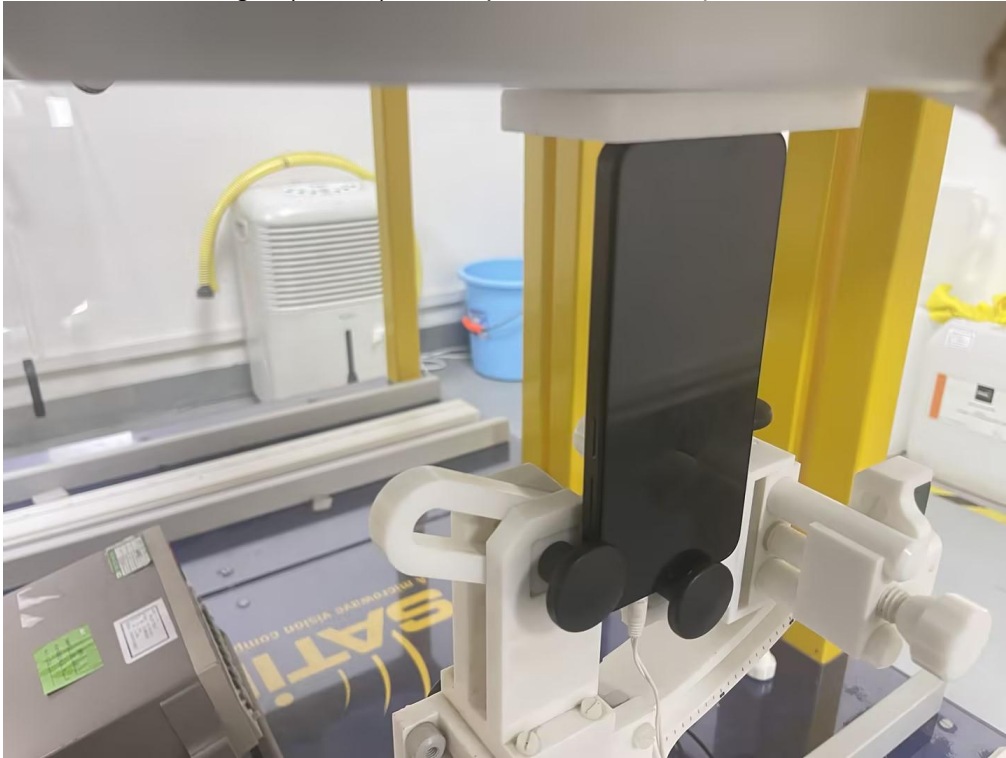
