Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."




### **TEST PLOT**





### 9.5 CONDUCTED SPURIOUS EMISSION

#### **LIMITS**

§ 15.247(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the and that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in § 15.209(a) is not required. 



## **OUT-OF-BAND SPURIOUS EMISSIONS-CONDUCTED MEASUREMENT**







## 9kHz ~ 30MHz




#### 30MHz ~ 1GHz

## **TEST PROCEDURE**

- a. The EUT was placed on the top of a rotating table 0.8/1.5 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. While measuring the radiated emission below 1GHz, the EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower. White measuring the radiated emission above 1GHz, the EUT was set 3 meters away from the interference-receiving antenna
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarization of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. The tests were performed in accordance with KDB 558074 D01 15.247 Meas Guidance v05

## 9.7 POWERLINE CONDUCTED EMISSIONS


