## 2 SYSTEM TEST CONFIGURATION

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

### 2.2 EUT Exercise

An engineering test mode (software/firmware) that applicant provided was utilized to manipulate the EUT into transmit, selection of the test channel, and modulation scheme.

### 2.3 Test Procedure

#### 2.3.1 Conducted Emissions

The EUT is placed on a turn table which is 0.8 m above ground plane. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz. The CISPR Quasi-Peak and Average detector mode is employed according to §15.207. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table. For emissions testing at or below 1 GHz, the table height shall be 0.8 m above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna.

## 2.4 Measurement Results Explanation Example

### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

The spectrum analyzer offset is derived from RF cable loss and attenuator factor. Following shows an offset computation example with cable loss and attenuator.

= RF cable loss (dB)+ attenuation factor(dB) dB =12.60 (dB)

Fig. 2-1 Radiated & Conducted Emission Configuration

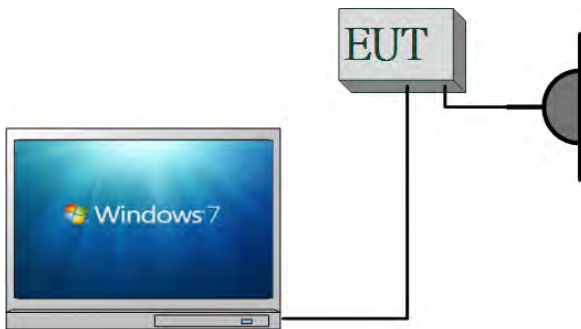


Fig.2-2 AC power line Configuration

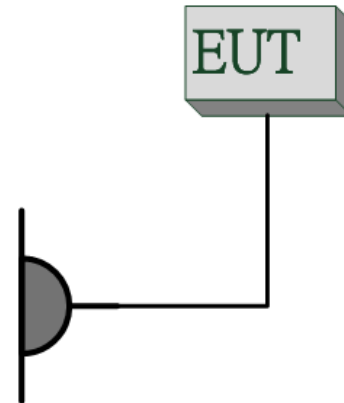

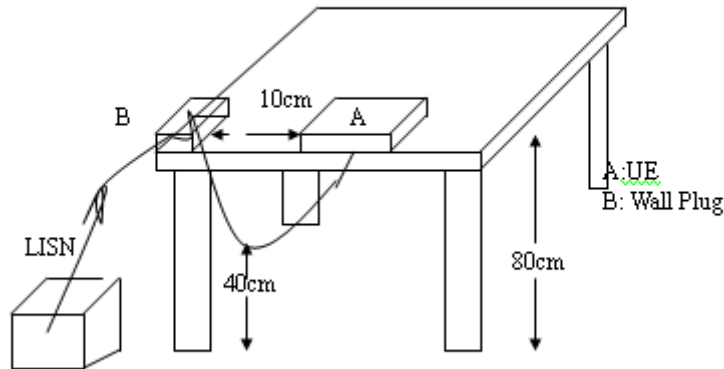

## 10 CONDUCTED BAND EDGE AND SPURIOUS EMISSION MEASUREMENT

### 10.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.

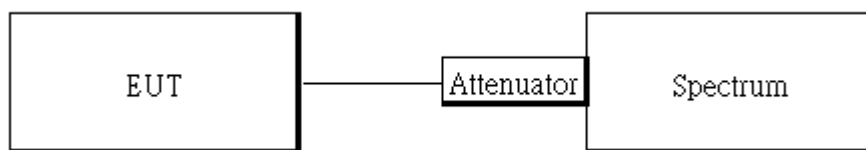
In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a) & RSS-Gen §8.10, must also comply with the radiated emission limits specified in §15.209(a) & RSS-Gen §8.8.

If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section 5.4(4), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

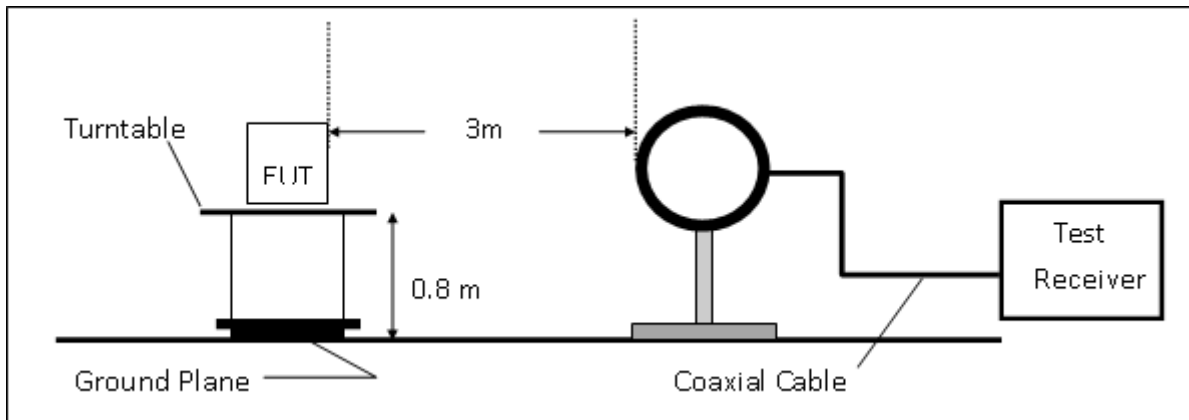

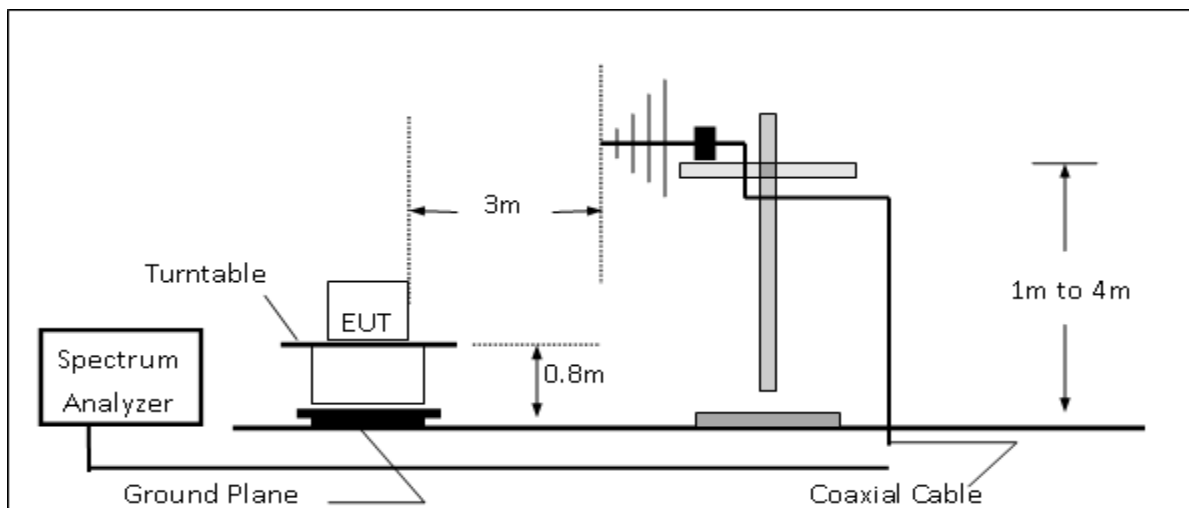

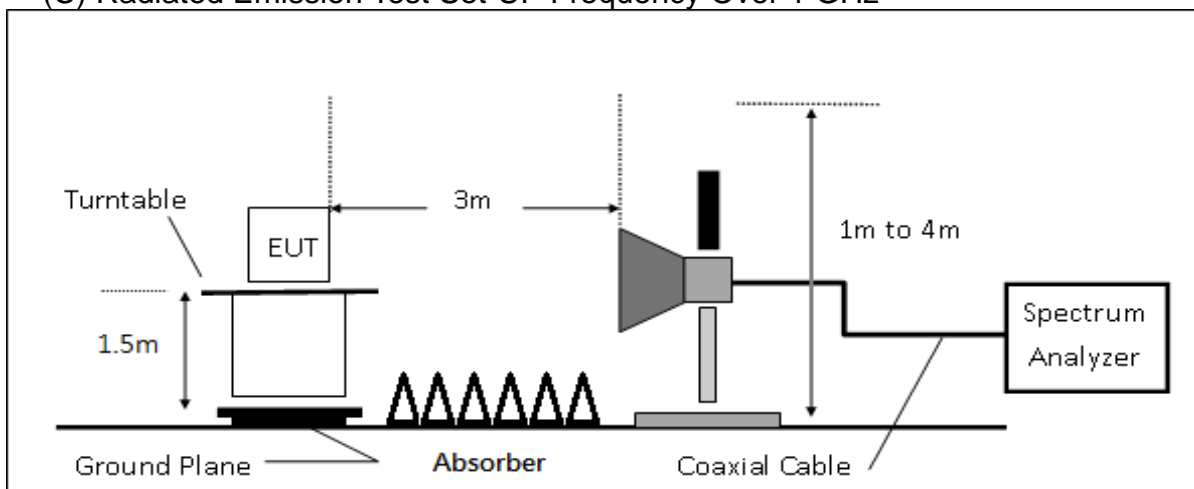
(A) Radiated Emission Test Set-UP Frequency Below 30MHz.

1. The testing follows the Measurement Procedure of FCC KDB 558074 D01 DTS Meas. Guidance .
2. The EUT was placed on a turn table with 0.8m for frequency< 1GHz and 1.5m for frequency> 1GHz above ground plane.
3. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
4. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
5. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
6. Set the spectrum analyzer as RBW=120 kHz and VBW=300 kHz for Peak Detector (PK) and Quasi-peak (QP) at frequency below 1 GHz.
7. Set the spectrum analyzer as RBW=1 MHz, VBW=3 MHz for Peak Detector at frequency above 1 GHz.
8. Set the spectrum analyzer as RBW=1 MHz, VBW=10 Hz (Duty cycle > 98%) or VBW ≥ 1/T (Duty cycle < 98%) for Average Detector at frequency above 1 GHz.
9. The test-receiver system was set to quasi-peak detect function and specified bandwidth with maximum hold mode when the test frequency is below 1 GHz.
10. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
11. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. On spectrum, change spectrum mode in linear display mode, and reduce VBW = 10Hz if average reading is measured.
12. Repeat above procedures until all default test channel measured were complete.

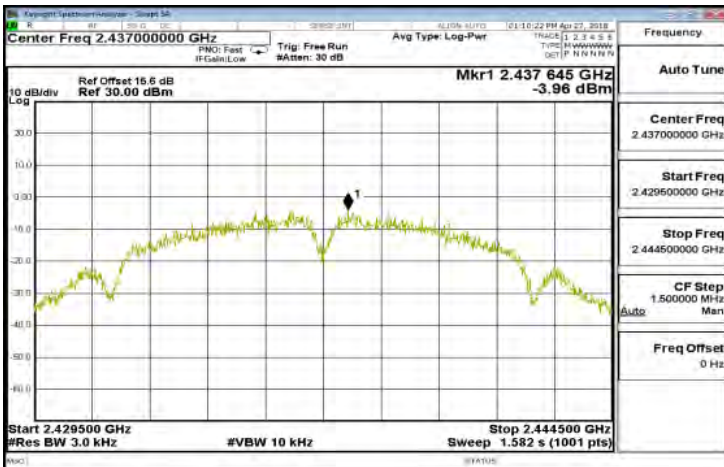
### 802.11b Power Spectral Density Test Plot (CH-Low)



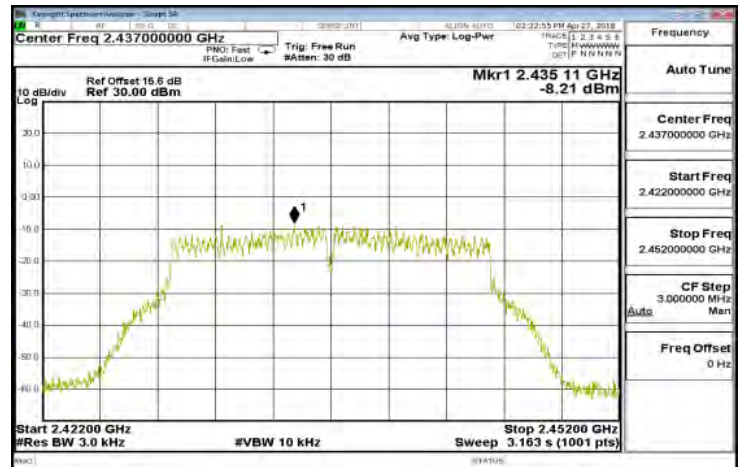
### 802.11g Power Spectral Density Test Plot (CH-Low)



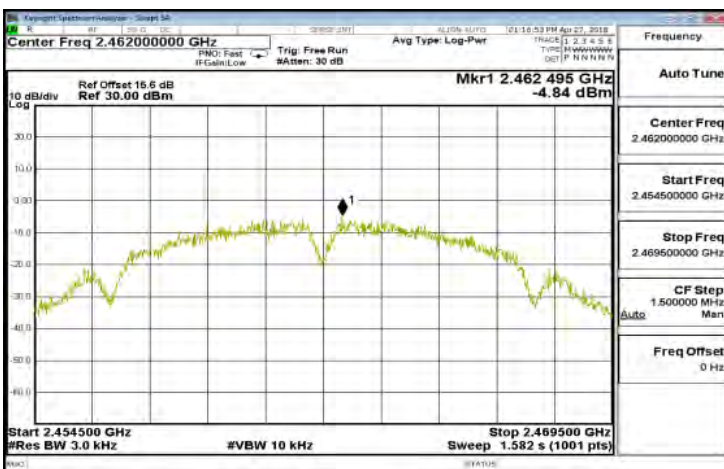
### Power Spectral Density Test Plot (CH-Mid)



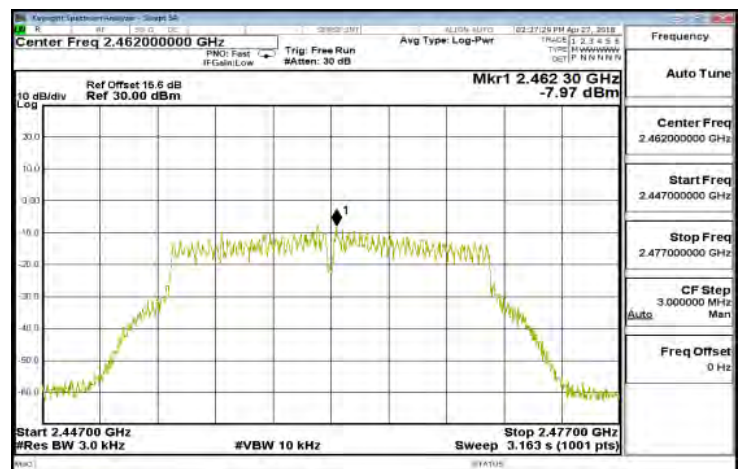

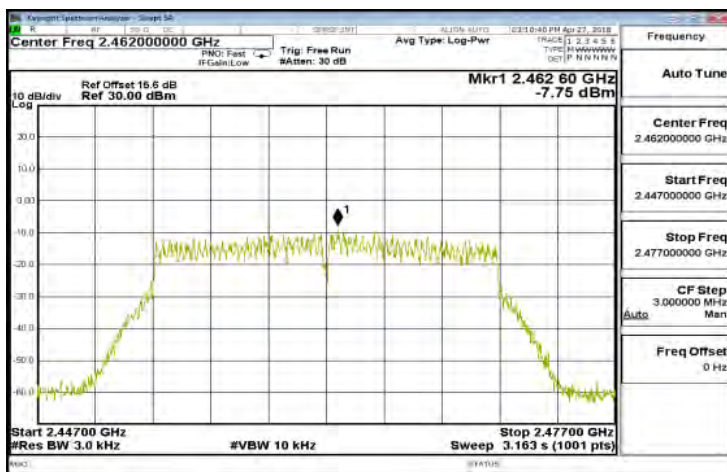
### Power Spectral Density Test Plot (CH-Low)
