Photograph of the Tissue Simulant Fluid liquid depth





Body - distance between flat phantom and EUT is 10 mm




Photograph 1. Body, Front Surface, 10mm


Photograph 3. Body, Back Surface, 10mm






Photograph 7. Body, Bottom Edge, 10mm


Photograph 11. Body, Right Edge, 10mm


