



2. Security scan functions

This product offers the following security scan functions.


- Anti-virus
 - Programs which include virus and dangerous codes are blocked. Web browsing, receiving emails, and the communication of other applications are observed, and checks whether a virus exists in a downloaded file.
- Intrusion Prevention
 Security measure level is improved by sensing and defending the network, such as company Intranet, against unauthorized intrusion and attack.
- Web Guard
 Access to dangerous sites, such as sites that are infected with virus by fishing site and browsing, is guarded by accumulated signatures.
- URL Filtering Specifying the category of Web sites is set beforehand to limit the browsing.
 - As a result, access to a harmful or a non-business related site is blocked.
- URL Keyword Filtering
 Specific character strings are registered beforehand. During Web browsing, URL access to pages that matches the registered character string is blocked.
- Application Guard
 The use of applications wherein an unspecified number of individuals can exchange information like file exchange software and video sharing application, messenger application, etc. is blocked.
