C. Test Site

All testing was performed at MET Laboratories, Inc., 914 West Patapsco Avenue, Baltimore, MD 21230. All equipment used in making physical determinations is accurate and bears recent traceability to the National Institute of Standards and Technology.

Radiated Emissions measurements were performed in a 3 meter semi-anechoic chamber (equivalent to an Open Area Test Site). In accordance with §2.948(a)(3), a complete site description is contained at MET Laboratories.

D. Description of Test Sample

The Vuzix Corporation M300, Equipment Under Test (EUT), is a smart glasses device that is worn on the head. The device includes a display, processor, camera, speaker, and wireless connectivity, and runs the Android operating system. The user runs applications on the device that assist them in their job or provide environmental information.

The M300 must always be connected to an external battery pack. The connection is a custom 8-pin cable designed by Vuzix that connects the M300 to custom battery packs. The default battery pack is an 860 mAh cell with onboard electronics to monitor state of charge and provide battery charging over USB.

Test Requirements: § 15.403(i): For purposes of this subpart the emission bandwidth shall be determined by

measuring the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, that are 26 dB down relative to the maximum level of the modulated carrier. Determination of the emissions bandwidth is based on the use of measurement instrumentation employing a peak detector function with an instrument resolution bandwidth approximately equal to 1.0 percent of the emission bandwidth of the device under

measurement.

Test Procedure: The transmitter was set to low, mid, and high operating frequencies at the highest output power

and connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using a RBW approximately equal to 1% of the total emission bandwidth, VBW > RBW. The 26 dB Bandwidth was

measured and recorded.

Test Results The 26 dB Bandwidth was compliant with the requirements of this section.










Plot 1. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5745M, a mode




Plot 2. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5745M, ac mode




Plot 3. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5745M, n mode






Plot 4. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5785M, a mode




Plot 5. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5785M, ac mode




Plot 6. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5785M, n mode






Plot 7. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5825M, a mode




Plot 8. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5825M, ac mode




Plot 9. Occupied Bandwidth, 6dB, Bandwidth 20M, Ch. 5825M, n mode






Plot 10. Occupied Bandwidth, 6dB, Bandwidth 40M, Ch. 5755M, ac mode




Plot 11. Occupied Bandwidth, 6dB, Bandwidth 40M, Ch. 5755M, n mode




Plot 12. Occupied Bandwidth, 6dB, Bandwidth 40M, Ch. 5795M, ac mode

§15. 407(a)(3) Maximum Conducted Output Power

Test Requirements: §15.407(a)(3): For the band 5.725-5.85 GHz, the maximum conducted output power over the

frequency band of operation shall not exceed 1 W.

If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power.

Test Procedure: The EUT was connected to a spectrum analyzer through a cable and attenuator. Measurements






Plot 15. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, a mode, port a



Plot 16. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, a mode, port b






Plot 17. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, ac mode, port a




Plot 18. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, ac mode, port b






Plot 19. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, n mode, port a




Plot 20. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5745M, n mode, port b






Plot 21. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, a mode, port a



Plot 22. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, a mode, port b






Plot 23. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, ac mode, port a




Plot 24. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, ac mode, port b






Plot 25. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, n mode, port a



Plot 26. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5785M, n mode, port b






Plot 27. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, a mode, port b



Plot 28. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, a mode, port a






Plot 29. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, n mode, port b




Plot 30. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, n mode, port a






Plot 31. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, ac mode, port a



Plot 32. Maximum Conducted Output Power, SISO, Bandwidth 20M, Ch. 5825M, ac mode, port b






Plot 33. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5755M, ac mode, port a




Plot 34. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5755M, ac mode, port b






Plot 35. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5755M, n mode, port a




Plot 36. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5755M, n mode, port b






Plot 37. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5795M, ac mode, port b



Plot 38. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5795M, ac mode, port a






Plot 39. Maximum Conducted Output Power, SISO, Bandwidth 40M, Ch. 5795M, n mode, port a

Plot 41. Maximum Conducted Output Power, SISO, Bandwidth 80M, Ch. 5775M, ac mode, port a




Plot 42. Maximum Conducted Output Power, SISO, Bandwidth 80M, Ch. 5775M, ac mode, port b




Plot 43. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, a mode, port a




Plot 44. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, a mode, port b






Plot 45. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, ac mode, port a



Plot 46. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, ac mode, port b






Plot 47. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, n mode, port a




Plot 48. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5745M, n mode, port b






Plot 49. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, a mode, port a



Plot 50. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, a mode, port b






Plot 51. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, ac mode, port a




Plot 52. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, ac mode, port b





Plot 53. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, n mode, port a




Plot 54. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5785M, n mode, port b






Plot 55. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, a mode, port a




Plot 56. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, a mode, port b






Plot 57. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, ac mode, port a




Plot 58. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, ac mode, port b





Plot 59. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, n mode, port a




Plot 60. Maximum Conducted Output Power, MIMO, Bandwidth 20M, Ch. 5825M, n mode, port b






Plot 61. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5755M, ac mode, port a




Plot 62. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5755M, ac mode, port b






Plot 63. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5755M, n mode, port a



Plot 64. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5755M, n mode, port b






Plot 65. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5795M, ac mode, port a



Plot 66. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5795M, ac mode, port b






Plot 67. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5795M, n mode, port a




Plot 68. Maximum Conducted Output Power, MIMO, Bandwidth 40M, Ch. 5795M, n mode, port b




Plot 71. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, a mode, port a




Plot 72. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, a mode, port b






Plot 73. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, ac mode, port a




Plot 74. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, ac mode, port b






Plot 75. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, n mode, port a




Plot 76. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5745M, n mode, port b






Plot 77. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, a mode, port a




Plot 78. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, a mode, port b






Plot 79. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, ac mode, port a




Plot 80. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, ac mode, port b






Plot 81. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, n mode, port a




Plot 82. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5785M, n mode, port b






Plot 83. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, a mode, port a




Plot 84. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, a mode, port b






Plot 85. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, ac mode, port a




Plot 86. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, ac mode, port b






Plot 87. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, n mode, port a




Plot 88. Power Spectral Density, SISO, Bandwidth 20M, Ch. 5825M, n mode, port b






Plot 89. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5755M, ac mode, port a




Plot 90. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5755M, ac mode, port b






Plot 91. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5755M, n mode, port a




Plot 92. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5755M, n mode, port b






Plot 93. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5795M, ac mode, port a




Plot 94. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5795M, ac mode, port b






Plot 95. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5795M, n mode, port a




Plot 96. Power Spectral Density, SISO, Bandwidth 40M, Ch. 5795M, n mode, port b






Plot 97. Power Spectral Density, SISO, Bandwidth 80M, Ch. 5775M, ac mode, port a




Plot 98. Power Spectral Density, SISO, Bandwidth 80M, Ch. 5775M, ac mode, port b




Plot 99. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, a mode, port a




Plot 100. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, a mode, port b






Plot 101. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, ac mode, port a




Plot 102. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, ac mode, port b






Plot 103. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, n mode, port a




Plot 104. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5745M, n mode, port b






Plot 105. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, a mode, port a




Plot 106. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, a mode, port b






Plot 107. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, ac mode, port a




Plot 108. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, ac mode, port b






Plot 109. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, n mode, port a




Plot 110. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5785M, n mode, port b






Plot 111. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, a mode, port a




Plot 112. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, a mode, port b






Plot 113. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, ac mode, port a




Plot 114. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, ac mode, port b






Plot 115. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, n mode, port a




Plot 116. Power Spectral Density, MIMO, Bandwidth 20M, Ch. 5825M, n mode, port b






Plot 117. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5755M, ac mode, port a




Plot 118. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5755M, ac mode, port b






Plot 119. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5755M, n mode, port a




Plot 120. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5755M, n mode, port b






Plot 121. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5795M, ac mode, port a




Plot 122. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5795M, ac mode, port b






Plot 123. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5795M, n mode, port a




Plot 124. Power Spectral Density, MIMO, Bandwidth 40M, Ch. 5795M, n mode, port b

$\S15.407(b)(4) \& (6-7)$ Undesirable Emissions

Test Requirements:

§ 15.407(b)(4): For transmitters operating in the 5.725-5.85 GHz band: All emissions within the frequency range from the band edge to 10 MHz above or below the band edge shall not exceed an e.i.r.p. of -17 dBm/MHz; for frequencies 10 MHz or greater above or below the band edge, emissions shall not exceed an e.i.r.p. of -27 dBm/MHz.

§ 15.407(b)(6): Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in Section 15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in Section 15.207.

§ 15.407(b)(7): The provisions of Section 15.205 of this part apply to intentional radiators operating under this section.

Test Procedure:

The EUT was placed on a non-conducting stand on a turntable in a chamber. To find the maximum emission the EUT was set to transmit on low, mid, and high channels. Additionally, the turntable was rotated 360 degrees, the EUT was oriented through its three orthogonal axes, and the receive antenna height was varied in order to maximize emissions.

For frequencies from 30 MHz to 1 GHz, measurements were first made using a peak detector with a 100 kHz resolution bandwidth. Emissions which exceeded the limits were re-measured using a quasi-peak detector with a 100 kHz resolution bandwidth.

Above 1 GHz, measurements were made pursuant the method described in FCC KDB 789033 D02 General UNII Test Procedure New Rules v01. The equation, **EIRP=E+20 log D-104.8** was used to convert field strength to EIRP (**E** = field strength (dB μ V/m) and **D** = Reference measurement distance).

For emissions above 1 GHz and in restricted bands, measurements of the field strength were made with a peak detector and an average detector and compared with the limits of 15.209.

As an alternative, according to FCC KDB 789033 D02 General UNII Test Procedure New Rules v01, all emissions above 1 GHz that comply with the peak and average limits of 15.209 satisfy the requirements of unwanted emissions in 15.407.

Test Results:






Plot 127. Undesirable Emissions, Below 1GHz





Plot 128. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5745, a mode




Plot 129. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5825, a mode




Plot 130. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5745, ac mode






Plot 131. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 40M, Ch. 5755, ac mode




Plot 132. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 80M, Ch. 5775, ac mode




Plot 133. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 40M, Ch. 5795, ac mode






Plot 134. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5805, ac mode




Plot 135. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5745, n mode




Plot 136. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 40M, Ch. 5755, n mode






Plot 137. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 40M, Ch. 5795, n mode




Plot 138. Undesirable Emissions, MIMO, Emissions Mask, Bandwidth 20M, Ch. 5805, n mode

























































K. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio-frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or preproduction stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements provided that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.



- (e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:
 - (i) Compliance testing;
 - (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
 - (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.
- (e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.
- (f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated. In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

(a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.

(b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.



§ 2.948 Description of measurement facilities.

- (a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.
 - (1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.
 - (i) If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.
 - (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
 - (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.



Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

- (a) In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:
 - (1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

- (4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.
- (5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.



The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
