Antenna port conducted and radiated test items were performed according to KDB 971168 D01 Power Meas. License Digital Systems v03 and ANSI C63.26-2015 with maximum output power.

Radiated measurements were performed with rotating EUT in different three orthogonal test planes to find the maximum emission.

Radiated emissions were investigated as following frequency range:

30 MHz to 10th harmonic for GSM850, PCS1900.

All modes and data rates and positions were investigated.

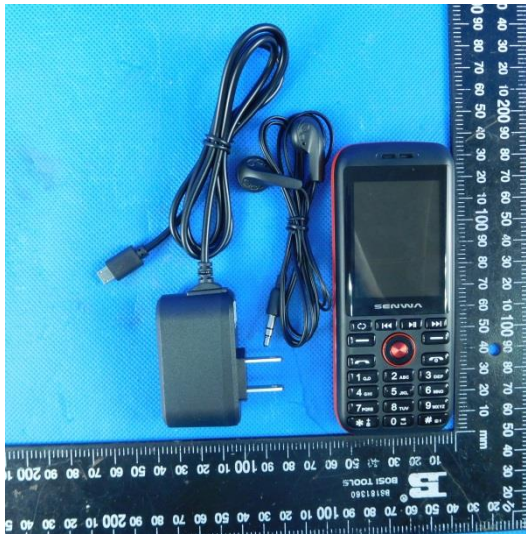
Radiated emission:



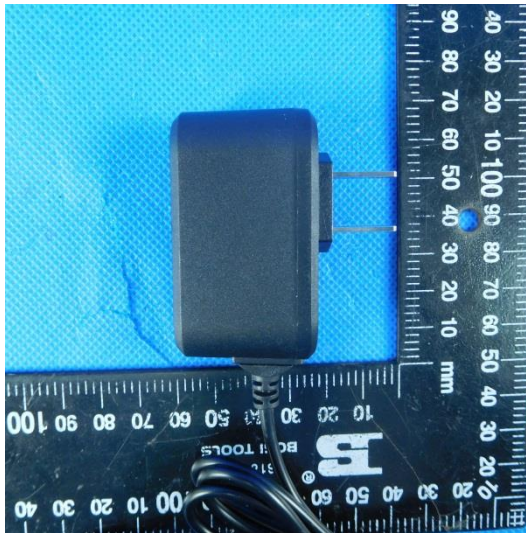

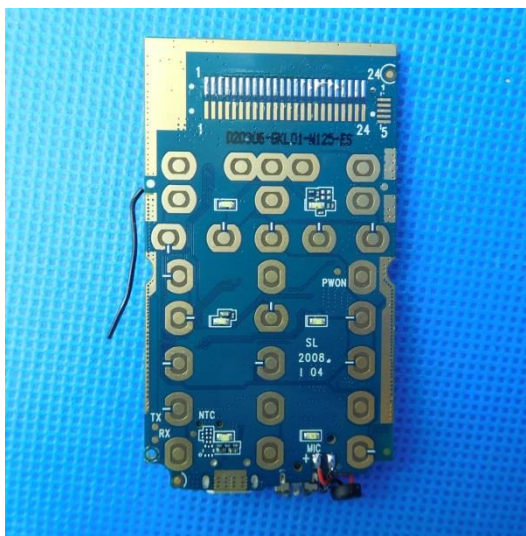
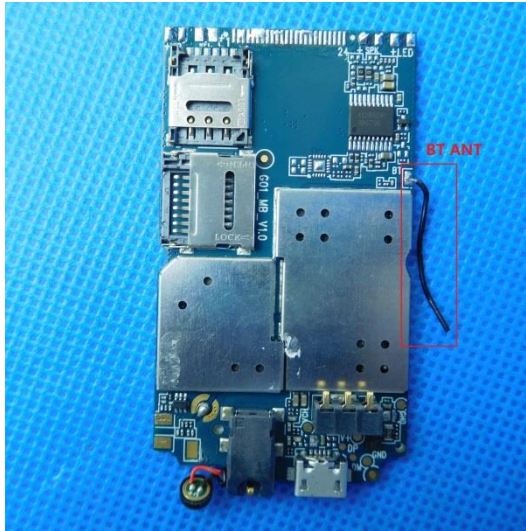
