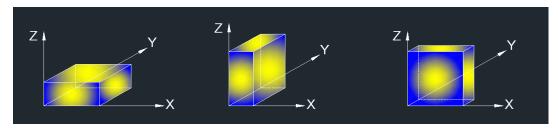

If that calculated VBW is not available on the analyzer then the next higher value should be used.

If the EUT is configured to transmit with duty cycle ≥ 98%, set VBW ≤ RBW/100 (i.e., 10 kHz) but not less than 10 Hz.
