

7.2. SPURIOUS EMISSIONS MEASUREMENT

7.2.1. LIMITS OF CONDUCTED EMISSIONS MEASUREMENT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site. The transmitter output is connected to the spectrum analyzer. The resolution bandwidth is set to 100 kHz. The video bandwidth is set to 300 kHz.





CH Low (30MHz ~26.5GHz)




CH Low (2.31GHz ~2.41GHz)



CH Mid (30MHz ~26.5GHz)




CH High (30MHz ~26.5GHz)





Below 30MHz





6dB Bandwidth (CH Low)




6dB Bandwidth (CH Mid)


Detector mode: Average Polarity: Vertical







Detector mode: Peak Polarity: Vertical







