Follow driver installation procedure steps to install the GB9662 driver on your PC (OS: XP).




➤ 1-3.In Device Manager, choose SDA Standard Compliant SD Host Controller and click right button of mouse and then choose Update driver




➤ 1-4.Choose No, not now, and then click Next.

➤ 1-6. Choose Don't search, I will choose driver to install, and then click Next.




➤ 1-7. Click Have Disk .




➤ 1-8. Click Browse to choose correct directory of Driver


➤ 1-9. Choose Broadcom 802.11g Network Adapter and click Next to install driver.




➤ 1-10. Click Finish and you can check the device is working fine in Device Manager.
