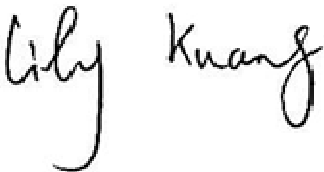

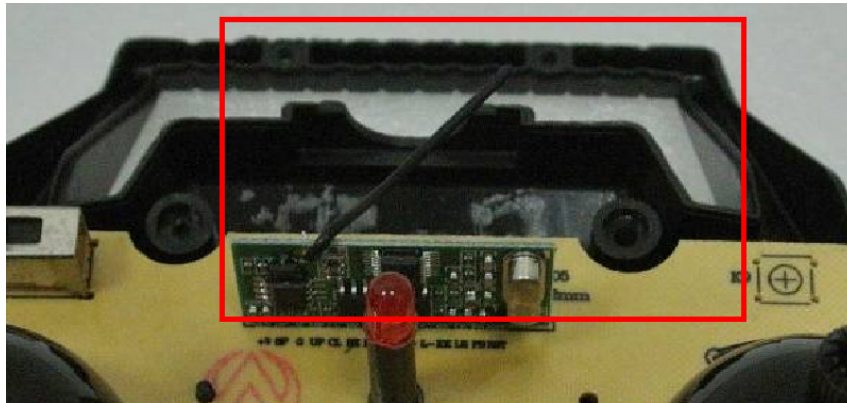

The antenna is an integrated antenna on the main PCB and no consideration of replacement. The best case gain of the antenna is 0 dBi.

### Test Procedure:

#### 1) 9 kHz to 30 MHz emissions:

For testing performed with the loop antenna, testing was performed in accordance to ANSI C63.10. The centre of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT. During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane.

#### 2) 30 MHz to 1 GHz emissions:

For testing performed with the bi-log type antenna, testing was performed in accordance to ANSI C63.10. The measurement is performed with the EUT rotated 360°, the antenna height scanned between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.

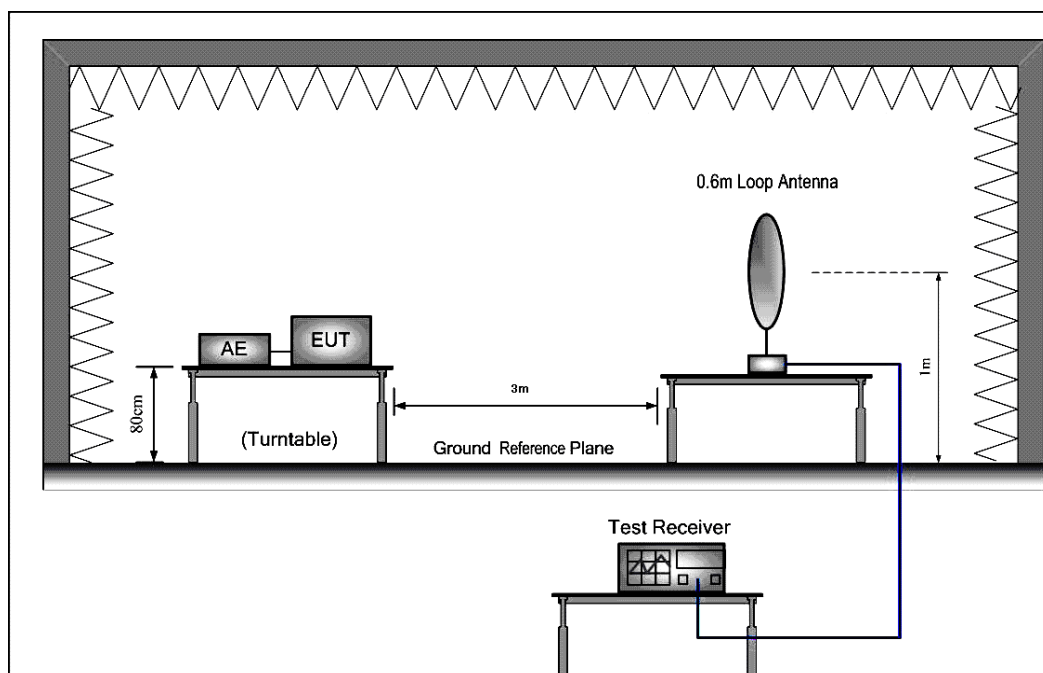
#### 3) 1 GHz to 25 GHz emissions:

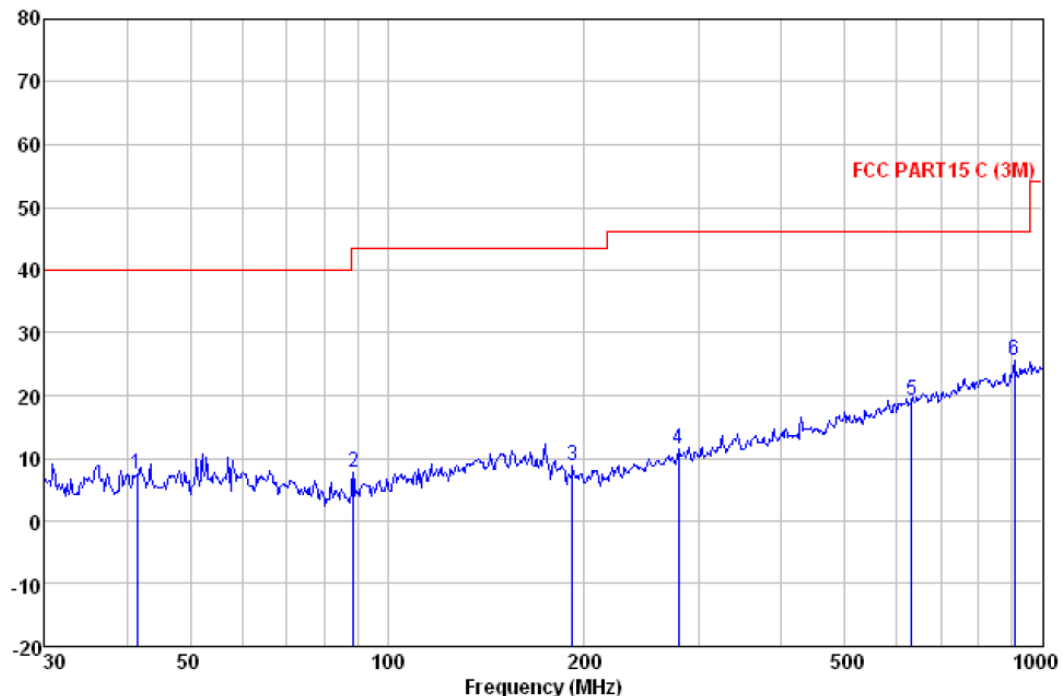

**Remark:**

1). The field strength is calculated by adding the Antenna Factor. Cable Factor & Preamplifier. The basic equation with a sample calculation is as follows:

Final Test Level = Receiver Reading + Antenna Factor + Cable Loss – Preamplifier Factor.

2). As shown in Section, for frequencies above 1000 MHz. the above field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation.

3). The test only perform the EUT in transmitting status since the test frequencies were over 1GHz only required transmitting status.

4). For Radiated Emissions fall in the restricted bands (2400MHz is worse case than 2390MHz and report it as above), which set out in Section 15.205 Restricted bands.

Also there is not any other emission which falls in restricted bands can be detected and reported.

**Test result: The unit does meet the FCC requirements.**



## 7.4 Occupied Bandwidth

Test Requirement: FCC Part 15 C section 15.215 (c)

Intentional radiators operating under the alternative provisions to the general emission limits, as contained in §§ 15.217 through 15.257 and in Subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equipment operates, is contained within the frequency band designated in the rule section under which the equipment is operated. The requirement to contain the designated bandwidth of the emission within the specified frequency band includes the effects from frequency sweeping, frequency hopping and other modulation techniques that may be employed as well as the frequency stability of the transmitter over expected variations in temperature and supply voltage. If a frequency stability is not specified in the regulations, it is recommended that the fundamental emission be kept within at least the central 80% of the permitted band in order to minimize the possibility of out-of-band operation.

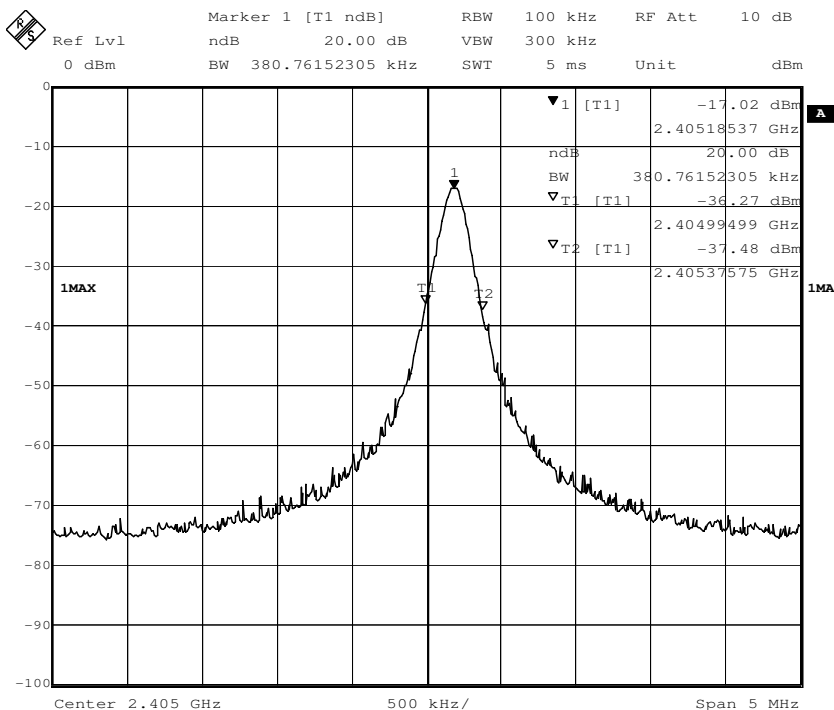

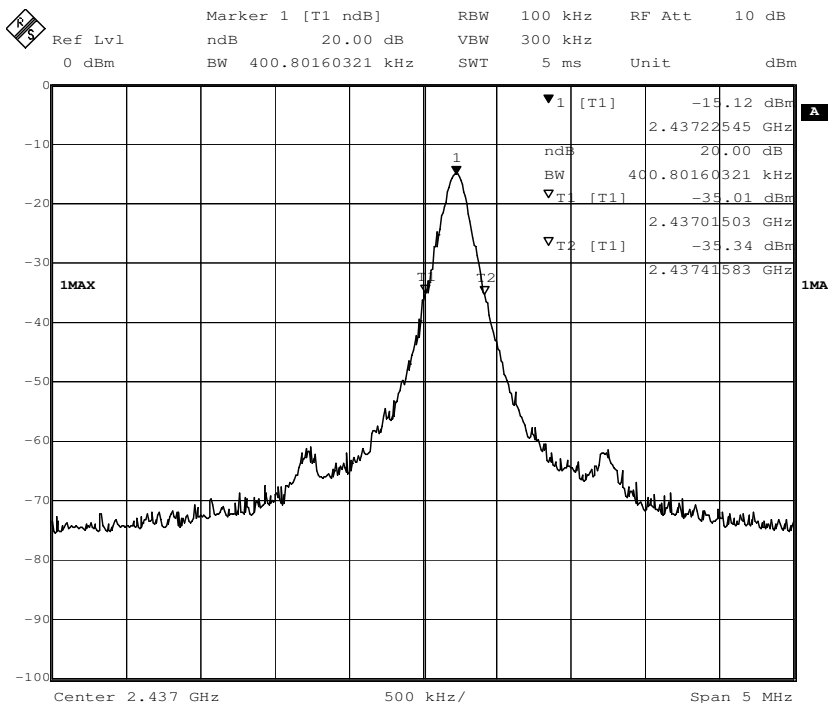

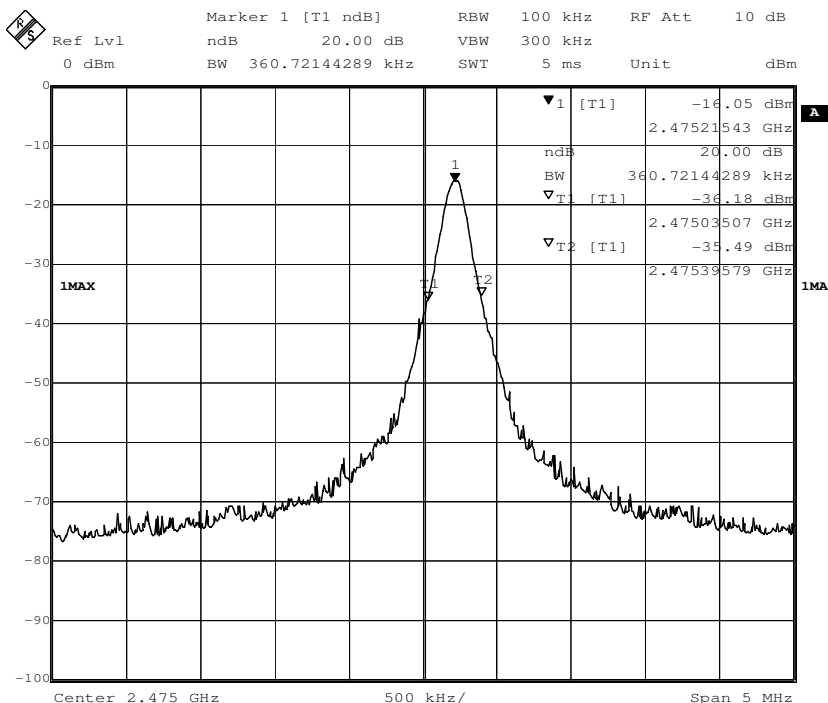
### 1.Test in the lowest frequency 2.405 GHz
