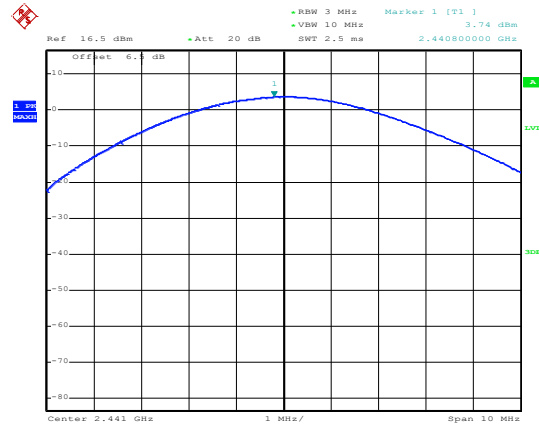

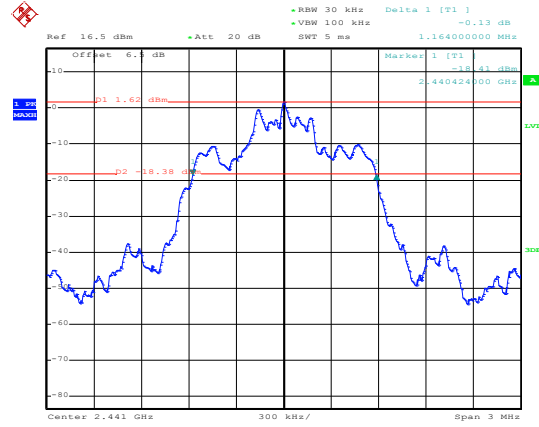


Modulation mode: 8DPSK



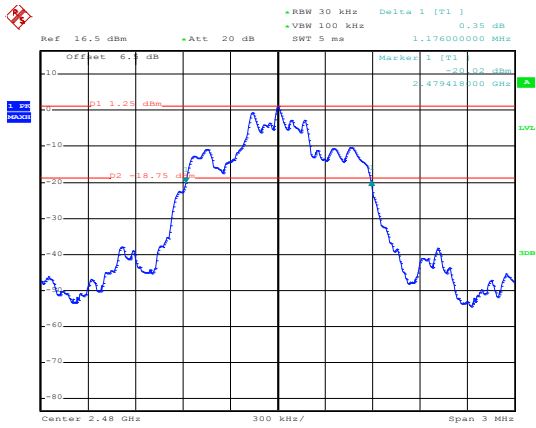

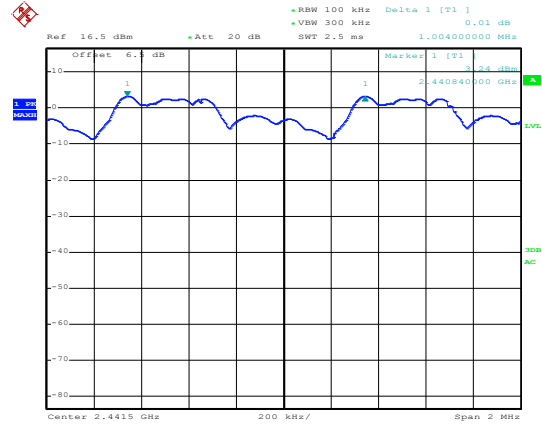


Modulation mode: 8DPSK



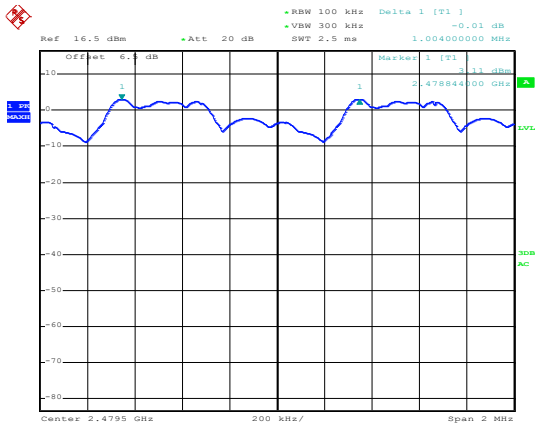
