The lowest, middle, highest channel numbers of the Bluetooth Module used and tested in this report are separately 0 (2402MHz), 39 (2441MHz) and 78 (2480MHz).

## 1.3. Facilities and Accreditations

### 1.3.1. Facilities

## 2. 47 CFR PART 15C REQUIREMENTS

### 2.1. Antenna requirement

#### 2.1.1. Applicable Standard

According to FCC 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The EUT has a permanently and irreplaceable attached antenna. Please refer to the EUT internal photos.


### 2.2. Number of Hopping Frequency

#### 2.2.1. Requirement

According to FCC §15.247(a)(1)(iii), frequency hopping systems operating in the 2400MHz to 2483.5MHz bands shall use at least 15 hopping frequencies.

#### 2.2.2. Test Description

##### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

Sweep = auto

Detector function = peak

Trace = max hold

Allow the trace to stabilize


**2.2.4. Test Result**

The Bluetooth Module operates at hopping-on test mode; the frequencies number employed is counted to verify the Module's using the number of hopping frequency.

(Plot A: GFSK)


## 2.3. Peak Output Power

### 2.3.1. Requirement

According to FCC §15.247(b)(1), for frequency hopping systems that operates in the 2400MHz to 2483.5MHz band employing at least 75 hopping channels, the maximum peak output power of the intentional radiator shall not exceed 1Watt. For all other frequency hopping systems in the 2400MHz to 2483.5MHz band, it is 0.125Watts.

### 2.3.2. Test Description

#### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Power meter and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm;the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

### 2.3.3. Test Result

The Bluetooth Module operates at hopping-off test mode. The lowest, middle and highest channels are selected to perform testing to verify the conducted RF output peak power of the Module.The lowest,



middle and highest channel were tested by Power meter.


## 2.4. 20dB Bandwidth

### 2.4.1. Definition

According to FCC §15.247(a)(1), the 20dB bandwidth is known as the 99% emission bandwidth, or 20dB bandwidth ( $10 \log 1\% = 20\text{dB}$ ) taking the total RF output power.

### 2.4.2. Test Description

#### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel

RBW  $\geq$  1% of the 20 dB bandwidth

VBW  $\geq$  RBW

Sweep = auto

Detector function = peak

Trace = max hold


The Bluetooth Module operates at hopping-off test mode. The lowest, middle and highest channels are selected to perform testing to record the 20dB bandwidth of the Module.





(Plot C: Channel = 2480 @ GFSK)


## 2.5. Carried Frequency Separation

### 2.5.1. Definition

According to FCC §15.247(a)(1), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater.

### 2.5.2. Test Description

#### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

### 2.5.3. Test Procedure

The EUT must have its hopping function enabled. Use the following spectrum analyzer settings:

Span = wide enough to capture the peaks of two adjacent channels

Resolution (or IF) Bandwidth (RBW)  $\geq$  1% of the span

Video (or Average) Bandwidth (VBW)  $\geq$  RBW

Sweep = auto

Detector function = peak


Trace = max hold

Allow the trace to stabilize. Use the marker-delta function to determine the separation between the peaks of the adjacent channels.

#### 2.5.4. Test Result

The Bluetooth Module operates at hopping-on test mode.

For any adjacent channels (e.g. the channel 39 and 40 as showed in the Plot A), the Module does have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel (refer to section 2.4.3), whichever is greater. So, the verdict is PASSING



(Plot A: GFSK)


## 2.6. Time of Occupancy (Dwell time)

### 2.6.1. Requirement

According to FCC §15.247(a) (1) (iii), frequency hopping systems in the 2400 - 2483.5MHz band shall use at least 15 non-overlapping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

### 2.6.2. Test Description

#### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm;the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

### 2.6.3. Test Procedure

The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan. The number of pulses is measured in a 3.16 second scan, to enable resolution of each occurrence.

The average time of occupancy in the specified 31.6 second period (79 channel \* 0.4 s) is equal to 10 \* (# of pulses in 3.16 s) \* pulse width.







(Plot A: DH1 @ GFSK)

(Plot C: DH5 @ GFSK)


## 2.7. Conducted Spurious Emissions

### 2.7.1. Requirement

According to FCC §15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

### 2.7.2. Test Description

#### A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm;the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

Allow the trace to stabilize.

## 2.7.4. Test Result

The Bluetooth Module operates at hopping-off test mode. The measurement frequency range is from 30MHz to the 10th harmonic of the fundamental frequency. The lowest, middle and highest channels are tested to verify the spurious emissions.




(Plot A.1: Channel = 0, 30MHz to 25GHz @ GFSK Mode)




(Channel = 0, Band edge @ GFSK Mode)




(Channel = 0, Band edge with hopping on @ GFSK Mode)




(Plot B.1: Channel = 39, 30MHz to 25GHz @ GFSK Mode)


## 2.8. Restricted Frequency Bands

### 2.8.1. Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power. In addition, radiated emissions which fall in the restricted bands, as defined in 15.205(a), must also comply with the radiated emission limits specified in 15.209(a).

### 2.8.2. Test Description

#### A. Test Setup:



The Module is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading. During the measurement, the Bluetooth Module is activated and controlled by the Bluetooth Service Supplier (SS) via a Common Antenna, and is set to operate under hopping-on test mode transmitting 339 bytes DH5 packages at maximum power.

For the Test Antenna:

Horn Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength.




(Plot A1: Channel = 0 PEAK @ GFSK)

## 2.9. Conducted Emission

### 2.9.1. Requirement

According to FCC section 15.207, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency within the band 150kHz to 30MHz shall not exceed the limits in the following table, as measured using a 50 $\mu$ H/50 $\Omega$  line impedance stabilization network (LISN).



### 2.9.2. Test Description

#### A. Test Setup:



The Table-top EUT was placed upon a non-metallic table 0.8m above the horizontal metal reference ground plane. EUT was connected to LISN and LISN was connected to reference Ground Plane. EUT was 80cm from LISN. The set-up and test methods were according to ANSI C63.4:2009

The factors of the site are calibrated to correct the reading. During the measurement, the Bluetooth

Module is activated and controlled by the Bluetooth Service Supplier (SS) via a Common Antenna, and is set to operate under hopping-on test mode transmitting 339 bytes DH5 packages at maximum power.


### 2.9.3. Test Result

The maximum conducted interference is searched using Peak (PK), if the emission levels more than the AV and QP limits, and that have narrow margins from the AV and QP limits will be re-measured with AV and QP detectors. 

## 2.10. Radiated Emission

### 2.10.1. Requirement

According to FCC section 15.247(d) and RSS-A8.5, radiated emission outside the frequency band attenuation below the general limits specified in FCC section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in FCC section 15.205(a), must also comply with the radiated emission limits specified in FCC section 15.209(a).

According to FCC section 15.209 (a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:







The test site semi-anechoic chamber has met the requirement of NSA tolerance 4dB according to the standards: ANSI C63.4 (2009). The EUT was set-up on insulator 80cm above the Ground Plane. The set-up and test methods were according to ANSI C63.4.

The Bluetooth Module of the EUT is powered by the Battery. The Module is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading. During the measurement, the Bluetooth Module is activated and controlled by the Bluetooth Service Supplier (SS) via a Common Antenna, and is set to operate under hopping-on test mode transmitting 339 bytes DH5 packages at maximum power.

For the Test Antenna:

- In the frequency range of 9kHz to 30MHz, magnetic field is measured with Loop Test Antenna. The Test Antenna is positioned with its plane vertical at 1m distance from the EUT. The center of the Loop Test Antenna is 1m above the ground. During the measurement the Loop Test Antenna rotates about its vertical axis for maximum response at each azimuth about the EUT.
- In the frequency range above 30MHz, Bi-Log Test Antenna (30MHz to 2GHz) and Horn Test Antenna (above 2GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength. The emission levels at both horizontal and vertical polarizations should be tested.

### 2.10.4. Test Result

According to ANSI C63.4 selection 4.2.2, because of peak detection will yield amplitudes equal to or greater than amplitudes measured with the quasi-peak (or average) detector, the measurement data from a spectrum analyzer peak detector will represent the worst-case results, if the peak measured value complies with the quasi-peak limit, it is unnecessary to perform an quasi-peak measurement.

The measurement results are obtained as below:








(30MHz to 25GHz, Antenna Horizontal @ GFSK, channel 0)




(30MHz to 25GHz, Antenna Vertical @ GFSK, channel 0)

Plot for Channel = 39




(30MHz to 25GHz, Antenna Horizontal @ GFSK, channel 39)




(30MHz to 25GHz, Antenna Vertical @ GFSK, channel 39)
