The above equipment has been tested by **Bureau Veritas Consumer Products Services (H.K.) Ltd., Taoyuan Branch**, and found compliance with the requirement of the above standards. The test record, data evaluation & Equipment Under Test (EUT) configurations represented herein are true and accurate accounts of the measurements of the sample's RF characteristics under the conditions specified in this report.

## 2 Applicable RF Exposure Limit

§ 1.1310 Radiofrequency radiation exposure limits.

(a) Specific absorption rate (SAR) shall be used to evaluate the environmental impact of human exposure to radiofrequency (RF) radiation as specified in § 1.1307(b) of this part within the frequency range of 100 kHz to 6 GHz (inclusive).

(b) The SAR limits for occupational/controlled exposure are 0.4 W/kg, as averaged over the whole body, and a peak spatial-average SAR of 8 W/kg, averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the parts of the human body treated as extremities, such as hands, wrists, feet, ankles, and pinnae, where the peak spatial-average SAR limit for occupational/controlled exposure is 20 W/kg, averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). Exposure may be averaged over a time period not to exceed 6 minutes to determine compliance with occupational/controlled SAR limits.

(c) The SAR limits for general population/uncontrolled exposure are 0.08 W/kg, as averaged over the whole body, and a peak spatial-average SAR of 1.6 W/kg, averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the parts of the human body treated as extremities, such as hands, wrists, feet, ankles, and pinnae, where the peak spatial-average SAR limit is 4 W/kg, averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). Exposure may be averaged over a time period not to exceed 30 minutes to determine compliance with general population/uncontrolled SAR limits.

Medical implant devices may only use this exemption and that in [paragraph \(b\)\(3\)\(ii\)\(A\)](#).

#### Notes:

- Determining compliance based on the results of the compliance measurement, not taking into account measurement instrumentation uncertainty.
- Calculate the ERP of GFSK from the radiated field strength:  

$$\text{ERP (dBm)} = \text{Radiated field strength (dBuV/m)} + 20 \times \text{Log}(d) - 104.77 - 2.15$$
 d is the measurement distance, in 3 m.  

$$\text{ERP} = 62.8 + 20 \times \text{Log}(3) - 104.77 - 2.15 = -34.58 \text{ dBm (0.0003483 mW)}$$

$$\text{Average Power} = \text{ERP (dBm)} - \text{Antenna Gain (dBi)} + 2.15 = -28.59 \text{ dBm (0.0013834 mW)}$$
 The power used to evaluate 1 mW exclusion is the max tune-up conducted average output power.

### 4 Conclusion

Source-base time average power is below Exemption Criteria and/or Routine Evaluation MPE thresholds, therefore the device is compliant FCC RF exposure requirement.
