How to Play :

1. Remote Control - Turn the switch on the top of the remote to "ON".
2. Cat-Car - Turn the switch on the bottom of the Cat-Car to "ON".
3. Press the forward arrow on the remote control to move the car forward.
4. Press the spin arrow on the remote control to turn the car counter clockwise.

Hint :

Release the button to stop the car from Moving.
Turn both Remote Control and Cat-Car to "OFF" mode when not in use.

Remote Distance - 32 Feet (10 Meter)
