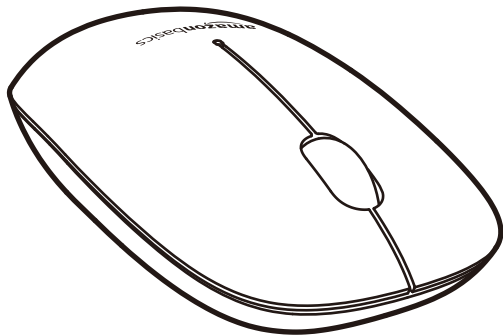

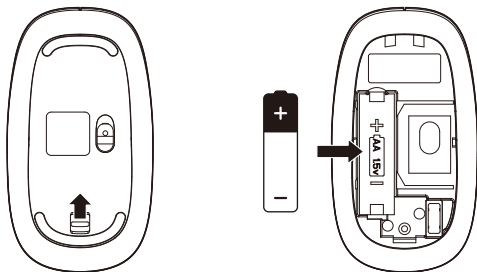

- 1** To put one AA battery into your Bluetooth mouse.

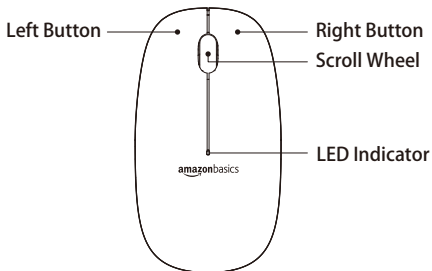


- 2** To use your Bluetooth mouse, you must first pair (connect) it with your computer.

1. Turn on the computer.
2. Ensure that your computer has Bluetooth turned on.
3. Start the Bluetooth pairing wizard on your computer.
4. Hold down the middle key + right key for 3 seconds.



## Key Functions & LED Behavior



Items	Specification
Pairing Mode	<ol style="list-style-type: none"><li>1. Hold down the middle key + right key for 3 seconds.</li><li>2. Red LED, 250 ms on and 250 ms off.</li><li>3. Pairing time: 1 minute.</li></ol>
Low Battery Alarm	<ol style="list-style-type: none"><li>1. Red LED, 500ms on and 500ms off for 10 times then turn off LED when moving mouse.</li><li>2. Low battery alert <math>\leq 1.1V</math> @ 1 AA battery.</li></ol>
Cut off	<ol style="list-style-type: none"><li>1. Cut off voltage <math>\leq 1.0V</math> @ 1 AA battery.</li></ol>

CPI Selection	1. Hold down left key and right key for 3 seconds. 2. 1000 cpi: Blinking 1 time, 1 s on/1 s off 3. 1200 cpi(default): Blinking 2 time, 1 s on/1 s off 4. 1600 cpi: Blinking 3 time, 1 s on/1 s off
Power on/off	1. Hold down the left Key + middle Key for 3 seconds. 2. Red LED, 250ms on, 250ms OFF, 5 times.
Wake up Mode	1. Standby 1/standby 2 mode: Support moving, Key and roller wake up. 2. Sleep mode: Only Key & roller wake up.
